Subject: Interim Councilor Interviews & Appointment

ACTION REQUESTED

Council is asked to interview applicants, deliberate, and appoint an individual to the vacant Council position 3 for an interim term.

HISTORY OF PRIOR ACTIONS AND DISCUSSIONS

<u>January 16, 2024</u>: Following the resignation of Council President Desi Nicodemus from Council position 3, Council declared the position vacant, called for a special election, and directed staff to conduct a recruitment process to fill the vacant position on an interim basis.

February 5: deadline to apply for the interim appointment to the vacant Council position 3.

ANALYSIS

Milwaukie City Charter Chapter V, Section 19 gives Council the authority to fill vacant Council positions on an interim basis before a special election can be held. Any interim appointment must be made by a majority vote of the remaining members of Council. As directed by Council on January 15, staff conducted a recruitment process to find individuals interested in filling the vacant Council position until a special election can be held on May 21.

Eight applications were received for the vacant Council position; applications were received from Shane Abma, Will Anderson, David Chitsazan, Corey Hester, Emily Lowry, Mary Rowe, Sheryl Wampler, and Timothy Welp. Staff has confirmed that all applicants are eligible to serve on Council – they are registered to vote in Oregon and have lived in Milwaukie city limits since at least August 13, 2023. The applications have been forwarded to Council for review.

On February 13 Council is asked to interview the applicants, deliberate, and vote on appointing one of the applicants to the vacant Council position. To make the appointment, a resolution (Attachment 1) has been prepared for Council to insert the individual's name and adopt.

If an interim appointment is made, the municipal court judge is prepared to administer the oath of office to the appointed individual. The oath of office is Attachment 2 to this report. If no interim Councilor is appointed the position will remain vacant until the results of the May 21 special election are certified.

BUDGET & WORKLOAD IMPACT

The city recorder's office can handle the extra costs and workload related to this process.
