March 18, 2021

1. Welcome/Introductions:

2. Presentation by Father's Heart Ministries conditional use permit:

A brief history and film were presented followed by brief explanation of the FH community engagement plan, which includes regular yearly meetings with the MNA. **Q&A**:

Cameron: suggested a Good Neighbor Policy between Father's Heart and MNA. Wendy: asked for clarification of what was being asked for. **A:** A warming center to be available every year without having to ask for a new permit each year.

Wendy: what happens when there is a problem with a guest? **A:** People who do not follow the house rules have to leave and will need to take a break from the shelter. FH works closely with OCPD, including Valentina (new Behavioral Specialist) and guests must behave in All of Oregon City.

Amy: what is FH doing to communicate with neighbors, especially those near FH? **A:** the plan is to meet with MNA once/year.

Jay: if permit is granted, will FH apply for permanent warming shelter? **A:** yes
Jesse: recommends we pursue a Good Neighbor Policy with FH & MNA **A:** yes, good idea

3. Approval of Minutes:

Denyse McGriff moved to approve the minutes without corrections. Jay Pearce seconded, and the minutes were unanimously approved without corrections

4. Police liaison update:

Justin Young Nothing new to report.

Q&A:

Jay: can police enter the Father's Heart property? **A:** Yes
Denyse: what are the crime stats? **A:** Justin did not have that available
Jess: can we start doing ride-alongs? **A:** yes, when COVID rules relax (Denyse gets first dibs)

5. Clackamas Fire liaison update Brandon Paxton

Brandon had numerous points of important information

- Clack. Fire is assisting Clackamas County Health in distribution of COVID-19 vaccines. Call 211 for information about locations, eligibility, etc..
- CERT (Community Emergency Response Team) is also helping vaccination clinics
- 2020 wildfires: Crew 30, a full-time seasonal crew is being hired for wildland fire fighting and fuel mitigation (tree debris cleanup)
- Clackamas Fire Prepares event in May to help people learn how to prepare for wildfire mitigation and what Evacuation orders mean (1-Ready, 2-Set, 3-Go) and how to access cell phone notifications.
- Ice storm: emphasized need for emergency preparedness-have supplies available for 72 hours.
- Fire Chief is retiring June 30. New chief is Nick Brown. Transfer of command ceremony may be live streamed.
- Burn/smoke complaints: people have erroneously been burning their ice storm tree debris inside the city limits, which is not allowed. Brandon encouraged us to contact DEQ to report backyard burning. Jesse and Denyse noted that DEQ does not respond to the online complaint form. Denyse recommends a courtesy call to the people who are doing backyard burning.

Q&A:

Denyse: will Brandon be our permanent liaison? **A:** no, staff rotate to neighborhood meetings

Jesse: why didn't people understand evacuation orders during the fire in September? **A:** the conditions changed very fast and it was hard to keep up.

Cameron: will there be any prescribed burns? A: do not know yet

Denyse: what is Clackamas Fire doing to bring more women and people of color into the department? **A:** working on a plan for Diversity, Equity, Inclusion. Hopeful the new fire chief will help implement this.
