## 3. CEREMONIES AND PROCLAMATIONS

3a. Oath of Office for New Oregon City Police Officer Matthew Pavey

Shaun Davis, Police Chief, introduced Matthew Pavey, new Police Officer.

Mayor McGriff administered the Oath of Office to Officer Pavey.

#### 4. CITIZEN COMMENTS

Jackie Hammond-Williams, of the Park Place Neighborhood Association, was there to support the Safe Routes to School infrastructure program and sidewalks on Holcomb. She had gone to the Transportation Advisory Committee about the bottom half of Holcomb that was constrained and lacked pedestrian connectivity to the rest of the City.

#### 5. PRESENTATIONS

# 5a. 2023 Police Department Annual Report

Chief Davis presented the 2023 annual report. He discussed the department staff, calls for service, stop data, police reports, citations and arrests, use of force incidents, code enforcement, detective division, crime scene processing and forensics, special investigations team, behavioral health unit, training division, homeless liaison officer, Newell Creek Canyon homeless camp cleanup, traffic team, community events, OCPD Summer Camp, Citizens Academy, prescription drug take back events, women's self defense classes, National Night Out, Trick or Treat Main Street, agency accreditation, remembering the

fallen, and future challenges.

There was discussion regarding partnering with behavioral health officers from surrounding cities, categorizing calls for service, DEI training, recruiting minorities and women, and reporting incidents to the police.

Item 7b was pulled from the consent agenda. The agenda was adopted as amended.

John Lewis, Public Works Director, discussed a bid protest that was filed Monday, February 19, 2024. He explained the protestor's bid submission had a mistake which staff considered non-responsive and had moved to the next bid. These protests normally did not go to the City Commission, but the protestor had requested the letter be shared. Staff was not changing the recommendation for approval.

Commissioner O'Donnell said bids needed to be submitted on time and accurately. Any errors could disqualify them. He did not have a problem with moving forward as recommended by staff.

#### 8. PUBLIC HEARINGS

8a. Second Reading of Ordinance No. 24-1002, Approving Zoning Text Amendments to I - Institutional District to Allow Recreational Vehicle Parks as an Allowed Accessory Use for Clackamette Park to City Code Section 17.39.030 (GLUA-23-00039 / ZC-23-00004)

Tony Konkol, City Manager, noted the Planning Commission had made some recommendations concerning allowing private RV parks in other zones throughout the City. It was something the City Commission could discuss at a later date.

Motion made by Commissioner Mitchell, Seconded by Commissioner Smith, to approve the second reading and final adoption of Ordinance No. 24-1002, Approving Zoning Text Amendments to I - Institutional District to Allow Recreational Vehicle Parks as an Allowed Accessory Use for Clackamette Park to City Code Section 17.39.030 (GLUA-23-00039 / ZC-23-00004). Christina Robertson-Gardiner, Senior Planner, presented the Beavercreek Road Industrial Land Readiness Strategic Plan. She gave an overview of the Metro Planning and Development Grant, study area, outcomes, next steps, and Commission options.

James Graham, Economic Development Manager, discussed the collaboration between economic development and planning for this project. This gave them the opportunity to talk to the property owners in a challenging area to develop.

Commissioner O'Donnell was not a fan of this but would go along because it only authorized the study.

Commissioner Mitchell was skeptical of getting property owner cooperation. Since they had the grant, he thought it was worth the effort.

Mayor McGriff supported the project to get updated information.

Motion made by Commissioner Marl, Seconded by Mayor McGriff, to approve the 2040 Planning and Development Grant Intergovernmental Agreement (IGA) Metro – City of Oregon City for the Beavercreek Road Industrial Land Readiness Strategic Plan. The motion carried by the following vote:

Mr. Lewis gave a presentation on the Holcomb Safe Routes to School project. He discussed the project details, concept plan, completion by November 2024, tree removals, tree mitigation requirements and intent, and schedule.

There was discussion regarding mitigation for tree removals in public rights-of-way that were acquired for the project. There was consensus that the mitigation requirements did not apply to the trees on private property. There would be mitigation for the ones that would end up in the right-of-way.
