

RESOLUTION NO. 24-13

A RESOLUTION DECLARING AN EMERGENCY AND TEMPORARILY EXEMPTING THE CONSTRUCTION ACTIVITIES IN 10th STREET ASSOCIATED WITH THE 2024 OREGON CITY ROADWAY RECONSTRUCTION PROJECT PMUF (CI 23-007) FROM THE PROHIBITION AGAINST UNLAWFUL NOISES

WHEREAS, Oregon City Municipal Code (OCMC) 2.52.020 defines “emergencies” to include “utility or transportation emergencies”; and

WHEREAS, OCMC 2.52.040(L) authorizes the City, in cases of emergency, to “order such other measures as are necessary for the protection of life or property, or for the recovery from the emergency”; and

WHEREAS, the City would be acting in the best public interest by facilitating the completion of paving work within the 10th Street travel lanes (between 99E and Main Street) required of the Roadway Reconstruction Project (“Project”); and

WHEREAS, transportation in the vicinity of the Projects is vital to the community, and completing the needed work at night is vital to the economic and mobility interests of the City; and

WHEREAS, OCMC 9.12.023(E) declares the construction, demolition, alteration, or repair of any building or the excavation of any streets and highways in a residentially-zoned neighborhood between the hours of 6:00 PM and 7:00 AM, Monday through Friday; and between 6:00 PM and 9:00 AM on Saturday and Sunday, to be a violation.

NOW, THEREFORE, OREGON CITY RESOLVES AS FOLLOWS:

Section 1. The City Commission declares an emergency, limited to paving activities within 10th Street associated with the Roadway Reconstruction Project (“Project”) as shown in the **Exhibit A** – Site Map attached to this resolution. Consistent with OCMC 2.52.070 and by this resolution, the Commission declares an emergency from July 7, 2024, at 9:00 PM to July 18, 2024, at 7:00 AM.

Section 2. Based on the emergency identified above, the City Commission grants the construction activities in the 10th Street rights-of way exemption from Section 9.12.020 of the Oregon City Municipal Code for paving activities in 10th Street, during the period identified above in Section 1 of this resolution.

Section 3. This resolution shall take effect immediately upon its adoption by the City Commission.

Section 4. The City Commission hereby directs the City Manager and City staff to undertake all appropriate and practical measures to lessen the impacts of night-time work on City residents and businesses as authorized by this resolution.

Section 5. The City Commission adopts these procedures to prevent, minimize, respond to, or recover from emergencies consistent with OCMC 2.52.040.


