# WEST LINN CITY COUNCIL MEETING NOTES July 8, 2024

Call to Order and Pledge of Allegiance [6:00 pm/5 min]

Council President Mary Baumgardner moved to approve the agenda for the July 8, 2024, West Linn City Council Meeting. Councilor Leo Groner seconded the motion.

#### **Reports from Community Advisory Groups**

Council President Baumgardner noted many members of the public in attendance tonight were concerned about the wetlands. She advocated for the wetlands and would potentially have the City investigate purchasing the property.

Councilor Bryck reported on the South Fork Water Board meeting on June 24 where a tech overview and a cybersecurity audit were presented. The Supervisory Control and Data Acquisition system (SCADA), which monitored water flow and amounts, was isolated from the rest of the system and was at very low risk for cyberattacks.

Councilor Bonnington stated many community members had expressed concerns about escooters and e-bikes and seemed to suggest the existing laws needed to be enforced, and parents needed to remind their kids not to speed on sidewalks and to be careful in shopping centers. He had concluded he would not recommend Council consider the issue now.

Mayor Bialostosky noted an e-mail blast had been sent reminding people of the regulations regarding e-bikes.

#### Agenda Bill 2024-07-08-02: ORD 1751, AMENDING WEST LINN MUNICIPAL CODE CHAPTER 6 RELATING TO VEHICLES AND PARKING

**ORD 1751 Information** 

City Manager Williams noted Council had discussed this Code amendment several times and had provided direction for Staff to prepare an ordinance, which would be presented tonight.

Police Chief Mahuna gave a report on the ordinance which changed the boat trailer parking time allowance from four hours to 24 hours. He noted data would be collected over a year and reported back to Council. He read the changes to the Ordinance as shown in the meeting materials.

Councilor Bryck appreciated that statistics on the impact of the ordinance would be available in a year. She was concerned about unintended consequences of the ordinance and welcomed the opportunity to revisit the issue.

Council President Mary Baumgardner moved to approve First Reading for Ordinance 1751, amending West Linn Municipal Code Chapter 6 relating to vehicles and parking, and set the matter for Second Reading. Councilor Leo Groner seconded the motion.

#### Agenda Bill 2024-07-08-03: Community Recreation Center Phase II Feasibility Study Next Steps

Community Rec Center Information

Online Questionnaire Final Report

Parks and Recreation Director Big John introduced the Agenda Bill, noting the material to be covered and that Council's direction was being sought on next steps.

#### Public Comment

Charles Seims, West Linn, spoke to the impacts of the cost of a new Community Recreation Center on city residents, and noted Lake Oswego is opening a similar facility in November. He asked Council to not approve the project.

Dale Fortuna, West Linn, spoke to the cost of the project on residents, businesses, and schools, and its poor timing after the COVID-19 pandemic. Increased taxes would be an additional burden. The City had other priorities that were more important.

Ryan Mottau, MIG Opsis, gave a report highlighting the community polling and questionnaire respondent demographics and responses in support or opposed to operational and capital funding amounts as shown in the meeting materials.

#### **Presentation**

Parks and Recreation Director Big John reported on the community-provided written comments on the questionnaire with the main themes being support of the project, desire for a pool, a gathering space for the community, cost concerns of taxes and user fees, a center was unneeded, and funds needed to be used elsewhere in the city. The comments were included in the meeting packet. She requested Council's input on the next steps.

Mr. Mottau noted that though the results did not show overwhelming support, they strongly indicated community interest in the project and reluctance due to the cost. Information still needed to be disseminated to the community about the project. He noted the cost was significantly more than the project proposed in 2015 and a lot of that was due to inflation. Time would increase the cost of the project. This meeting would be the last chance to vote to include on the November ballot, though not much evidence in the poll showed an advantage in doing so.

Responses to Council questions from Staff were as follows:

- During reviews of individual properties at the Open House, assessed values were around 50 percent to 70 percent of the respondents' perceived market value of their homes. The difference was large, and the amount would depend on when the house was built and various tax laws in place at the time. Also, attendees noted the sizeable differences in the tax amount based on the assessed value of their homes, as opposed to the sale price.
- No list of other funding sources currently existed as the Parks and Recreation Advisory Board (PRAB) and the Steering Committee were waiting for the feedback from this Council meeting to determine potential next steps in approaching the private sector or other sources for alternative funding.

Council expressed the following key opinions and concerns:

- Looking at grants and the private sector for alternative funding sources makes sense to help bring costs down for residents. The Recreation Center was a good project and would bring many benefits and a lot of value to the city.
- Lake Oswego's recreation center had its school district as a substantial funding partner, which is another option to explore.
- The community has a strong desire for a recreation center, and the performance of past ballot measures for swim centers will inform people's vote, so timing is critical.
- Construction costs had increased more than any consumer price index, which had a big impact on the project. Citizens noted other needs in the city and questioned committing so much money if the City could not take care of what it already has.
- Adding the recreation center to this November's ballot was not the best plan. One benefit of waiting was that interest rates could potentially decrease, resulting in a more financially viable project.
- The risk of a five-year renewable levy was that it might not pass a second time and imperil future funding for operating the new facility.

Parks and Recreation Director Big John and Mr. Mottau noted:

- Even more outreach was needed given the confusion around the questionnaire; who could use the center; the conceptual design being based on the community's dream, which created the current cost estimates; the City's working relationship and the options already explored with the School District and Lake Oswego, which had a different type of facility; and the limited facilities Parks had to program out of.
- Last year, the Parks and Recreation Department's revenue of \$675,000 had not yet been

added into operation of the new recreation center, which would also generate revenue. More time would allow more fine tuning of the new center's potential operational costs.

- The shared understanding of what the Recreation Center could be and what it could look like was a unifying point that had only come together in recent months and having that focus made the project sellable and marketable to the community, partners, and funders.

City Manager Williams confirmed Council's direction was to continue working with elected officials, staff, and community members, and to approach funders, state agencies, Metro, etc., to find alternative funding options to cut the taxpayers' share of the costs, and then approach the community with any available additional funding. The next step would be to determine who would lead that discussion and effort.

Mayor Bialostosky suggested Council hold a joint public meeting with the Steering Committee and PRAB to discuss next steps.

#### City Manager Report [8:10 pm/5 min]

City Manager Williams reported on the operating hours of several local cooling centers, as well as West Linn's splashpads, given the high temperatures, noting the City was coordinating with the County and PGE about the possibility of power outages, and advised against using artificial turf fields in temperatures above 95 degrees.

- He noted this month's art rotation featured art from Karen LaGrave Small which including a series on climate change.
- -Council's special meeting agenda on July 15 would include a Planning Department update on the Climate-Friendly Equitable Communities Implementation, and possibly the Council stipend issue. The next Council meeting would be on August 5 followed by Council's August recess.
- Election information had been put together for the fall. The Mayor's and two Council positions would be open for the election on November 5. Those wishing to run had to file by August 27.

#### City Attorney Report [8:15 pm/5 min]

Mayor Bialostosky reported on the work he and the City Attorney had been doing on the Council stipend issue. The Budget Committee had researched Council stipends in other cities and based on the market and other councilors' job responsibilities, recommended \$15,000 per year per Councilor and \$30,000 per year for the Mayor. As per the City Charter, this change would have to go before voters for approval. At the Council meeting next week, a draft resolution would be presented to Council to make the filing deadline for the November ballot. City Attorney Wigod would send a memo to Council regarding the legal requirements around pay issues that impact the Councilors' own salaries.

City Attorney Wigod noted the Oregon Government Ethics Commission stated no conflict of interest existed for the sitting Councilors to vote to refer the stipend issue to the voters for a decision. She would send the memo tomorrow to Council.

Council President Baumgardner expressed condolences to the family and friends of Alfredo Vicario Venancio Hernandez, who had died at the boat dock. She cautioned people to be very careful in the heat.



#### Waterline Replacement Information

City Manager Williams noted the water capital needs of the City is a Council priority. This part is making sure the City is taking care of our system and later on we will be talking about the future of the system.

Assistant City Engineer Ide stated they issued a request for qualifications (RFQ) back in December which is going to replace 7,300 linear feet of substandard waterline throughout the City. The City received four proposals. ### Agenda Bill 2024-06-03-02: Oregon Department of Transportation Highway 43 Intergovernmental Agreement

City Manager Williams stated this project has been through several iterations as Council is aware, and the Intergovernmental Agreement (IGA) between the State or Oregon and the City needs to be modified to reflect the current project scope.

Management Analyst Coffie stated the amendment before Council addresses some changes to the scope of the design of this project. The City was awarded funding in 2018 through federal highway funds. This program is administered by the state and these improvements are on a state-owned facility. The City and State have been partnering to come up with a design to address multi-modal transportation safety and improve vehicular traffic flow through the corridor. To finalize the design, they had to address some changes within the original scope of work that was adopted and approved by Council in 2018. The significant change for consideration is there were supposed to be grade separated by facilities along the corridor for a certain portion. Due to budget restrictions and the length of time it has taken, that project has not been able to be fully realized. With negotiations with the state and adhering to state requirements for construction and project oversight required by the state, while also meeting the City's goal of approving safety along the corridor, the majority of the project will involve protected intersection changes at Marylhurst Drive. This will include improvement to the signaling, approve and address lacking ADA access ramps in that corridor, improve traffic flow, and pedestrian safety.

In response to Council questions, staff responded:

- State projects require project oversight above and beyond local projects so there is a cost to doing things on the state highway and they are in charge of managing the project. Both parties are trying to do what we can to facilitate and complete this project.
- The possibility of adding back in the projects in the future is a good hope. Staff is always working with the State to improve that corridor. As Council is aware, just getting potholes repaired along the corridor is always something we are striving to do. The County and Transportation Policy Alternatives Committee (TPAC) are always discussing how to improve that corridor and are always looking for additional funding.
- The City Engineer regularly attends the County regional meetings. Lobbying is very important for the Regional Flexible Funding Allocation (RFFA) and the Statewide Transportation Improvement Program (STIP) funding that will help support this. Council was very vital in attending those meetings and advocating on the City's behalf.
- This corridor does not just serve West Linn residents, it is a thoroughfare from Portland to Oregon City and to important heritage sites like the Willamette Falls Locks area.

Mayor Bialostosky stated they will continue to advocate as we continue the Vision 43 work to identify the vision for the adjacent land use along the corridor and work to seek funding for improvements along the road and maybe someday do a jurisdictional transfer if the City can reach an agreement with ODOT to reduce the regulatory burden.

Council President Mary Baumgardner moved to approve amendment to the IGA and allow for public improvements to be completed. Councilor Leo Groner seconded the motion.

#### **Purpose:**

Amend Municipal Code Chapter 6 relating to vehicles and parking to allow overnight parking of boats and boat trailers on City streets.

#### Question(s) for Council:

Does Council wish to amend Chapter 6 and allow overnight parking of boat trailers on City streets?

#### **Public Hearing Required:**

None Required.

#### **Background & Discussion:**

Community members are allowed to park their trailers, including boat trailers, on the street for four hours. When trailer parking exceeds four hours, it is a violation of city code and can be reported to the police department for the police to respond and ask people to move their boat trailers.

A couple of community members have asked that the four hours allowed for boat trailer parking be increased to 24, 48, or 72 hours.

Council discussed what is a reasonable amount of time at their November 6, 2023 and June 17, 2024, work sessions. The police department feels four hours is a short amount of time for adequate use of a boat. The police are hesitant to allow overnight boat storage at parks because of public safety risks that allowance could create.

The community member who would like this change testified at the November 6 work session and stated they would talk about it at neighborhood associations meetings, including the Willamette Neighborhood Meeting, research what other communities do, and email Council the results of this outreach and research. The Willamette Neighborhood Association informed Council they feel it is feasible to have on street boat parking for 24 to 48 hours. They asked Council to consider placing conditions on the size of the boat, the street width, and traffic issues due to safety concerns.

#### **Propose Ordinance Change**

It is proposed to revise 6.105 to add (5) to allow boats and boat trailers more than five feet in width and eight feet in length, to park for up to 24 hours on any public street that has a minimum 28' pavement width for the full length of the street where the boat or boat trailer is parked. The ordinance also prohibits boat or boat trailer parking in a manner which interferes with traffic or creates a hazard by obstructing the view of drivers.

#### Other Considerations

It is recommended to revise the code to allow boats and boat trailers to park on streets of a minimum width for up to 24 hours and re-evaluate it after 12 months to identify whether other revisions are needed to make it easier for boat owners to use their boats and not impact the public health and safety of residents. Some of the additional ordinance limitations to evaluate during this twelve-months are:

- A seasonal limit on the 24-hour boat / boat trailer parking
- A requirement that the boat / boat trailer be parked on the right of way in front of the owner's property.

#### **ORDINANCE 1751**

### AN ORDINANCE AMENDING WEST LINN MUNICIPAL CODE CHAPTER 6 RELATING TO VEHICLES AND PARKING

Annotated to show <u>deletions</u> and <u>additions</u> to the code sections being modified. Deletions are <u>bold lined through</u> and additions are <u>bold underlined</u>.

WHEREAS, Chapter II, Section 4, of the West Linn City Charter provides:

Powers of the City. The City shall have all powers which the Constitution, statutes and common law of the United States and of this State now or hereafter expressly or implied grant or allow the City, as fully as though this Charter specifically enumerated each of those powers;

**WHEREAS,** Council received emails from the community requesting Municipal Code Section 6.105, Prohibited Parking and Standing of Commercial Vehicles and Trailers, be amended to allow on-street parking for trailers, specifically boat trailers, to be longer than four hours;

**WHEREAS,** Council had a Work Session on November 6, 2023 and again on June 17, 2024, to discuss allowing boats and boat trailers to be parked on-street longer than four hours without a special permit; and

**WHEREAS,** Council is interested in modifying Municipal Code Section 6.105 allowing boat trailers to be parked on-street longer than four hours without a special permit; and

**WHEREAS**, Staff believe 24-hours is a reasonable time to allow parking of a boat on a boat trailer for use without unreasonably affecting the safety and use of the residential street;

**WHEREAS,** Council desires that the impacts of allowing boat trailers to be parked on-street for up to 24-hours shall be reviewed by Council after twelve months, with the intent to revisit the Municipal Code and either maintain, make modifications, or eliminate the allowance, as needed.

#### NOW, THEREFORE, THE CITY OF WEST LINN ORDAINS AS FOLLOWS:

**SECTION 1. Amendment.** West Linn Municipal Code Section 6.105, Prohibited Parking and Standing of Commercial Vehicles and Trailers is amended to read as follows:

6.105 Prohibited Parking and Standing of Commercial Vehicles and Trailers.

In addition to the state motor vehicle laws prohibiting parking, no person shall park or stand:

\*\*\*

(2) A trailer or semi-trailer with a bed or box in excess of five feet in width and eight feet in length upon any residential public street for a period longer than four hours unless it is loading

or unloading except with the express written permission of the Chief of Police or their designee. This prohibition shall not apply to trailers or semi-trailers owned or operated by governmental units or public or private utility companies <u>or boat trailers</u>;

\*\*\*

(5) A boat, boat trailer, with a bed or box in excess of five feet in width and eight feet in length, or both, upon any public street with less than 28' pavement width for the full length of the street where the boat or boat trailer is parked, for a period longer than twenty-four (24) hours. In no event shall the boat or boat trailer be parked in a manner which interferes with traffic or creates a hazard by obstructing the view of drivers.

**SECTION 2. Review.** The change to section 6.105 shall be reviewed by Council following a twelve-month period in order to determine whether allowing a boat or boat trailer to be parked on a street for up to 24-hours results in issues which the Council deems should result in either modification or elimination of the allowance. During the initial twelve-month period following the effective date of this Code change, the Chief of Police is charged with the responsibility to document citizen complaints received by the Police Department, or citations issued, related to boat trailer parking on city streets. A report of complaints and citations shall be submitted to Council at the end of the twelve-month period following the effective date of this ordinance.

**SECTION 3. Severability.** The sections, subsections, paragraphs and clauses of this ordinance are severable. The invalidity of one section, subsection, paragraph, or clause shall not affect the validity of the remaining sections, subsections, paragraphs and clauses.

**SECTION 4. Savings.** Notwithstanding this amendment/repeal, the City ordinances in existence at the time any criminal or civil enforcement actions were commenced, shall remain valid and in full force and effect for purposes of all cases filed or commenced during the times said ordinance(s) or portions of the ordinance were operative. This section simply clarifies the existing situation that nothing in this Ordinance affects the validity of prosecutions commenced and continued under the laws in effect at the time the matters were originally filed.

**SECTION 5. Codification.** Provisions of this Ordinance shall be incorporated in the City Code and the word "ordinance" may be changed to "code", "article", "section", "chapter" or another word, and the sections of this Ordinance may be renumbered, or re-lettered, provided however that any Whereas clauses and boilerplate provisions need not be codified and the City Recorder or the designee is authorized to correct any cross-references and any typographical errors.

**SECTION 6.** Effective Date. This ordinance shall take effect on the 30<sup>th</sup> day after its passage.

#### **Purpose:**

To provide engagement outcomes of online questionnaire for the Community Recreation Center Feasibility Phase 2 and discussion of next steps.

#### Question(s) for Council:

Does the Council want to move forward with a Bond in November 2024 or further explore private funding options with the community?

#### **Public Hearing Required:**

None Required.

#### **Background & Discussion:**

The online questionnaire that replicated the statistically valid polling was completed on June 30<sup>th</sup>. The polling and online questionnaire results show similar feedback. Both show the community divided on support of the Center primarily due to cost. Compared to the 2013 Bond, which had 30% in favor and 70% opposed, this feasibility study showed that there was a more even divide. Both results showed there is concern about the cost of the center on the taxpayers, especially those with fixed incomes. Throughout this process the desire for active recreation opportunities (including a pool) and community spaces for youth and families was a common theme. The online questionnaire final report will be provided to the Council as soon as it is completed and will be presented at the meeting. Details of the statistically valid polling results are included.

#### **Budget Impact:**

Would require a 20-year Bond to build the facility for \$65 Million or \$45 Million with additional private funding. In addition, 5-year Levy for \$1,055,00 or increased Parks Utility Fees to pay for additional staff and materials to operate the facility. The details on the funding needs can be found at <a href="Funding">Funding</a> Information | City of West Linn Oregon Official Website

#### **Sustainability Impact:**

The concept design of the building includes design features that promote the City's Sustainable Goals.

#### **Council Options:**

- 1) Direct staff to move forward with ballot measure and bring back to Council.
- 2) Direct staff to work with community on exploring private funding sources.
- 3) Direct staff to stop feasibility study and not put on a November ballot.

#### **Staff Recommendation:**

With the divided feedback for the center the likelihood of a successful November ballot measure seems unlikely. This study has shown that there is an increased interest for the Community Recreation Center, but the cost is the primary concern. There appears to be a desire to explore private funding opportunities and to not lose the momentum that this process has created. This will take community support and effort to pursue private funding options. Discussions with the Steering Committee and Parks & Recreation Advisory Committee are needed to verify that exploring alternative funding is still a desired action.

#### **Potential Motion:**

Council to decide if they want to put on the ballot in November or work with community on exploring private funding options.

### **Bonds to Construct New Community Recreation Center**



### **Initial Vote: \$65m Bond**

Shall the City of West Linn issue \$65,400,000 in bonds to construct a recreation center? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of sections 11 and 11b, Article XI of the Oregon Constitution.

If passed, bond funds are expected to finance construction of a new recreation center for all ages that is anticipated to include, without limitation:

- Multipurpose community room
- Indoor courts for sports like pickleball and basketball
- Indoor walking/jogging track
- Group workout room with exercise facilities and equipment
- Administrative and support spaces including locker rooms, lobby, and office space
- An area designated for potential future indoor pool and aquatics facility

Bonds would mature in **not to exceed 21** years from issuance. Passage of this measure would result in an estimated increase in property taxes of \$1.18 per \$1000 of assessed value.


### Initial Vote: \$65m Bond with Annual Property Tax Increase

For the average homeowner in the City of West Linn with a residence assessed at \$427,000, the annual property tax increase would be approximately \$502 per year or \$42 per month.

# **Vote Progression**



Voters initially support a \$65 million bond for a new recreation center, however, hearing the per-household cost to homeowners has a strong impact on support for the measure. Support rebounds after voters hear a variety of reasons to support the measure, and opposition messaging does not significantly impact support.



# **Initial Operating Levy Measure**



#### FIVE-YEAR OPERATING LEVY FOR PARK AND RECREATION

Shall the City of West Linn issue a five-year local option levy for parks and recreation beginning in 2025? This measure may cause property taxes to increase more than three percent.


This measure, if approved, would authorize the City of West Linn to levy taxes to support the annual operating costs of the West Linn Parks and Recreation Department including without limitation operating costs of a recreation center. The measure would provide for a local option operating levy at a rate not to exceed \$0.25 per \$1000 of taxable assessed value within the Department for five years, beginning January, 2027. The proposed rate would cost the owner of a home assessed at \$427,000, the average assessed value of a home in West Linn, approximately \$105 per year or \$8.75 per month and will raise approximately \$1,055,000 per year.

The estimated tax cost for this measure is an ESTIMATE ONLY, based on the best information available from the county assessor at the time of the estimate and may reflect the impact of early payment discounts, compression, and the collection rate.

# **Vote Progression**




Support for the operating levy moves modestly with more information – notably seeing a greater impact from opposition messaging than the recreation center bond.



### **Recreation Center Support Messaging**




Top supportive messages focus on the center's provision of recreation opportunities for people of all ages, including teen youths and families. Sports courts and wellness equipment is also convincing.



Instead of raising taxes to pay for a brand-new recreation center, we should focus on improving existing parks and rec facilities or fund more important projects like maintaining our drinking water system.




# Final Vote - Lower Bond Amount of \$45m



Finally, when hearing about a compromise bond amount that includes making up the remainder of funding through a public/private partnership, voters are equally split in their support.


Now, think back to the \$65 million bond amount. West Linn could pursue a lower bond amount of \$45 million to build the recreation center, and cover the gap in funds by raising money through a public/private partnership. The City would still need to form this partnership, so there is no quarantee it would actually happen. This version of the measure would result in an increase in property taxes of \$0.81 per \$1000 of assessed value costing the average homeowner \$345 per year or \$29 per month.

Support for the lower bond amount is stronger among higher-propensity voters, women, voters over 40 years of age, and voters with children in the household.

















# 13. In what year were you born?





# 14. Do you have any children under the age of 18 living in your home?







487	As a senior, I do not see benefits relative to the cost. There are plenty of outdoor places to walk. I would like to see more thoughts going toward more community meeting places. This concept works for families, but not for seniors. I think a better use of monies would be to fix our roads and not just patch the huge holes.
488	Increasing taxes could impose a financial burden on residents who are already struggling to make ends meet. Construction and operation of the center could have negative environmental effects, such as increased traffic, noise pollution, habitat disruption, reduction in space for concerts in the park and open spaces. In my opinion there are more pressing needs than a community center. The proposed benefits of the community center might not justify the long-term costs associated with higher taxes. Implementing higher taxes for a community center would mean that even those who may not use it or benefit directly from it would still be required to pay. This raises questions about equitable distribution of financial responsibilities among residents. There are concerns about transparency. I haven't seen details about whether there will be additional costs to actually use the facility, on top of the increased taxes. This lack of clarity raises questions about the overall fairness and affordability of the proposal. Adding a community center at a time when inflation and construction costs are high raises serious financial concerns. It's unclear how these elevated costs will impact taxpayers already dealing with economic challenges. There is a risk that funds allocated for the community center could be mismanaged or misappropriated, leading to inefficiencies or even financial losses. Uncertainty exists about the center's ability to sustain itself financially over the long term, potentially requiring continuous subsidies from taxpayers. Higher taxes could potentially lower property values in the area, affecting homeowners' investments.
490	While I like the idea of a rec center in West Linn, I think our city needs to spend our tax dollars on more crucial things like the school district. I think that bringing music, art, library and higher learning classes to the primary schools would be more beneficial to our children then a rec center would be.

This would have an overall adverse impact especially on retired empty nesters on a fixed income as our current property tax already exceeds \$10,000 / year. Do not cut the solar panels, the green roof, the parking pavers, or any of the other aspects that would make this building stand out as an example of sustainability. 732 At this price we should have an ice rink in our rec center. Would add a major revenue stream and make the facility unique and comprehensive 733 The main problem is that the City doesn't have enough commercial revenue coming in so everything is funded by homeowners taxes and there are many people here living paychecks paycheck. We would normally be 100% behind something like this. However, what is being proposed sounds like it would be very expensive for what we'd be getting. The indoor courts are great, but what this community really needs is an investment in outdoor spaces. We are so limited in our fields, and it's frustrating to see our neighbors in LO continuing to create first class outdoor spaces for soccer, lacrosse, football, softball, baseball, etc. If I were being consulted on this project and you told me I had \$40M to \$60M to potentially spend, we absolutely should focus on adding to our inventory of fields (ideally including lights), with Tanner Creek and Oppenlander being perfect places to start. I would then use the remainder of the money to create indoor athletic spaces, again to fill the gap we have for sports like Basketball and Volleyball. The school district can only handle so much, and it seems like the fields and gyms are always full (not to mention getting totally beat up...that West Linn stadium field is a mess). I would definitely think about the pool as a "nice to have". It always sounds good, but then they don't get used all that often. It's a catch-22 as far as they type of pool to build, as no one likes to swim inside during good weather, and no one wants to swim outside during bad weather. That leaves people who like to swim indoors during the off-season or perhaps do laps...it's just not that practical in Oregon, and is really expensive to build and maintain for what we get. I would also examine closely the need for a walking track (we have plenty of sidewalks and existing tracks. Maybe if it can be done efficiently at a pretty low added cost it would be OK. That being said, community fitness is cool. It would be nice to see WL really focus on getting people healthy. As far as community spaces, has there been an ask for that? We've lived here nearly 20 years, and I can't think of more than a couple of times where we've needed one. Perhaps for some sports banquets or other things like that it might make sense. It would have to be a nice space that was an improvement over the high school gym or cafeteria, but maybe a step down from the Oregon Club in terms of costs (Oregon Club is very reasonable, though). Bottom line, if we're going to go this route, let's really assess the holes in our community offering, and direct the money toward that. Let's not build a facility that ends up with a bunch of things that don't get used. I think about the fitness park down at Tanner Creek, as well as the bike paths along Rosemont, neither of which ever get much use, and just want to focus us on really getting this right if we're going to ask for this much investment from the community.

The children/teens of West Linn deserve a dedicated swim facility. The local swim teams have to drive out to pools in different cities at odd hours to complete their practices and meets. Children wanting to participate in swim lessons either have to pay premium prices for private instructors in West Linn, or try their luck and other city's pools. Oregon City's pool is incredibly old and crowded, and the North Clackamas Aquatic Park gives priority registration to residents, so no spots are remaining when registration is opened up to non-residents. Workout facilities are a great resource to the community IF they meet the needs of the community members. Unfortunately, many facilities make it difficult for parents of young children to participate in activities because there are not childcare options available. Parents are forced to workout in the wee hours of the morning or late at night, and this mostly means parents are unable to utilize this "community" resource because it excludes a significant portion of the population. each day, to be more inclusive of young parents.

I hope that in future you can show more interest in cultural activities, since it is extremely difficult for organizations such as choirs to find performance facilities in West Linn. (The schools will not guarantee availability of their auditoriums for outside groups.)

Every single time I took my kids to an indoor playground there were obviously very sick kids playing, and mine would then be sick, and have weird rashes or fevers within 2-3 days. The air flow and UV germ killing benefits outdoors while protected from rain and winter wind would be nice. A primo natural playground with logs, boulders, trickle stream, etc would be a big draw. Warm benches for adults watching their kids close to the building would be a perk. Last comment: I'd love fun affordable Zumba classes for myself! 1399 Some of the wording is confusing-if that is the text going on the ballot, I would put it into language that can be clearly understood. I am for a new facility-but it wasn't until almost at the end that I read that there could be a partnership that would lower the burden of cost. Also, all of this money ONLY goes to parks and rec and I know the city needs money for everything else-infrastructure and will be asking for that money. I am on Social Security and essentially a \$600 a year increase in taxes hurts when my SS benefit is only \$1600 a month! I would prefer that the partnership option be aggressively explored to bring down the cost of this venture.
