Subject: Amending West Linn Municipal Code Chapter 5 Relating to attracting and

feeding wild animals

Purpose:

Discuss possible amendment to Municipal Code Chapter 5 (Public Protection) to prohibit attracting or feeding certain wild animals.

Question(s) for Council:

Does Council wish to amend Chapter 5 to prohibit attracting and feeding wild animals?

Background & Discussion:

A community member spoke at the September 9, 2024, City Council Meeting about the potential health impacts and public nuisance issues with residents feeding wild animals and the unintended consequences of doing so. The food being left out was initially intended for feral cats, however it has attracted skunks, rats, and crows. The amount of bird droppings that cover play structures and backyard furniture creates a health hazard. Community members have asked for an ordinance to be created to prohibit the attracting and feeding of wild animals.

Proposed Ordinance Change

An ordinance is attached. It would add new sections to the West Linn Municipal Code that better define attractants, feeders, water features, and wild animals. The new section would prohibit attracting or feeding of wild animals by declaring it to be a public nuisance, but would create exceptions, including for birdfeeders, feeding of domesticated rabbits, and feeding under permits obtained from state agencies.

Other Considerations

This ordinance would create standards within the City of West Linn but could be very challenging to enforce, as will be discussed at the Work Session. Enforcement may be simpler with very egregious cases. Enforcement would follow the process requirements of other nuisances, which begin in MC 5.495.

The proposed ordinance has been reviewed by the City Attorney.

Council Options:

- 1) Direct staff to bring the proposed ordinance to the next Council Meeting for adoption.
- 2) Direct staff to revise the proposed ordinance and bring to the next Council Meeting for adoption.
- 3) Direct staff to conduct public outreach prior to returning to Council for a decision.
- 4) Direct staff to leave the Code as is.

Staff Recommendation:

Staff recommends moving forward with the Ordinance and recommends allowing public comment prior to further consideration, including forwarding to all neighborhood associations in a timely manner to allow their discussion at an upcoming meeting.

ORDINANCE XXXX

AN ORDINANCE RELATING TO ATTRACTING AND FEEDING WILD ANIMALS AND AMENDING WEST LINN'S MUNICIPAL CODE

Annotated to show deletions and additions to the code sections being modified. Deletions are **bold lined through** and additions are **bold underlined**.

WHEREAS, Chapter II, Section 4, of the West Linn City Charter provides:

Powers of the City. The City shall have all powers which the Constitution, statutes and common law of the United States and of this State now or hereafter expressly or implied grant or allow the City, as fully as though this Charter specifically enumerated each of those powers;

WHEREAS, the feeding of wildlife <u>animals</u>, <u>including pests</u>, in an urban environment can <u>lead</u> to <u>create a public health hazard</u>, <u>public nuisance</u>, <u>and</u> negative impacts <u>on animals</u>, <u>to people</u>, <u>animals</u>, and the environment; and

WHEREAS, feeding wildlife animals can lead to aggressive behavior towards humans, which presents health and safety concerns for residents and visitors; and

WHEREAS, feeding wildlife <u>animals</u> can artificially support the growth and carrying of capacity of urban wildlife populations, compromising wildlife health, and increasing human exposure to and conflict with wildlife; and

WHEREAS, feeding wildlife <u>animals</u> can cause certain species to localize activity in the vicinity of those food sources, thus increasing associated negative impacts on residents and visitors within those neighborhoods; and

WHEREAS, the City Council has a duty and interest in protecting public health, safety, and welfare within the City of West Linn.

NOW, THEREFORE, THE CITY OF WEST LINN ORDAINS AS FOLLOWS:

SECTION 1. New Section(s). West Linn Municipal Code Section(s) 5.540-5.4## Purpose through 5.545-5.4## Exemptions are added to read as follows:

5.540 Purpose. Feeding wild animals in an urban environment is can be both detrimental to wildlife health, and causes create a public health and safety hazard, and become a public nuisance and safety hazard that negatively impacts public health, safety, and general welfare. This chapter is intended to prohibit, with exceptions, the feeding of certain wild animals within the Ceity of West Linn so as in order to protect public health, safety, and welfare,; reduce public health risks in residential areas caused by elevated rat and mice populations, and significant accumulation of bird or other animal feces; and to prescribe penalties for failure to comply.

ORD Page 1 of

5.545 Definitions.

"Attractant" means any substance that draws animals to a particular location and includes, but is not limited to, food and garbage. Attractant does not include ponds, water features, lawns, flowers, shrubs, trees, fallen fruit, or gardens that are eaten by wild animals.

"Feeder" means any device or container used for feeding animals.

"Bird feeder" A container, receptacle or apparatus designed for the feeding of songbirds or other backyard birds.

"Feed" to give, place, expose, deposit, distribute or scatter any edible material which can be utilized for consumption by wild animals. Feeding does not include baiting for the legal taking of fish and/or game.

"Water feature" means a decorative landscaping element that incorporates water.

"Wild animal" means, for the purpose of this chapter, all non-domesticated animals, including but not limited to-(i.e., bear, cougar, coyote, deer, fox, opossum, rabbit, raccoon, skunk, rats, and other rodents), and crows.

5.540. Attracting or Feeding Wild Animals Prohibited. The attracting or feeding of wild animals within the city limits is declared to be a public nuisance and is prohibited. This prohibition includes a person repetitively placing or knowingly allowing food or other attractants to be placed on private property or public property with the intent of attracting or feeding wild animals. No person shall store pet food or animal feed in an negligent-open and accessible manner likely to attract wild animals.

5.545. Exceptions. The prohibitions in this section do not apply to:

A. Feeding of birds, other than crows; provided that the food is contained in a bird feeder which is reasonably designed to avoid access by wild animals and placed in a manner to avoid access by wild animals. [consider addition of sample city code from NJ]

- **B.** Feeding of domesticated rabbits kept in an enclosure.
- C. Feeding of wild animals kept under a valid permit issued by the Oregon Department of Fish and Wildlife.
- D. Any state, county or local government employee or agent authorized to implement a wildlife management program involving baiting, or any other person authorized to bait and trap wildlife pursuant to state law.

E. Baiting rats and mice to control population growth in the interest of public health.

F. Trapping of wild animals for the purpose of relocation to appropriate animal service organizations.

SECTION 2. Severability. The sections, subsections, paragraphs and clauses of this ordinance are severable. The invalidity of one section, subsection, paragraph, or clause shall not affect the validity of the remaining sections, subsections, paragraphs and clauses.

SECTION 3. Savings. Notwithstanding this amendment/repeal, the City ordinances in existence at the time any criminal or civil enforcement actions were commenced, shall remain valid and in full force and effect for purposes of all cases filed or commenced during the times said ordinance(s) or portions of the ordinance were operative. This section simply clarifies the existing situation that nothing in this Ordinance affects the validity of prosecutions commenced and continued under the laws in effect at the time the matters were originally filed.

SECTION 4. Codification. Provisions of this Ordinance shall be incorporated in the City Code and the word "ordinance" may be changed to "code", "article", "section", "chapter" or another word, and the sections of this Ordinance may be renumbered, or re-lettered, provided however that any Whereas clauses and boilerplate provisions need not be codified and the City Recorder or the designee is authorized to correct any cross-references and any typographical errors.

SECTION X. Effective Date. This ordinance shall take effect on the 30th day after its passage.

Subject: Severely Rent Burdened Meeting

Purpose:

Conduct a public meeting per OAR 813-112 to discuss the City's designation as severely rent burdened.

Question(s) for Council:

What are possible solutions to reduce the number of severely rent burdened households within the City?

Background & Discussion:

In 2018, the Oregon Legislature passed <u>HB 4006</u> outlining several housing reporting requirements for cities with populations greater than 10,000. This legislation identifies definitions for "severe rent burden" or "severely rent burdened" as the circumstance where a household spends more than 50 percent of the household income on gross rent for housing. A "severely rent burdened city" is a city where at least 25 percent of the renter households in the city are severely rent burdened. The determination for a severely rent burdened city is implemented by OAR 813-112-0020.

The City of West Linn was notified of its severely rent burdened status in March 2024 (see attached document from Oregon Housing and Community Services (OHCS)). This determination (30.8 percent of renter households in West Linn spend more than 50 percent of income on rent – up from 26.0 percent during last year's reporting) requires the City to hold a public meeting in accordance with OAR-813-0030 to discuss the following:

- 1. The causes and consequences of severe rent burdens within the city;
- 2. The barriers to reducing rent burdens; and
- 3. Possible solutions to reduce the number of severely rent burdened households within the city.

Staff have invited representatives from local non-profit housing providers, Clackamas County Housing Authority, and state agencies to attend and participate in the discussion.

In addition to the attached OHCS document, as part of HB2003 implementation, the City has collected additional data on housing conditions and needs within the community. This data is included in the 2021 West Linn Housing Capacity Analysis (HCA) the City adopted in October 2023.

Staff recommends reviewing the linked documents, but here are a couple of tables from the HCA that are relevant to the discussion:




FIGURE 4.3: PROFILE OF CURRENT HOUSING SUPPLY BY TYPE (2020)

Mr. Mayor and Councilors,

I understand that there have been recent examples of use of property that require correction for the health and safety of the community. However I am writing to ask you to consider changes to the proposed revised nuisance ordnance, which, as drafted, is discriminatory in its targeting of crow populations and concerning because it condones poisoning wildlife.

West Linn already has a section of the municipal code that covers the described situation: Chapter 5.425 provides that "no owner or person in charge of property may permit or cause a nuisance affecting public health." The examples given of feeding skunks to excess could be cited under this existing provision without criminalizing the behavior of our otherwise engaged, considerate neighbors.

As a bird loving resident, how am I to distinguish feeding "songbirds" from crows? A sign that reads "cute songbirds only? No Corvids allowed?"

If the concern is property damage, why are woodpeckers not included in the prohibition? The population of woodpeckers in our neighborhood will take out your siding and trees as soon as look at you. Rather than trying to parse desirable and undesirable animals, we should focus on the excessive behavior that creates the unhealthy situation.

I am also very concerned about the most recent draft of the legislation that I saw which specifically condones poisoning wildlife by excluding from the prohibition: "E. Baiting rats and mice to control population growth in the interest of public health."

"Baiting" is a euphemism for leaving out food laced with poison to attract wildlife with the intent to kill it. Those rats and mice may be eaten by cats, dogs, crows, owls and other wildlife which then become critically ill or die.

It breaks my heart that in the interests of addressing a single or limited issue we assume we have to interfere with the quiet enjoyment of our neighbors and become the suburb that tacitly (or explicitly rather) condones poisoning wildlife.

Please consider keeping the municipal code "as is". If revisions are absolutely necessary, please focus on the excess that creates the nuisance. The revisions can be drafted like any other statute that targets too much of anything, not the thing itself.

Finally, thank you for the hard work you do and your efforts to strike the right balance for our community.

Respected members of the West Linn City Council and Senator Wagner,

This is my first letter to the city council since moving to West Linn in 2018. My husband and I are both productive members of our loved community. I hope I have some of the facts wrong about the measure soon to be voted on regarding the feeding of wildlife, specifically crows. My goodness, this is certainly overreach and in the wake of the events of P'Nut the squirrel I certainly hope this motion will be unanimously shot down. The state of New York and its involved departments are going to be sued. This is how it begins. I have to assume this is in response to a neighbor, or more than one, who is against seeing any form of wildlife near their home. In my neighborhood some of us feed the squirrels peanuts, some the hummingbirds, some the crows, and there is one neighbor in the middle, hostile to it all. How ridiculous. Yes, we don't want to make wildlife dependent but showing a little love to creatures during cold spells or because we like our yards to be a haven to birds and squirrels is not something that should be punished. If hummingbirds were not fed, they would not survive the cold snaps/ice storms. How exactly will this be enforced? Are neighbors going to show proof by invading privacy and property with drones and pictures over fences? Have the unintended consequences of property rights and privacy rights been thought through? I doubt it.

A couple of summers ago we found a poor raccoon who had a broken limb in the park near us. I could get absolutely no help from any agency, state or local. Not the Audubon Society (who had the nerve to tell me they couldn't help because raccoons weren't native- exactly how many millenia are they going back?). Not Oregon Fish and Wildlife and not any other of the dozen "rescue" offices I called throughout the state and city. Should I have let this poor creature sit in the road and die? No, I fed it as often as I could and would never apologize for doing so. All our neighbors felt awful for this creature in agony. It did not threaten anything or anyone- it needed help and none was to be had. I could not even find help to get it euthanized. The person in West Linn was on vacation and despite numerous calls- I never received one back. Oregon Fish and Wildlife would not return my calls even to direct me to another agency despite numerous messages. My neighbors and I could find no help across county lines as they could not cross them to help. How about improving these mostly tax funded services instead?

I'm currently trying to befriend a stray/lost cat by leaving it some food at night when it comes by. It's too scared to approach me so this will take some time but hopefully I can humanely trap before the freezing weather sets in. What if a crow grabs some left behind kibble? Am I going to receive a fine or worse? Are we not supposed to show compassion now because of the few who FEAR wildlife rather than respect and revere it?

How about a wildlife crossing sign or slower speed signs at Mary's Woods and Mary S. Young Park where deer and wildlife are consistently mowed down. How about when you call for a deer pick up killed by the

side of the road it doesn't take 3 phone calls and subsequent days to put these beautiful creatures to rest?

Perhaps there would be a better argument to be had if this type of help was available. No one is trying to hurt wildlife. A little help and push through winter for creatures we share the land with should not be made a crime and I'm quite disgusted that there is time and effort put forth on this. How about some education programs on wildlife instead? Time and effort would be better spent on roads, schools, and supporting local businesses (many of which are suffering in West Linn) or any of the wildlife support suggestions above.

Don't turn our neighborhoods into warzones of neighbors against neighbors. Haven't we had enough of this? Enough overreach, enough bureaucracy and wasted tax money. Enough on fines that only serve to fill coffers and take away from hard working and well meaning citizens. In other words, your constituency.

Dear Mr. Mayor and Members of City Council,

Re: Proposed Attracting and Feeding Wild Animal Ordinance and addition to West Linn Municipal Code 5.540-5.545.

Thank you very much for this opportunity to speak on this issue. The ordinance that is before the council appears to be in response to one single (1) resident's actions on their own private property in a city of over 26,000 people. The individual is reported to be in violation, per given testimony for a contiguous 33 years, by their actions of Class A violations of **Offensive** and **Public Nuisance** covered under 5.400-5.495 of the West Linn Municipal code for their interactions with skunks.

5.400 Definitions.

For purposes of Sections $\underline{5.400}$ to $\underline{5.527}$, except where the context indicates otherwise, the following terms shall have the meanings given to them in this section:

<u>Offensive</u>. A condition that impacts the appearance of an area and offends the surrounding neighbors or is a fire or health hazard. This definition applies to the word "offends."

5.495 Violations - Public Nuisance Declaration - Abatement.

(1) The acts, conditions or objects specifically enumerated and defined in Sections $\underline{5.405}$ to $\underline{5.490}$ are declared to be Class A violations and public nuisances, and such acts, conditions or objects as a public nuisance may be abated by any of the procedures set forth in Sections $\underline{5.400}$ to $\underline{5.527}$.

As this seems to be one of the largest questions raised by the proposal of this new broad, sweeping, yet highly selective and targeted ordinance, please confirm in writing: the agencies involved, the abetment actions taken, and explain why this is an ongoing issue for apparently 33 years per testimony could not be resolved through communication of enforcement of existing codes or the cause for their failure.

Our community's response is weighty and rapid due to the comment in the Nov 18th meeting stating that this ordinance was to be considered in December with the addition of an emergency clause to go into effect right away. No date was given on which December meeting the vote would take place.

Selective:

The draft copies of the ordinance from the City Council agenda, specifically added on and targeted crows.

5.545 Definitions. "...including but not limited to (i.e., bear, cougar, coyote, deer, fox, opossum, rabbit, raccoon, skunk, rats, and other rodents), and crows."

5.545. Exceptions. The prohibitions in this section do not apply to:

A. Feeding of birds, other than crows; provided that the food is contained in a bird feeder which is reasonably designed to avoid access by wild animals and placed in a manner to avoid access by wild animals. [consider addition of sample city code from NJ]*

• Please tell us that we are not using New Jersy as our template for model wildlife management.

This and the rest of the wording around the addition of crows feels deliberately personal or arbitrary from the perspective of the writer(s), with qualifications tacked on to fit later. It does not read as scientifically backed, objective, or give cause as to why specifically *Corvus brachyrhyncho* is targeted and not other raptors, vultures, or other native species of birds in the Willamette Valley.

Unintended Consequences:

Proposed Ordinance 5.545 Exceptions: **"E. Baiting rats and mice to control population growth in the interest of public health"**

"Baiting" is widely and collectively known as a reference to leaving exposed poison in this case for rodents. Which is illegal in many cities, municipalities and as of Oct 1^{st} 2021, the entire state of California.

Do we really have to walk through the chain of not only complicity but direct consequences of the city inadvertently suggesting this as an alternative means of population control?

It is not a targeted kill method, there are numerous studies, articles, ad nauseum showing how effectively this kills wholesale indiscriminately and throughout the food chain including protected/endangered wildlife, (Cougars, Bald Eagles.) Pets cats and dogs, and children.

I ask that you please remove any variations of Item E. in any and all actions going forward.

Damages/Dangers

In the <u>testimony</u> given on the Nov 18th City Council meeting and in subsequent discussions, neighbors to the single (1) individual that is the cause, there are mentions of "property damage" attributed by crows. This and 'public health hazard' have been ascribed to them in these conversations.

I spent and unexpectedly very enjoyable afternoon reaching out to insurance companies and speaking with 1. Insurance Agents. 2. Property Claims Departments. 3. Insurance Adjusters. I say enjoyable due to the large amount of laughter the conversations created by those in the insurance industries. None of them had EVER heard of claims in Oregon attached to damage by crows or birds to property. Further, none of them could find any claims of property damage claims attributed to members of the Corvidae family. I was thanked personally by over three of the individuals for changing and brightening their day investigating the reported 'massive property damage' created by crows and ravens. Unless testimony can be backed by any insurance claims, or

direct relevant local evidence of genuine public health hazards, I ask that all refences of these types be stricken from consideration and influence.

Governance:

It is deeply concerning that the option of creating a new ordinance a law in perpetuity affecting all residents current and future caused by a single (1) resident whose actions can already be curtailed by existing ordinances and laws, has been put forth before the council as a viable option, over enforcement of existing ordinances and laws. We would want to see leadership of enforcement through existing laws and communication, it does not speak of strength of leadership to use such a punitive broad sweeping measure in lieu of existing and sufficient codes and opportunities of communication.

Unless we are taking the wrong tone here, and this is the right and just means of dealing with such issues based on the actions of a single (1) individual. If we choose to go forward via Governance via Ordinance from 2020 to the end of 2023. West Linn Police Logs shows Driving Under the Influence as having 388 calls with 191 arrests made of adults and juveniles. And as losing a loved one to a DUI collision is far more damaging to the community and its members. And whereas proposed municipal code 5.540-5.545 sets such firm precedence of how we will govern, then it is inescapable that if the actions of a single (1) resident shall possibly criminalize the behavior of over 26,000 residents, then the actions of between 388 to 191 residents dictate that West Linn Must have an ordinance banning all liquor sales and making West Linn a dry town effective immediately.

We must either apply this measure to all relating causes or abandon our faith in the pleasant poetry of Governance via Ordinance.

Enforcement:

Enforcement and reporting appear to learn towards neighbors reporting on each other, there is a great weariness of continued divisiveness of citizens being divided against citizens. This ordinance has the feel of community tearing rather than building in its execution.

Religion and Faith:

Please keep in mind that the way the ordinance is written or at least as it appears on paper, it weirdly and creepily singles out Crows. Which regardless of anyone of our individual thoughts, are sacred in many religions, belief systems, and to individuals. The overwhelming majority of people I have spoken with each feel a special connected relationship with members of the Corvus family. Adding them to the ordinance is not only attacking their friend, but attacking their beliefs and identity. Which is how you get people to react quickly and not in a good way.

Real quick skimming of their place in human history and faith.

As every schoolchild knows Raven created the world in in cauldron, Crows and Corvids, his Divine Cousins.

They are protected and to be riend them is to be riend the Divine.

Hinduism: As everyone knows they are most favored of Lord Rama.

Christianity: Among many others Crows are Sacred to St. Vincent, messengers to him and God.

Aboriginal culture is forever indebted to Crows for bringing man Fire.

There are so many more. But for even agnostic people in Greater West Linn they still have an aura, a sanctity, they remain the messengers, whether between their backyard, Nature, realms, their intentions, connections to God and carriers of wisdom.

None of this proves anything in particular, but when you target Crows specifically to be excluded from human interactions here on a day-to-day level, you are chipping away, taking the magic out of the Forest, the beauty out of the Wind, God out of the cathedral. You are messing with people's personal connection to nature, the planet they walk. Taking away their spirit animal and their connection, their communion with the World and the semi-otherworldly. You are taking away their connection to the Divine.

Due to Crows being a holy animal in several faiths, feeding them might be interpretated as a religious right. The specific targeting of crows in the ordinance for many, was a personal attack on their identity as an individual, how they see themselves in relation to the world and their beliefs. Blowback on such an attack had to be expected. It just seems like a better focus could have been directed elsewhere.

We live in a Wild Place:

I am not trying to make your life difficult. I am speaking from a place of deep and grateful love of where we live. We live in a wild place. During the last week of October, we graced with the beautiful sounding howls of coyotes along Fern Creek. In the Fall young male coyotes break off from their pack to try and form their own packs. Every one to two years in the Fall we look forward to hearing them come up our little hollow and then the overwhelming response of every single dog on each side of the ridge lighting up with barks, howls and yells that encourages our young coyote friends to keep looking. Less then 5 days later we had a cougar screaming just under and around our house. Another week later we watched a skunk trotting along some streets as we drove home at night. We have for the last two decades turned to each other and smiled as some other poor creature finding out a skunk's effluvium defenses. When we first moved to West Linn, we loved watching the bats dance and hunt among the trees at dusk, sadly we believe pesticides are the reason we have not had that pleasure in over a decade.

We live in a wild place; it is why we live here, it is why many residents have chosen to live here. This is why our children have love for West Linn in their hearts. The deer that constantly devour our roses and the doe and her fauns who nest under the house next door. (Our girls named the youngest one Cocco.) The adolescent bald eagles that rest atop the trees at eye level with our bedroom. The half dozen Northern Nocturnal flying squirrels we have rescued and released. The Barred owls, Barn owls, Great Horned owls, Western Screechowls, and so many others who we have silently watched and listened too for two plus decades from our back window and porches.

The newts, snakes, salamanders, frogs, lizards that we shoo out of our garden and some serenade us at night. Earlier this Fall I called my wife up as a very large Western Garter snake had made its way into our entryway. It was safely released and told to have a ssssupper afternoon. The first month we had moved into our house an exhausted colony of bees came in through a pet door and expired, we suspect as part of extended colony collapse. Unlike every other instance, none of these were a pest, nuisance, or issue, and the only time an outside agency was contacted was concerning the bees, we called OSHU to see if they wanted samples for study. We live in a wild place. Just because you don't see them or perhaps even like some of these animals does not make them not exist. This is their ecosystem as well and crows are an essential part of pest and predator control in that balance. The choices made in animals picked, again specifically crows, feels arbitrary or personal.

One of the rebuttals often cited is of a dead skunk found. I will not bother with a list of all reported road kill by county, year etc. It happens almost everywhere there is life, regardless of a person feeding or not.

Conclusion:

Please consider retaining and enforcing the existing municipal code "as is". If further solutions or code adjustment is required, focusing on the excessive actions that caused the initial issues feels much more productive and balanced. The targeting of crows in the manner that it is written is egregious and unwarranted.

Please remove all exceptions to poison as it sounds as an endorsement and it could end in a favored pet or child's death, plus the widespread indiscriminate killing of wildlife through connected food chains.

Thank you so very dearly for your time and diligence on this and so many matters that improve our community, we truly appreciate your time and work. It is also wonderful to see how many people are engaged with the political process in this issue, for some it's their first time being an active participant. Thank you for allowing them the opportunity.

As I understand it, this issue arose because neighbors complained about the feeding of feral cats creating a skunk nuisance and then was followed with a few similar complaints.

5.495 Violations - Public Nuisance Declaration - Abatement.

(1) The acts, conditions or objects specifically enumerated and defined in Sections $\underline{5.405}$ to $\underline{5.490}$ are declared to be Class A violations and public nuisances, and such acts, conditions or objects as a public nuisance may be abated by any of the procedures set forth in Sections $\underline{5.400}$ to $\underline{5.527}$.

Before voting to enact this new ordinance, please confirm in writing to me and the public that the steps in place to abate the problem were taken along with the results. If the results were not successful, why not?

In my career of negotiating a few hundred agreements, often either party would bring forward a 1 or even 10-person issue when the agreement covered a thousand. From what has been published about this issue, it appears to be a small issue to be managed without creating a division of constituents in our city with a new controversial ordinance.

I have received bird feeders as gifts. I purchase my feed from our local Backyard Bird Store. I also talk to our crows and they are allowed to eat the slugs and bugs in my gardens and occasionally apple peels from my compost.

I request that you each read the attached document, postpone your vote until you have additional information and try to come to a solution that unites our citizens, not divides us.

Oregon has ordinances and laws that prohibit feeding wild animals, including birds, in certain areas:

• **City limits**: Many cities in Oregon, including Portland and Warrenton, prohibit feeding wild animals within city limits. **These ordinances may allow feeding songbirds in a bird feeder that's designed to keep wild animals out.** Songbirds range in size from tiny hummingbirds to comparatively large crows. They are mainly land birds that live in a wide variety of situations, from open grasslands to forests.

Oregon Department of Fish and Wildlife:

Most important of the three essentials for bird life is food. Water and shelter play a lesser role. Feeding may be of two different kinds -- summer and winter. Correct feeding requires varying diet with the season. Summer feeding is usually unnecessary but will bring more birds to the feeding area for people to enjoy. Winter is the important time for feeding. Begin in early fall to attract and hold birds that would otherwise migrate farther south. Once lured from their natural wintering areas, birds concentrate around feeders in larger numbers that the area can naturally support. They are now your dependents. Feeding must continue until spring when natural foods are again abundant.

Bird Diets: Feeding birds is largely an art which must be learned through experience and observation. On the basis of diet, birds may be roughly separated into seed eaters and insect eaters. This division is not a clean one, for most fit both categories at some time in their life. The use of several different feeders or combination feeders should satisfy requirements of all. Bird Foods

Suet - Insect eaters like nuthatches and woodpeckers will consume large amounts of suet when insects and larva are not available. Avoid stringy suet. It is hard for birds to eat. Suet may be made available plain or in any large-mesh container. A better way is to grind it, melt in a double boiler, and pour into molds to harden. It is more durable if the melted suet to any of the seeds or mixtures listed below. Melted suet or suet-seed mixtures should be placed in suet stick feeders while in a semi-liquid state.

Peanut Butter - May be used in place of suet in manner described above. It is much more expensive, however, Look into obtaining substandard quantities for bird feeding.

Seeds - Even insect eaters consume some seeds, especially in winter. Seeds will attract many different kids of birds. Grocery, pet, or feed stores will carry the following materials for seed feeding.

- sunflower
- hempseed
- millet
- buckwheat
- wheat
- cracked corn
- rice
- chopped nuts
- oatmeal
- bread crumbs (dried)
- popcorn
- commercial birdseed mix Dog biscuits, rabbit food, raisins, and other such items are also used in mixtures.

A good homemade mixture is 3 parts sunflower, 3 parts hempseed, 3 parts millet, and 1 part buckwheat. Several mixtures should be experimented with to complete the diet.

Hummingbird food - A solution of 1 part sugar or thinned honey to 4 parts water. Red food coloring may be added or the outside of the feeder painted an attractive color.

Placement of Feeders: Feeders should be placed with protection in mind. Squirrels, cats, or other predators should be unable to gain access to feeding stations. Escape routes to nearby trees or shrubbery must be available. These cover plants also provide a place to Perch before going to feed. Feeders should be protected from Weather by facing them away from the wind. South or east sides of buildings provide the most sun and warmth. Placement must also consider ease in servicing and refilling. Locations where

large drifts form or high ladders are required will likely result in empty and ineffective feeders.

WILDLIFE CONTROL

6.15.040 Feeding, baiting, and maintaining wildlife prohibited – Notice – Abatement.

(1) The following is hereby declared to be a public nuisance and unlawful: (a) feeding, baiting, and/or maintaining any wildlife, including, without limitation, hand feeding or setting out food to be left attended or unattended, which creates or has the potential to create a hazard to the public health, safety, and/or welfare of humans and/or property; (b) leaving, storing, and/or maintaining any feed or attractant in a manner and location accessible to any wildlife which creates or has the potential to create a hazard to the

public health, safety, and/or welfare of humans and/or property; and/or (c) feeding stray or feral cats if such feeding creates or has the potential to create a hazard to the public health, safety, and/or welfare of humans and/or property.

- (2) A person who violates subsection (1) of this section may be issued a written notification by the city manager requiring the person to remove the food, garbage, bait, and/or other attractant within three days of notification. A person who receives a written notice under this subsection (2) will immediately remove the food, garbage, bait, and/or other attractant as directed.
- (3) Any nuisance described in this chapter that is allowed to continue by any person responsible for a period of more than three days after notification by the city manager under subsection (2) of this section may be subject to city's nuisance abatement and enforcement procedures and penalties and/or any other rights and remedies available to city, including, without limitation, city's rights and remedies provided under this chapter. Notwithstanding anything contained in this chapter to the contrary, if the city manager reasonably determines that a nuisance described in this chapter imminently threatens and/or endangers the public health, safety, and/or welfare of humans and/or property, the city manager may cause such nuisance to be summarily abated.
- (4) If any part or area within city's jurisdictional limits experiences the presence of wildlife and/or feral cat populations that endangers, threatens, and/or creates a hazard to the health, safety, and/or welfare of humans and/or property, city may take those

steps authorized by the appropriate regulatory agency to disperse or otherwise control the offending wildlife and/or feral cats. [Ord. 15-837(2) § 5, 2015]

6.15.050 Exceptions – Feral cats.

The prohibitions described in BMC 6.15.040 do not apply to the following: (1) feeding birds, other than waterfowl, utilizing a bird feeder that can be accessed only by birds; (2) feeding livestock in normal agricultural operations; and/or (3) feeding wildlife kept under a valid license or permit issued by the Oregon Department of Fish and Wildlife, and in compliance with all applicable federal, state, and local laws, regulations, and ordinances, by the person who is the legal owner or guardian of such wildlife. Nothing in this chapter will prohibit the actions of an authorized agent of the state of Oregon lawfully engaged in a wildlife or waterfowl management program. Any person feeding stray or feral cats may be required to cooperate with any humane program (which is supported by or operating under the auspices of local governmental authorities) that traps stray and feral cats for the purpose of spaying/neutering the cats, immunizing the cats from rabies, and then returning the cats to their environment in the general vicinity in which they were trapped. [Ord. 15-837(2) § 6, 2015]

6.15.070 Enforcement - Penalties.

This chapter will be enforced by any sworn peace officer authorized to enforce the laws of city and any other city official authorized to administer city's land use, development, nuisance, building, and/or other regulations. In addition, city may initiate appropriate suit

or legal action in a court of competent jurisdiction to enforce this chapter. **Any violation** of this chapter is punishable by a fine not to exceed \$250.00 per violation. City will be entitled to collect from any person violating this chapter city's attorney fees and other fees, costs, and expenses incurred by city to enforce this chapter. Each violation, and each day that a violation continues, constitutes a separate civil infraction. The remedies available under this chapter are not exclusive of any other remedies available under any applicable federal, state, and/or local laws, regulations, and/or ordinances. It is within city's discretion to seek cumulative remedies for a violation of this chapter. Nothing in this chapter will be construed to relieve a person from complying with any applicable federal, state, and/or local laws, regulations, and/or ordinances. Failure of any person responsible to receive a notice required under this chapter and/or an error in the name or address of the person responsible will not render the notice void and in such case the notice will be sufficient. [Ord. 15-837(2) § 8, 2015]

Subject: Wildlife Feeding Ordinance

I would like to thank the Mayor, City Council, Police Chief, and others from the City for the progress on the wildlife feeding issue. What follows are three suggestions on the draft wildlife feeding ordinance dated Nov 22.

First, the definition of "bird feeder" (below) uses the terms "songbirds" and "apparatus". As you probably know by now, crows are part of the songbird order of birds. In my research, crows can be fed on an elevated platform feeder without a "container", and one could reasonably say that such a platform feeder is an "apparatus". I surveyed many other wildlife feeding ordinances and most did not define "bird feeder".

"Bird feeder" A container, receptacle or apparatus designed for the feeding of songbirds or other backyard birds.

Second, in paragraph 5.540 (below) – It seems to me this may not address the person who regularly feeds their dog or cat on the back porch, and some uneaten food sits in the food bowl and attracts wildlife. The person might assert they were not "storing" the food, or they had no "intent" of feeding wildlife.

5.540. Attracting or Feeding Wild Animals Prohibited. The attracting or feeding of wild animals within the city limits is declared to be a public nuisance and is prohibited. This prohibition includes a person repetitively placing or knowingly allowing food or other attractants to be placed on private property or public property with the intent of attracting or feeding wild animals. No person shall store pet food or animal feed in an negligent open and accessible manner likely to attract wild animals.

Third, in my opinion, the bird feeding portion (5.545 below) should prohibit attracting rats, especially because it impacted our neighborhood. As most of us know, feeding birds from a feeder often results in seeds falling to the ground and attracting rats. Imagine an egregious case where the person has many feeders and is not doing enough to prevent rats from eating the seeds that fall to the ground. If this is not included in the ordinance, the person feeding the birds might reasonably assume feeding birds is listed as an exception and nothing in 5.540 applies, or they might claim they did not intend to attract rats. Adding something about not attracting rats would articulate one of the chief health risks with bird feeding and it may provide the neighbors and police something helpful to resolve the situation.

5.545. Exceptions. The prohibitions in this section do not apply to:

A. Feeding of birds, other than crows; provided that the food is contained in a bird feeder which is reasonably designed to avoid access by wild animals and placed in a manner to avoid access by wild animals. [consider addition of sample city code from NJ]
