

RESOLUTION NO. 690 - 9-71

A RESOLUTION ACCEPTING THE IMPROVED STREETS IN JAN PARK SUBDIVISION FOR MAINTENANCE PURPOSES.

WHEREAS, the hereinafter described streets in Jan Park Subdivision were dedicated to the public for public use in the original subdivision plat, and,

WHEREAS, the owner has improved said streets as follows:

1. S.E. Alder Street from the west line of said subdivision easterly, 480 feet to S.E. 37th Avenue to a width of 36 feet between curbs.
2. S.E. 36th Avenue from S.E. Alder Street northerly 428.6 feet to the north line of said subdivision to a width of 36 feet between curbs.
3. S.E. 37th Avenue from the north line of S.E. Bentley Street northerly 212.0 feet to a width of 36 feet between curbs.
4. S.E. 37th Avenue from S.E. Alder Street northerly 416.2 feet to the north line of said subdivision to a width of 32 feet between curbs, and,


WHEREAS, on August 26, 1971 the City Engineer of the City of Hillsboro did certify to the City Manager that said streets have been improved by the owner and have been completed in accordance with the City of Hillsboro specifications including grading, base rock, curbs and asphaltic pavement and such drainage as is necessary.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Hillsboro that the above described streets are hereby accepted by the City for maintenance purposes, and that the owner is hereby relieved of any further maintenance cost on said streets.
