## ORDINANCE NUMBER 1481

AN ORDINANCE OF THE CITY OF MILWAUKIE DECLARING THE ASSESSMENTS FOR STREET IMPROVEMENT PROJECTS.

WHEREAS, the following described improvements have been made and it is necessary to assess the cost to the benefitted property, and

WHEREAS, Ordinance No. 1278 provides that the Council shall levy the assessment in accordance with ORS 223.389, and

WHEREAS, the Council finds that all objections to the proposed assessments are overruled,

NOW, THEREFORE, THE CITY OF MILWAUKIE DOES ORDAIN AS FOLLOWS:

Section 1. The cost of the following described improvements are apportioned and assessed in the manner described on the attached exhibits:

- a. Street improvement, storm sewer, and waterline extension for SE International Way from the east boundary of the Freeman Industrial Park to SE 40th Avenue. (Exhibit A.)
- b. Street improvement, storm sewer and waterline extension for SE Edison Street from SE 37th Avenue to SE 40th Avenue. (Exhibit B.)
- c. Street improvement of SE 36th Avenue from SE Roswell Street to Johnson Creek Boulevard. (Exhibit C.)

Section 2. The Recorder is directed to enter the assessments in the City lien records in the manner provided by Ordinance No. 1278.

Read the first time on <u>February 17</u>,1981 and moved to second reading by unanimous vote of the City Council.

Read the second time and adopted by the City Council on March 3 , 1981.
