A RESOLUTION TO THE PORTLAND METROPOLITAN AREA LOCAL GOVERNMENT BOUNDARY COMMISSION REQUESTING ANNEXATION OF THE UNINCORPORATED PORTION OF THE PLAT OF RONLER ACRES SUBDIVISION.

WHEREAS, recent annexations to the City of Hillsboro have isolated the majority of Ronler Acres subdivision as an unincorporated island within the Hillsboro city limits, and

WHEREAS, ORS 227.750 authorizes cities to initiate annexations of unincorporated islands within their city limits without receiving prior petitions from the affected property owners, and

WHEREAS, the Hillsboro Planning Commission, at its regular meeting of February 12, 1985, adopted Resolution No. 305-P, initiating the annexation of the unincorporated portion of the plat of Ronler Acres subdivision, and

WHEREAS, the Hillsboro Planning Commission held a public hearing on the proposal on March 26, 1985, and voted to recommend that the City Council approve the annexation, and

WHEREAS, the portion of the territory that lies in the Washington County Rural Fire District No. 2 and within the boundaries of the Unified Sewerage Agency would, by operation of ORS 199.510, be automatically withdrawn from those districts immediately upon consummation of the annexation, and

WHEREAS, the City Council does hereby favor the annexation of the subject property and will insure that a representative of the City will appear before the Boundary Commission to testify in favor of this annexation request.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF HILLSBORO that the City, by and through this resolution, requests annexation of the following described tracts of land to the City of Hillsboro, Oregon:
