

RESOLUTION NO. 1369

A RESOLUTION OF INTENT TO ASSESS THE COST OF MOWING TALL GRASS AND WEEDS TO ABATE POSSIBLE FIRE HAZARDS ON CERTAIN LOTS IN THE CITY OF HILLSBORO, WASHINGTON COUNTY, OREGON.

WHEREAS, the City of Hillsboro mowed tall grass and weeds located on certain tax lots within the City during the Summer of 1986 as per Ordinance No. 1721, as amended, and

WHEREAS, the property owners were billed for amount due, and

WHEREAS, the property owners failed to make the necessary payments, and

WHEREAS, Section 110 and Chapter XXIX of the Amended Charter of the City of Hillsboro authorize and provide a procedure for assessing these costs to the properties.

NOW, THEREFORE, BE IT RESOLVED THAT, unless there are valid objections, the City shall assess the cost for mowing of tall grass and weeds, plus the appropriate processing fee, as established by Resolution No. 1156, as follows:


