#### NEIGHBORHOOD COUNCIL REPORTS

Neighborhood Council 3 executive board has sent memorandum, dated May 26, 1977, on duck crossing signs. Mrs. Burgess had also written a memo on this subject, dated June 1, which was listed later on the agenda. Reporter for the Milwaukie Review presented two "duck crossing" signs to the Council.

It was MOVED by Hutchison, SECONDED by Hupp, to amend the motion to be not to exceed eight signs. On the amending motion, MOTION CARRIED unanimously.

Mr. Manuel asked for a map of the area showing which properties are on the sewer at present. Kenneth Barton, 1660 SE Waverly, asked for a copy of such a map, when prepared.

## MEMORANDUM FROM PLANNING COMMISSION RE ZC-77-1

As requested by Council, the Planning Commission, in memo dated June 2, 1977, has adopted and recommends to the Council, findings as part of the Commission's action recommending denial of an application to change zoning at Oak and Campbell Streets from A-2 to A-1-B (ZC-77-1).

It was MOVED by Hutchison, SECONDED by Swan, to uphold Planning Commission recommendation for denial of ZC-77-1, based upon the facts presented in the Planning Commission memo of June 3, 1977. MOTION CARRIED unanimously.

Staff was asked to prepare a proposed amendment to the zoning ordinance making a Planning Commission denial of zone change final, unless appealed to the Council.

#### AWARD OF BID - LAKE ROAD BIKEWAY

City Manager has written memo, dated June 2, 1977, with a recommendation on Lake Road bikeway. It was MOVED by Hutchison, SECONDED by Swan, to accept the Manager's recommendation and authorize proceeding with the Lake Road bikeway project in the amount of approximately \$82,000, city participation to be in the amount of \$23,000, with the difference from bikeway fund reserves to be taken from street and storm drain line items; also that the bid as submitted by Wes Notz Construction Company, in the amount of \$81,828.50, be awarded, and all other bids rejected. MOTION CARRIED unanimously.

## SE 17TH/MILPORT ROAD BIKEWAY

J. Wayne Daigle has written memo to Manager, dated May 23, 1977, concerning SE 17th/Milport Road bikeway. It was MOVED by Hupp, SECONDED by Swan, to accept the bid of Cascade Construction Co. on Schedules A, B and C, in the amount of \$24,434, for bikeway construction along SE 17th Avenue from McLoughlin Boulevard to Ochoco Street. It was MOVED by Swan, SECONDED by Hupp, to read Ordinance Number 1366 (AN ORDINANCE WITHDRAWING THE ASSETS OF THE FORMER PORTLAND SUBURBAN WATER DISTRICT PROPERTY WHICH HAS PREVIOUSLY BEEN ANNEXED INTO THE CITY OF MILWAUKIE) the first time by title only. GARBAGE RATE INCREASE REQUEST

Finance Director has written memorandum, dated June 1, 1977, concerning request by representatives of garbage franchisees for rate increase. Representatives of the franchisees stated they are no longer represented by Attorney Dale Harlan. DENTAL PLAN COSTS

SEWER ASSESSMENT MODIFICATION - LINCOLN PROPERTIES
Finance Director has written memorandum, dated June 1, concerning request of Lincoln Property Company, in letter dated May 25, for adjustment of lines on sewer assessment on property owned by the company in Omark Industrial Park.
