COUNCIL CHAMBERS1092nd Meeting

The one thousand ninety-second meeting of the Council of the city of Milwaukie, Oregon, was held on the 9th day of December, 1968. The meeting was called to order by Mayor Robert E. Richmond with the following councilmen present:

The invocation was given by the Reverend Arthur Peters, First Baptist Church.

It was moved by Slominski, seconded by Strauss, that the minutes of the regular meeting of November 25, 1968, be approved as written. Motion carried and so ordered.

It was moved by Slominski, seconded by Strauss, that the minutes of the special meeting of November 8, 1968, be amended as follows: Under "CIVIL SERVICE COMMISSION APPOINTMENT" change "... that the Council reappoint Kenneth J. Levstone to the Civil Service Commission of the City of Milwaukie for a two-year term..." to "... that the Council reappoint Kenneth J. Levstone to the Civil Service Commission of the City of Milwaukie for a four-year term...". Motion carried and so ordered.

CORRESPONDENCE

A letter from Columbia Region Association of Governments was read, giving notice of public hearing on December 13 concerning the formation of the Clackamas County recreation district #2.

CHALET L'ABBE APPEAL

Notice of appeal from revocation of conditional permit was read, signed by Mr. and Mrs. Gordon Watkins, of the Chalet l'Abbe. The Council also received a letter from Attorney Fred M. Aebi, asking that he be advised of any hearing on the matter.

Mrs. John A. Burgess, 2208 S. E. River Road, presented petitions to the Council signed by property owners in the area, supporting the decisions of the Planning Commission concerning the Chalet l'Abbe, and opposing any zone change in the area.

It was moved by Strauss, seconded by Slominski, that the City Manager be directed to set an appeal hearing date, and that the parties concerned be notified of this date. Motion carried and so ordered.

ORDINANCE NUMBER 1186, AMENDING FEE-SETTING ORDINANCES

It was moved by Slominski, seconded by Strauss, that Ordinance Number 1186 (AN ORDINANCE AMENDING ORDINANCES NUMBERS 471, 489 AS AMENDED BY 535, 518 AS AMENDED BY 574, 520, 546, 549, 558, 592, 633, 770, 772 AS AMENDED BY 1073 AND 1099, 981 AS AMENDED BY 1047 AND 1063, 1075, 1098, 1107, 1157, 1162, 1175 AND 1183; PROVIDING FOR ESTABLISHING BY RESOLUTION OF THE COUNCIL OF THE CITY OF MILWAUKIE FEES FOR SERVICES, PERMITS, PETITIONS, APPLICATIONS, NOTICES, APPEALS AND OTHER FILINGS MADE WITH THE CITY; AND DECLARING AN EMERGENCY) be read the first time. Motion carried and so ordered. After reading, it was moved by Strauss, seconded by Slominski, that Ordinance Number 1186 be read the second time at the next regular meeting of the Council. Motion carried by the unanimous vote of all Council members present, and so ordered.

CIVIL SERVICE COMMISSION APPOINTMENT

It was moved by Slominski, seconded by Strauss, that Gary McClain, Milwaukie attorney, be appointed to fill out the remainder of the term of Vernon Thompson, who retired for reasons of health, on the Milwaukie Civil Service Commission, The term will end November 12, 1971. Motion carried and so ordered.

BUSINESS LICENSE RENEWAL


It was moved by Slominski, seconded by Strauss, that the business license of Harger's Mower Shop be renewed. Motion carried and so ordered.
