

MEETING OF AUGUST 27, 1956

COUNCIL CHAMBER

899th MEETING

The eight hundred ninety-ninth regular meeting of the Council of the City of Milwaukie, Oregon, was held on the twenty-seventh day of August, 1956

The meeting was called to order by Mayor Mullan.

Present: Mayor Mullan; Councilmen Clay, Perkins, Shook and Klein; Manager Burdick, Attorney Sheldahl and Recorder Martin.

The minutes of the eight hundred ninety-eighth regular meeting of the Council, held on the thirteenth day of August, 1956, were approved as written.

Mr. Charles Wilder and Mr. John Botsford, owners of property along 34th Street, Quincy Addition, were present. Mayor Mullan read the following letter.

City Council,
City of Milwaukie,

We, the following property owners on 34th Street do hereby accept the ten percent adjustment on sidewalk and curb assessment as offered by the City Council of Milwaukie.

Mr. Wilder called attention to the fact that he had not signed the letter and stated that he did not think ten percent of the cost would be sufficient to bring his walk up to standard. Manager Burdick stated that Mr. Knapp, appraiser, appointed by the property owners, had suggested a way the walks could be fixed to take care of expansion, which appears to be the cause of much of the trouble, and that he (Mr. Knapp) had quoted a price of \$5.00 for putting in such repair. Mr. Burdick pointed out that Mr. Wilder's ten percent discount would amount to \$49.17. It was moved by Shook and seconded by Klein that the Council allow a ten percent discount to the property owners, on the assessment for the improvement of 34th Street by curbs and sidewalks, and that a re-hearing for this assessment be held on the 10th day of September, 1956. Motion carried and so ordered.

The Recorder announced that this was the time set for a hearing on the vacation of Streets in Milwaukie Industrial Park, formerly known as Kellogg Park. It was shown that proper notices had been published and posted for this vacation. The Mayor called for any objections or protests to the vacation of "B" Street, "C" Street, "D" Street, "E" Street and "F" Street in the West side of Milwaukie Industrial Park and Road "A", Road "B" and Road "C" in the east side of Milwaukie Industrial Park. There had been no written protest or objection filed with the Recorder, and there was no person present who made protest or objection to the vacation of the streets as listed above. Ordinance Number 653 was taken up and read in full for its first reading. It was moved by Klein and seconded by Shook that Ordinance Number 653 be passed to its second reading and that it be read at this time. Motion carried and so ordered. Ordinance Number 653 AN ORDINANCE vacating certain public Streets heretofore dedicated as such in that part of Milwaukie Industrial Park, Milwaukie, Oregon, formerly known as Kellogg Park, Milwaukie, Oregon, lying to the west of U.S. Highway 99E, the plat of which is recorded in Book 26, Page 13, Record of Townplats, Clackamas County, Oregon, and fixing the effective date of such vacation, was taken up and read for its second reading and put on its passage with the following results being had: Ayes: Mullan, Clay, Perkins, Shook and Klein. Nays: None. Ordinance Number 653 passed the Council and was so declared by the Mayor.

Ordinance Number 654 was taken up and read in full. It was moved by Klein and seconded by Clay that Ordinance Number 654 be passed to its second reading and that it be read at this time. Ordinance Number 654 AN ORDINANCE vacating certain public streets heretofore dedicated as such in that part of Milwaukie Industrial Park, Milwaukie, Oregon, formerly known as Kellogg Park, Milwaukie, Oregon, lying to the east of U.S. Highway 99E, the plat of which is recorded in Book 26, Page 13, Record of Townplats, Clackamas County, Oregon, and fixing the effective date of such vacation, was taken up and read for its second reading and put on its passage with the following results being had. Ayes: Mullan, Clay, Perkins, Shook and Klein. Nays: None. Ordinance Number 654 passed the Council and was so declared by the Mayor.

Manager Burdick reported progress on the extension of Main Street and stated that he would be able to get dirt for the fill. Mr. Burdick also reported his plans for street repair and maintenance and the anticipated cost of same and stated that he expected to have enough money to pave 34th Street from Wister Street to Lake Road this year. The Council approved Mr. Burdick's plan and authorized him to proceed with the Main Street extension and the paving of a portion of 34th Street as outlined.

Manager Burdick read a letter from Henry A. Fischer, manufacturer of Fischer's Flavor Seal, requesting a change of zone for Tax Lot 81, Whitcomb D.L.C. located at 2326 Washington Street. This matter was referred to the Planning Commission.

Manager Burdick read the following Resolution and requested that it be adopted.

RESOLUTION NUMBER 16-1956

RESOLUTION REQUIRING THE CITY TREASURER TO FILL AND PERFORM THE DUTIES OF TWO OFFICES, NAMELY, THAT OF TREASURER AND THAT OF RECORDER.

WHEREAS the Charter of the City of Milwaukie, Oregon, as amended, provides by Section 5 of Chapter II thereof that the City Council may require any officer of the City appointed by the City Manager to fill and perform the duties of two or more offices, and

WHEREAS the City Council now deems it expedient and for the best interests of the City of Milwaukie that the City Treasurer be required to fill and perform the duties of both the City Treasurer and the City Recorder.

NOW THEREFORE, BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF MILWAUKIE, OREGON, THAT Jean Dillery be and she is hereby required to fill and perform the duties of both the City Treasurer and the City Recorder from and after the Dec 1 day of December 1956.

It was moved by Klein and seconded by Clay that Resolution Number 16-1956 be adopted. Motion carried and so ordered.

Ordinance Number 652 was taken up and read for its first reading. It was moved by Shook and seconded by Klein that Ordinance Number 652 be passed to its second reading and that it be read at this time. Motion carried and so ordered. Ordinance Number 652, AN ORDINANCE providing for the sale, in furtherance of the public interest, of certain real property owned by the City of Milwaukie, Oregon, not deeded for public use, authorizing and directing the Mayor to execute a deed for said property on behalf of said city, and declaring an emergency, was taken up and read for its second reading and put on its passage with the following results being had: Ayes: Mullan, Clay, Perkins, Shook and Klein. Nays: None. Ordinance Number 652 passed the Council and was so declared by the Mayor.

Councilman Shook reported that the Traffic Committee had made a survey of traffic conditions in the City. There was discussion on this matter.

It was moved by Shook and seconded by Clay that the following Resolution be adopted.

RESOLUTION NUMBER 17-1956

A RESOLUTION RELATING TO STOP SIGNES AT THE INTERSECTION OF OAK AND WASHINGTON STREETS AND AT HARRISON AND 32nd STREETS.

WHEREAS, extreme traffic hazards now exist at the intersection of Oak and Washington Streets and at Harrison and 32nd Streets, in Milwaukie, Oregon, and

WHEREAS, the Council of the City of Milwaukie, Oregon, deems it expedient to provide that all vehicular traffic be required to stop before entering into and upon Washington Street from Oak Street, excepting that vehicles making a right turn onto Washington Street at the intersection of Oak Street shall be excused from stopping before proceeding on to Washington Street; and

WHEREAS, the Council of the City of Milwaukie, Oregon, deems it expedient to provide that all vehicular traffic traveling in a westerly direction, in and upon Harrison Street, Milwaukie, Oregon, shall stop at the easterly line of the intersection of 32nd Street and Harrison Street before proceeding in any direction,

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MILWAUKIE, OREGON that pursuant to the provisions of Ordinance Number 530 of the said City of Milwaukie, Oregon, all vehicles shall come to a complete stop before entering Washington Street from Oak Street, except those vehicles which turn right into and upon Washington Street.

BE IT FURTHER RESOLVED BY THE COUNCIL OF THE CITY OF MILWAUKIE, OREGON that, pursuant to the provisions of Ordinance Number 530, of the said City, all vehicles traveling in a westerly direction shall come to a complete stop before entering the intersection of 32nd Street at Harrison Street.

BE IT FURTHER RESOLVED BY THE COUNCIL OF THE CITY OF MILWAUKIE, that the City Manager of Milwaukie, Oregon, be and he is hereby directed to place and erect suitable signs to indicate the stopping requirements and the turning provisions, provided by this Resolution, and to see that the same are properly placed at the indicated intersections.

BE IT FURTHER RESOLVED BY THE COUNCIL OF THE CITY OF MILWAUKIE, OREGON, that this Resolution be and the same is hereby made effective as of the day that such suitable signs are erected at the hereinabove indicated streets.
