

MEETING OF DECEMBER 12, 1955

COUNCIL CHAMBER

382nd MEETING

The eight hundred eighty-second regular meeting of the Council was held on the fifteenth day of December, 1955.

The meeting was called to order by Mayor Mullan.

Present: Mayor Mullan, Councilmen Shook, Clay and Klein; Manager Burdick, Attorney Sheldahl and Recorder Martin. Absent: None.

The minutes of the eight hundred eighty-first regular meeting of the Council, held on the twenty-eighth day of November, 1955, were approved as written.

The minutes of a special meeting of the Council, held on the fifth day of December, 1955, were approved as written.

Mr. Morris C. Martin, laid before the Council, a written consent to annex to the city, signed by the owners of a tract of land which lies between Keil Heights and Martin Heights in the J.D. Garrett D.L.C. and requested that this territory, which is contiguous to the present boundaries of the City, be annexed to the City.

Ordinance Number 626 was taken up and read in full for its first reading, (calling for hearing on Martin annexation) It was moved by Klein and seconded by Clay that Ordinance Number 626 be passed to its second reading Motion carried and so ordered.

Mrs. G. Fischer laid before the Council, a petition, signed by fifty-one citizens residing in and near Milwaukie, requesting that the cross-walk pedestrian lane, crossing McLoughlin Blvd. at the south side of Monroe Street intersection, be re-opened. The matter was discussed at some length and it was decided that Manager Burdick would take the matter up with the State Highway Department.

Ordinance Number 624, AN ORDINANCE amending Ordinances No. 481 and No. 559, and providing for the re-zoning of certain real property located within the boundaries of the City of Milwaukie, Oregon, was taken up and read for its second reading and put on its passage with the following results being had, Ayes: Mullan, Clay, Shook and Klein. Nays: None. Ordinance Number 624 passed the Council and was so declared by the Mayor.

Ordinance Number 627 was taken up and read in full for its first reading. It was moved by Klein and seconded by Shook that Ordinance Number 627 be passed to its second reading. Motion carried and so ordered.

Manager Burdick read a letter from Chief of Police Nichols, in which he recommended that traffic signs be checked and replaced where they are missing, and that all stop streets be properly marked.

Attorney Sheldahl reported that he had been making a search of the titles of Block 39 and 52 Milwaukie, and the present status of this property

The Police Chief's monthly report was read and ordered filed.

It was moved by Shook and seconded by Clay that the following bills be approved and that warrants be drawn for the payment of same.
