

MEETING OF SEPTEMBER 25, 1944

COUNCIL CHAMBERS

613th MEETING

The six hundred thirteenth regular meeting of the Council was held on the twenty-fifth day of September, 1944.

The meeting was called to order by Mayor Roberts.

Present. Mayor Roberts; Councilmen Bevington, Sperr and Rowe. Water Superintendant Counsell, Fire Chief Lewellyn and Recorder Martin, Absent: Councilmen McClure and Newman and Treasurer Walcott.

The minutes of the six hundred twelvth regular meeting of the Council, held on the eleventh day of September 1944, were read and corrected.

Mr. H.M.Christen came before the Council and made application for a license to operate a Convelascent Home at Block 2 Streib's First Addition. Fire Chief Lewellyn reported that he had made a survey of the property and that, with the exception of one or two minor things, Mr. Christen had complied with the requirements of the State Fire Marshall. Mr. Lewellyn also reported that Mr. Christen had promised to place necessary fire extinguishers in the building and to correct any other fire hazard that had been pointed out. Dr. Remley reported that the rooms in the building were sufficiently large and that there were adequet bath rooms, and, although the place was incomplete and unoccupied, Mr. Christen seemed to be making an effort to comply with the regulations of the State Board of Health. It was moved by Rowe and seconded by Sperr that Mr. Christen be granted a license to operate a Convelascent Home at Block 2 Streib's First Addition conditioned upon his compliance with Ordinance Number 446. Motion carried and so ordered.

Mr. Bringle, pastor of the Seventh Day Adventist church on Harrison St., came before the Council and made request to rent the auditorium in the City Hall for meetings three nights per week during October, November and December. After some discussion it was agreed that in as much as the Auditorium was used for public meetings, or meetings of orginazitions of public nature, it should not be rented for regular meetings.

It was moved by Sperr and seconded by Bevington that the Recorder institute proceedings for the vacation of the alley extending from 28th street to 29th street in Block "A" Kerr & Shindler's Addition. Motion carried and so ordered.

It was moved by Rowe and seconded by Sperr that the City sell Lot 7 Block 2 Duerst's Addition, to Harry Dean, for the full amount of the City's Lien against same. Motion carried and so ordered.

The Fire Chief's monthly report was read and ordered filed.

It was moved by Sperr and seconded by Rowe that the following bills be allowed and that the Recorder be directed to issue warrants for the payment of same.
