

COUNCIL CHAMBER'S AUGUST 14, 1939

The four hundred ninety-fourth regular meeting of the Council was held on the 14th day of August, 1939.

The meeting was called to order by Mayor Burdick.

Present: Mayor Burdick, Councilmen Gillem, Kirkpatrick, Mourer, Roberts and Rudder; Water Superintendent Bevington, Fire Chief Lewellyn, Marshal Stanley and Recorder Adams.

The minutes of the four hundred ninety-second and four hundred ninety-third regular meetings of the Council held respectively on the 10th and 24th days of July, 1939 were each read and were each approved as read.

The Treasurer's monthly report was read and ordered filed.

The Fire Chief's monthly report was read and ordered filed.

The Librarians semi-annual report was read and ordered filed.

Jarvis Thompson Jr., requested that the Council give consideration to the establishment of traffic signs and pedestrian lanes on all streets abutting schools located in the City.

It was moved by Kirkpatrick and seconded by Rudder that a committee be appointed to confer with the various School Boards in reference to protection of school children pedestrian traffic. Motion carried and so ordered. The Mayor appointed Kirkpatrick to be the Committee.

It was moved by Kirkpatrick and seconded by Rudder that not to exceed \$25.00 be appropriated for furniture and repairs for the library. Motion carried and so ordered.

It was moved by Roberts and seconded by Gillem that the following bills be approved and that the Recorder issue warrants covering the same.
