An Ordinance providing for the construction of concrete sidewalks on the south side of Main Street along the north side of Block 4 of and in Fairview Addition to the Town (now City) of Hillsboro, Oregon, and also on the east side of Eighth Street, in said City, beginning at the center of the west end of the alley running east and west through Block 5, Fairview Addition to said Town (now City) of Hillsboro, Oregon, on the east side of said Eighth Street, and extending thence south, parallel with the said east side of street, to a point 6 feet south of the north line of Base Line Street, thence turning east and continuing parallel to the north line of said Base Line Street 95 feet, more or less, to and connecting with the present concrete sidewalk at the southwest corner of the Sinclair property. Also beginning at the southwest corner of Lot. 8, Block 5, Fairview Addition to the Town (now City) of Hillsboro, Oregon, at the present concrete sidewalk, and extending thence east 50 feet to and connecting with present concrete sidewalk, requiring the owners of lots or tracts of land abutting upon said sidewalks to construct the same, at their own expense, within the time prescribed herein and in conformity with Ordinance No. 901 of said City of Hillsboro, and providing that if the owners fail to construct said sidewalk within said prescribed time the same shall be constructed by the City Engineer of said City, and at the expense of the lots or tracts of land abutting thereon, and declaring an emergency.

The City of Hillsboro does ordain as follows:

Section 1. That the following described sidewalks, in the City of Hillsboro, Oregon, be constructed within 30 days next from and after the passage of this ordinance, to wit. A concrete sidewalk on the south side of Main Street along the north side of Block 4 of and in Fairview Addition to the Town (now City) of Hillsboro, Oregon, and also a concrete sidewalk on the east side of Eighth Street, in said City, beginning at the center of the west end of the alley running east and west through Block 5, Fairview Addition to said Town (now City) of Hillsboro, Oregon, on the east side of said Eighth Street, and extending thence south, parallel with the said east side of street, to a point 6 feet south of the north line of Base Line Street, thence turning east and continuing parallel to the north line of said Base Line Street 95 feet, more or less, to and connecting with the present concrete sidewalk at the southwest corner of the Sinclair property; Also a concrete sidewalk beginning at the southwest corner of Lot 8, Block 5, Fairview Addition to the Town (now City) of Hillsboro, Oregon, at the present concrete sidewalk, and extending thence east 50 feet to and connecting with the present concrete sidewalk, by the owners of the lots, tracts or parcels of land abutting upon said sidewalks.

Section 2. That said sidewalks shall be constructed under the supervision and subject to the approval of the City Engineer of said City of Hillsboro, Oregon, five fest wide, of sand, gravel and cement, and in conformity with Ordinance No. 901 of said City, entitled "An Ordinance providing specifications for construction of concrete sidewalks in the City of Hillsboro, Oregon, repealing Ordinance No. 701 of said City, and declaring an emergency, approved April 23,1929.

Section 3. That the following named owners, or reputed owners, of the following described lots, tracts or parcels of land abutting upon said sidewalks, to wit:

Lot 3, of Block 4, Fairview Addition to the Town (now City) of Hillsboro, Oregon,

Lot 4 of Block 4, Fairview Addition to the Town (now City) of Hillsboro, Oregon,

Annie M. Imbrie, owner.

The west 80 feet of Lots 5 and 6, Block 4, Fairview Addition to the Town (now City) of Hillsboro, Oregon.

Annie M. Imbrie, owner:

The east 110 feet of Lots 5 and 6, Block 4, Fairview Addition to the Town

(now Chty) of Hillsboro, Oregon. Dr. E. H. Smith, owner

The west $\frac{1}{2}$ of Lots 1 and 2, Block 5, Fair view Addition to the Town (now City) of Hillsboro, Oregon.

Clara M. Cox, owner:

The west 50 feet of Lot 8, Block 5, Fairview Addition to the Town (now City) of Hillsboro, Oregon. Mrs. J. Jones, owner, contracted to Mrs ____ Tucker. be and they are hereby required to construct concrete sidewalks along and abutting upon their respective lots, tracts or parcels of land, and at their own expense, within thirty days next from and after the passage of this ordinance, such construction work to be done as prescribed in this ordinance and in conformity with said Ordinance No. 901.

Section 4. Inasmuch as it is necessary for the public convenience, health, peace and safety of the inhabitants of said City that said sidewalks be constructed without delay, an emergency is hereby declared to exist, and this ordinance shall take effect upon its approval.
