An Ofdinance providing for the construction of concrete sidewalks in the City of Hillsboro, Oregon, as follows: a concrete sidewalk in the City of Hillsboro. Oregon, as follows: a concrete sidewalk beginning at a point six feet east of the intersection of the west line of Eleventh Street with the south line of Main Street, in said City, and thence westerly along the south line of said Main Street 101 feet, more or less, to and connecting with the present concrete sidewalk: also a concrete sidewalk beginning at the northeast corner of Lot 1. Block E. Doughty's Subdivision, in Hillsboro, Oregon, thence westerly along the south line of Main Street 191 feet, more or less, to and connecting with the present concrete sidewalk at the northeast corner of Lot 3 in said Block E, Also a concrete sidewalk beginning at a point six feet west of the southeast corner of the intersection of Eleventh Street with Main Street, in Hillsboro, Oregon, thence easterly along the south line of said Main Street to and connecting with the present concrete sidewalk at the northwest corner of Lot 3, Block E. Doughty's subdivision, in said City, requiring the owners of lots or tracts of land abutting upon said sidewalks to construct the same, at their own expense, within the time prescribed herein and in conformity with Ordinance No. 901 of said City of Hillsboro. and providing that if the said owners fail to construct said sidewalks within said prescribed time the same shall be constructed by the City Engineer of said City, and at the expense of the lots or tracts of land abutting thereon, and declaring an emergency

The City of Hillsboro does ordain as follows:

Section 1. That the following described sidewalks, in the City of Hillsboro, Oregon, be constructed within 30 days from and after the passage of this ordinance, to-wit: A concrete sidewalk beginning at a point six feet east of the intersection of the west line of Eleventh Street with the south line of Main Street, in said City, and thence westerly along the south line of said Main Street 101 feet, more or less, to and connecting with the present concrete sidewalk; Also a concrete sidewalk beginning

at the northeast corner of Lot 1, Block E. Doughty's Subdivision, in Hillsboro, Oregon, thence westerly along the south line of Main Street 191 feet, more or less, to and connecting with the present concrete sidewalk at the northeast corner of Lot 3, in said Block E; Also a concrete sidewalk beginning at a point six feet west of the sout east corner of the intersection of Eleventh Street with Main Street, in Hillsboro, Oregon, thence easterly along the south line of said Main Street to and connecting with the present concrete sidewalk at the northwest corner of Lot 3, Block E, Doughty's Subdivision, in said City, by the owners of the lots, tracts or parcels of land abuttin upon said sidewalks.

Section 2. That said sidewalks shall be constructed under the supervision and subject to the approval of the City Engineer of said City of Hillsboro, Oregon, five feet wide, of sand, gravel and cement, and in conformity with Ordinance No. 901 of said City, entitled "An Ordinance providing specifications for construction of concrete sidewalks in the City of Hillsboro, Oregon, repealing Ordinance No. 701 of said City, and declaring an emergency, "approved April 23,1929

Section 3. That the following named owners, or reputed owners, of the following

described lots, tracts or parcels of land, to wit:

Beginning at the southwest corner of the intersection of Main Street with Eleventh Street, in Hillsboro, Oregon, thence south 166 feet to the northeast corner of Larsen's land, thence west 95 feet; thence north 166 feet, more or less, to the south line of Main Street, thence easterly to the place of beginning, containing a acre, more or less, John Johansen, owner

Lot 1, Block E, Doughty's Subdivision in the Town (now City) of Hillsboro

Minnie E. Gerrish, owner.

Lot 2, Block E. Doughty's Subdivision in the Town (now City) of Hillsboro

Oregon,

Lot 4, Block E. Doughty's Subdivision in the Town (now City) of Hillsboro,
Oregon,

George V. Doughty, owner-contracted to

Ray Darland be and they are required to construct concrete sidewalks along and abutting upon their respective lots, tracts or parcels of land, as above specified, and at their own expense, within thirty days next from and after the passage of this ordinance, such construction work to be done as prescribed in this ordinance and in conformity with said Ordinance No. 901.

Section 4 Inasmuch as it is necessary for the public convenience, health, peace and safety of the inhabitants of said City that said sidewalk be constructed without delay, an emergency is hereby declared to exist, and this ordinance shall take effect upon its approval.
