J ORDINANCE NO. 1572

AN ORDINANCE DECLERING AN ASSESSMENT UPON EACH LOT, TRACT OR PARCEL OF LAND ABUTTING UPON EAST MAPLE STREET BETWEEN THE EAST LINE OF SOUTH EIGHTH AVENUE AND THE WEST LINE OF SOUTH NINTH AVENUE IN THE CITY OF HILLSBORD, OREGON, WHICH IMPROVEMENT WAS AUTHORIZED BY ORDINANCE NO. 1542 OF THE CITY OF HILLSBORD, OF ITS PROPORTIONATE SHARE OF THE WHOLE COST AND EXPENSE OF IMPROVING SAID STREET; DIRECTING THAT SAID ASSESSED COST BE ENTERED IN THE LIEN DOCKET OF THE CITY; AND DECLARING AN EMERGENCY.

THE CITY OF HILLSBORO DIES ORDAIN AS FOLLOWS:

Section 1. That each lot, tract and parcel of land abutting upon or benefitted by the improvement of East Maple Street between the east line of South Eighth Avenue and the west line of South Ninth Avenue which improvement was authorized by Ordinance No. 1542 of the City of Hillsboro, be and the same hereby is assessed with its proportionate share of the whole cost and expense of improving said street, which said improvement was provided for and prescribed in said Ordinance No. 1542 of said City, entitled

"AN ORDINANCE PROVIDING FOR THE IMPROVEMENT OF EAST MAPLE STREET BETWEEN THE EAST LINE OF SOUTH EIGHTH AVENUE AND THE WEST LINE OF SOUTH NINTH AVENUE; DEFINING THE CHARACTER OF THE IMPROVEMENT AND THE MANNER OF PERFORMING THE SAME; AND DECLARING AN EMERGENCY"

introduced and passed on the high day of August, 1953, and as apportioned to the property of the City of Hillsboro, as follows, to-wit:

Ext. No. 230 E. Maple St., 8th to 9th

Total assessment on 32.0 foot width of street

City of Hillsboro, a municipal Corp. \$3,886.13

All of Lots 10, 11 and 12 of Block 2, South Coast Addition to Hillsboro, Oregon as shown on the duly recorded map and plat thereof.

The South 53.0 feet of the North 103.0 feet of Lots 7 and 8, Block 2, South Coast Addition to Hillsboro, Oregon, as shown on the duly recorded map and plat thereof.

The North 50.0 feet of Lots 7 and 8, Rlock 2, South Coast Addition to Hillsboro, Oregon, as shown on the duly recorded map and plat thereof.

Total Project Cost \$6.080.98

Section 2. The Recorder of the City of Hillsboro, be and he hereby is directed to enter a statement of said assessed costs in the Docket of City Liens of said City, as provided by the Amended Charter thereof.

Section 3. Inasmuch as the above described street improvement is necessary to the peace, health and safety of the people of the City of Hillsboro that the cost thereof be docketed as soon as possible, an emergency is hereby declared to exist and this ordinance shall take effect and be in force upon its passage by the Council and approval by the Mayor.
