JORDINANCE NO. 1645

AN ORDINANCE DECLARING AN ASSESSMENT UPON EACH LOT, TRACT OR PARCEL OF LAND ABUTTING UPON EAST WALNUT STREET BETWEEN THE WEST LINE OF SOUTH EIGHTH AVENUE AND THE EAST LINE OF SOUTH NINTH AVENUE IN THE CITY OF HILLSBORO, OF ITS PROPORTIONATE SHARE OF THE WHOLE COST AND EXPENSE OF THE IMPROVEMENT OF SAID STREET, DIRECTING THAT SAID ASSESSED COST BE ENTERED IN THE DOCKET OF CITY LIENS OF SAID CITY, AND DECLARING AN EMERGENCY.

THE CITY OF HILLSBORO DOES ORDAIN AS FOLLOWS:

Section 1. That each lot, tract or parcel of land abutting upon or benefitted by the improvement of East Walnut Street between the west line of South Eighth Avenue and the east line of South Ninth Avenue, in the City of Hillsboro, Oregon, be and the same hereby is assessed with its proportionate share of the whole cost and expense of improving said street, which said improvement was provided for and prescribed in Ordinance No. 1597 of said City entitled
