V ORDINANCE NO. 1653

AN ORDINANCE PROVIDING FOR THE CONSTRUCTION OF A CONCRETE SIDEWALK IN FRONT OF THE PROPERTIES HEREINAFTER DESCRIBED IN THE CITY OF HILLSBORO; REQUIRING THE OWNERS OF THE PROPERTY ABUTTING THEREON TO CONSTRUCT THE SAME: DESIGNATING THE TYPE OF CONSTRUCTION, AUTHORIZING THE CITY TO CONSTRUCT THE SAME AND CHARGE THE COST AGAINST THE ABUTTING PROPERTY UPON FAILURE OF THE OWNER TO CONSTRUCT.

THE CITY OF HILLSBORD DOES ORDAIN AS FOLLOWS:

Section 1. The following described sidewalks in the City of Hillsbore, Oregon be and the same hereby are ordered to be constructed by the owners of the lots or parcels of land abutting thereon within thirty days after the passage of this ordinance, to-wit: On the East side of North Seventh Avenue between Main Street and Lincoln Street, to-wit:

Beginning at a point on the north line of E. Main Street, 1.0 feet west of the intersection with the east line of North Seventh Avenue in the City of Hillsboro, Oregon, and running thence north parallel to and 1.0 feet distant from the east line of said North Seventh Avenue a distance of 133.6 feet to the end of an existing sidewalk; thence west 5.0 feet to a point; thence north to the said north line of E. Main Street a distance of 133.6 feet; thence southeasterly 5.0 feet to the place of beginning.

On the east side of North Seventh Avenue between Main Street and Lincoln Street, to-wit: Beginning at a point 1.0 feet north and 1.0 feet west of the northwest corner of Block 2, Boscow's Addition to Hillsboro, Oregon, and running thence south parallel to 1.0 feet distant from the west line of said Block 2 a distance of 81.4 feet the end of an existing concrete sidewalk; thence West 5.0 feet to a point; thence north 81.4 feet to a point; thence east 5.0 feet to the place of beginning.

On the south side of East Lincoln Street between Seventh and Eighth, to wit: Beginning at a point 1.0 feet north and 1.0 feet west of the intersection of the east line of S. Seventh Avenue with the south line of E. Lincoln Street in the City of Hillsboro, Oregon, and running thence east parallel to and 1.0 feet distant from the said south line of E. Lincoln St. a distance of 382.5 feet to a point 1.0 feet north and 1.0 feet east of the point of intersection of the west line of N. 8th Avenue with the said south line of E. Lincoln St.; thence north 5.0 feet to a point; thence west 382.5 feet to a point; thence south 5.0 feet to the place of beginning.

On the west side of North Eighth Avenue between Main Street and Linceln Street, to-wit: Beginning at a point 1.0 feet north and 1.0 feet east of the northeast corner of Boscow's Second Addition to Hillsboro, Oregon, and run thence south parallel to and 1.0 feet distant from the east line of said Boscow's Addition a distance of 466.0 feet to a concrete sidewalk 1.0 feet south and 1.0 feet east of the southeast corner of said Boscow's Addition; thence east 5.0 feet to a point; thence north 466.0 feet to a point; thence west 5.0 feet to the place of beginning.

On the east side of North Eighth Avenue between Main and Lincoln Streets, to-wit: Beginning at the end of an existing concrete sidewalk 1.0 feet west of the northwest corner of Lot 2, Block 1, Lincoln Addition to Hillsboro, Oregon, and running thence south parallel to and 1.0 feet distant from the east line of M. Eighth Avenue 313.8 feet to a concrete sidewalk 1.0 feet west and 1.0 feet south of the intersection of the east line of N. Eighth Ave. with the north line of E. Main St.; thence west 5.0 feet to a point; thence north 313.8 feet to a point; thence east 5.0 feet to the place of beginning.

On the east side of North Ninth Avenue between Maim and Lincoln Sts., to-wit: Beginning at a point 1.0 feet west and 1.0 feet north of the northwest corner of Block 2, Lincoln Addition to Hillsboro, Oregon, and run thence south parallel to and 1.0 feet distant from the west line of said Block 2 a distance of 240.7 feet to a concrete sidewalk; thence west 5.0 feet to a point; thence north 240.7 feet to a point; thence east 5.0 feet to the place of beginning.

On the east side of North 9th Avenue between Main and Lincoln Sts., to-wit: Beginning at a concrete sidewalk 1.0 feet south and 1.0 feet west of the intersection of the north line of East Main Street with the east line of N. Ninth Ave. in the City of Hillsboro, Oregon, and run thence north parallel to and 1.0 feet distant from the said east line of N. Ninth Ave. a distance of 145.3 feet to the end of a concrete sidewalk; thence west 5.0 feet to a point; thence south 145.3 feet to a point; thence east 5.0 feet to the place of beginning.

Section 2. That the sidewalks hereinabove ordered to be constructed shall be constructed under the supervision and control and subject to the approval of the City Engineer of the City of Hillsboro, and shall be 5 feet in width and 4 inches thick and constructed of sand, gravel and cement and in conformity with the provisions of Ordinance No. 1560 of the City of Hillsboro, being an ordinance entitled:

"AN ORDINANCE PROVIDING FOR SPECIFICATIONS FOR CONSTRUCTION AND REPAIR OF CONCRETE SIDEWALKS, DRIVEWAYS AND CURBS IN THE CITY OF HILLSBORO, OREGON "

which ordinance was passed and approved on the 7th day of September, 1954.

Section 3. That the owners or reputed owners of the lands abutting upon the sidewalks above described who are required to construct the said sidewalks together with the lots, blocks, parcels of land or portions thereof abutting upon the sidewalks are as follows, to-wit:
