# Transportation: The Next Chapter

Here's the next chapter in Milwaukie's Transportation System Plan story. When we left off, back in May, citizen groups had identified their priorities of various ways of getting around Milwaukie.

Using these priorities, population growth projections, pavement surveys and computer modeling, our transportation planners have come up with a list of Milwaukie's transportation needs in the next 20 years. A few of the major findings are listed below.

- Approximately \$4 million beyond the existing street maintenance budget will be needed to take care of pavement problems in the next 10 years.
- Pedestrian improvements are needed near elementary schools and other high-use walking areas.
   Gaps in the sidewalk network need to be filled.
- Bicycle improvements are needed along corridors leading to schools, parks, commuter routes, trails and transit locations. Gaps in the bike network need to be filled.
- Public transit should serve all neighborhoods and popular destinations, and provide service to special needs populations.
- By the year 2015, Hwy. 224 and McLoughlin Blvd. will be operating over-capacity through Milwaukie. This will create problems on 17th and 32nd Avenues and Johnson Creek Blvd. It will cause travel delays for freight trucks.
- An improved connection from Hwy. 224 to McLoughlin Blvd. is needed in the Oatfield Road area.

The final chapter, a plan for addressing these needs, will come later this summer. You'll have a chance to comment on the whole plan in public meetings this Fall. Stay tuned!

## **Light Rail Progresses**

Milwaukie's light rail working group, a citizen committee, has made its recommendations on potential light rail alignments through Milwaukie.

The working group favors the route from McLoughlin to 21st to Monroe St. This was chosen to serve the city in its downtown core. From Monroe, itsupports the line along Railroad Avenue to connect with Clackamas Town Center and beyond.

This recommendation is advisory. Metro makes the final decision, but the

City Council will have input into the process. This is expected to occur in the next few months. Once an alignment is selected, work will begin on a Draft Environmental Impact Statement. For more specific information on the schedule, call Nancy Waddell in Community Development at 786-7658.

## Help Keep Right-of-Way Clear



Most homes in Milwaukie have some cityowned right-of-way immediately adjacent to the street. This is the area where the city can put in traffic control signs, street lights, etc. Our street crews and public safety staff would like to remind Milwaukie citizens that it is illegal to put personal signs in this area. This includes Garage Sale or Real Estate signs. The reason is to maintain sight lines and visibility for drivers. If you put a sign in this area, and an accident occurs, you may be held liable. If it is necessary to put a sign in the right-of-way, you can obtain a permit from the city. Call 786-7600 for more information. Thanks for your cooperation in this matter.

# **Plastic Bottles** Recyclable at Curb!

Milwaukie garbage customers can now recycle most plastic bottles at the curb. Haulers will now collect plastic bottles (with necks smaller than the base) along with your other recyclables. The reason we can only collect plastic bottles is because those are the only plastics for which there is a long term and steady market.

All customers should have received a flyer with more specific information about the program. If you have questions, please call JoAnn Herrigel, the City's Solid Waste and Recycling Coordinator, at 768-7508.

If you're wondering, plastic tubs, bags and some other packages can still be recycled through the local depot programs listed to the right of this article. Each accepts different types of materials, so check with them before you bring in your plastics.
