On Tuesday, February 6, Fire Chief Dan Olsen reported the National Weather Service flood warning for the Willamette River. The city engineering team, featuring Greg Drechsler, Paul Roeger and Matt Freid, engineering team, featuring flood levels and elevations with our Geographic went to work plotting flood levels and elevations with our Geographic Information System computer. The GIS maps were ready for the Management Team's meeting on Wednesday morning. Armed with the GIS maps, Public Works crews began notifying businesses along Johnson Creek, and Island Station residents west of SE 19th Street, that they may be flooded. When the National Weather 19th Street, that they may be flood levels, the city prepared new maps and Service projected higher flood levels, the city prepared new maps and notified businesses on Main north of Scott Street that they may be notified businesses on Main north of Scott Street that they may be affected also. Sand and sand bags were provided at strategic locations.

Fire and Police officers continued to respond to routine calls, while adding special response to flood areas. Public Works ensured that the water and sewer systems remained operational, that flooded roads were closed, debris removed from bridges and primary travel routes remained open. When it appeared that McLoughlin Blvd. might have to be closed, open. When it appeared that McLoughlin Blvd. might have to be closed, alternative routes were planned, with detour signs distributed along the routes. Fortunately, we only had to close one lane.

Once the river crested, we initiated a recovery plan for sand bag pickup and flood debris removal. I am proud of our city staff's response to this emergency. They worked round the clock, from Wednesday through Saturday, to ensure that Milwaukie was as prepared as it could be for the Flood of 96. I thought you should know about their good works.

Wet, Wild and Windy Weather

Wind, rain, snow, ice and flood: we've seen it all this winter. While damage from these events was fairly localized within Milwaukie, several homes, apartments and businesses suffered losses due to this winter's wild weather. Through the course of it all most Milwaukians were fortunate in that we had very few serious injuries and no deaths due to storms.

This winter's weather served as a good reminder of the importance of being prepared. In a serious emergency, city and utility crews may not be able to restore services for 72 hours, and possibly longer.

For this reason, it is important for you and your family to be prepared. Make a home emergency kit to ensure you can make it through that first 72 hours. The Red Cross publishes a free booklet, "Before Disaster Strikes," which includes supply lists and information on family disaster preparedness. It is available for pick up in the lobby of the Public Safety Building, 3200 SE Harrison.



Board & Commission Review Project

Last summer, the city council began a review of its boards and commissions. The task was undertaken to make sure these citizen advisory groups, individually and as a whole, are functioning in alignment with the city's vision, mission and council goals. There had not been a comprehensive review in over 15 years.

The objectives of the review are to:

- ✓ Link Board and Commission work plans to the Community Vision and 1995 - 1997 Council Goals.
- Link Boards and Commissions to the Neighborhood Services program.
- Create consistencies in operations between and amongst the various boards.

The Council is in the process of meeting with each Board and Commission to review their findings and seek input. There will be a public hearing at a Spring Council meeting to consider input and approve final plans. For more information, please call 786-7502.

CITY EMERGENCY PRIORITIES

During an emergency such as wind or flood the city prioritizes its efforts according to need. During the event, the emphasis is on protecting human life. For the flood, advance notification of potentially affected property owners was a chief concern. Afterwards, returning public services, and assisting in the clean-up of flooded areas were the primary focus. Below is a list of city emergency priorities.

City Priorities During Emergencies

- Resolve life-threatening situations, such as medical emergencies
- Resolve potentially life-threatening situations, including securing downed wires or marking traffic control at intersections with power outages
- Keep primary travel routes open for emergency vehicles

City Priorities After Emergencies

- Maintain access to primary travel routes
- Restore water and sewer services to normal*
- Restore access to other streets by classification
- * Utilities such as electricity, gas and phone are privately-owned and thus not within the scope of city services.

Milwaukie Riverfront Planning Committee Selected

City residents have joined the City's efforts to create a Master Plan for the Milwaukie Riverfront for the next twenty years. Following a formal application process, members of the Milwaukie Riverfront Planning Committee were appointed by the City Council on February 6th. Councilors expressed their appreciation for the tremendous amount of interest from the public in serving on this committee.

Members of the Committee represent a broad spectrum of the community, including nearby residents and property owners, business interests, neighborhood associations, boaters and environmental interests. The Planning Committee will work with a Steering Committee composed of the City Council, members of the Planning Commission and a representative of the City's Parks & Recreation Commission.


The Riverfront Planning Committee will be the primary avenue for citizen input through the process of creating a Master Plan, and they will seek ways to involve the wider public as well. The Committee's meertings are open to the public. The first meeting will be Thursday, March 14 at 6:00 pm at the Milwaukie Public Safety Building.


Moving into Draft Environment Impact Study

In January, the Milwaukie City Council reviewed and concurred unanimously with Metro's Light Rail Design Option Narrowing Report. As a result, two possible alignments through Milwaukie will be studied in the Draft Environmental Impact Statement (DEIS). The DEIS will detail impacts of the alignments and identify possible measures to improve the light rail design through Milwaukie. It will take approximately a year to complete this detailed process.
