
A RESOLUTION ADOPTING A REVISED SOLID WASTE RATE SCHEDULE FOR WEST LINN DISPOSAL CO. AND KELLER DROP BOX, INC.

WHEREAS, Ordinance No. \_\_\_\_\_ establishes that solid waste rates shall be set by Council Resolution, and

WHEREAS, West Linn Disposal Co. and Keller Drop Box, Inc. have applied to the City for an increase in solid waste collection rates and have submitted supporting information and documentation to the satisfaction of the City to justify the rate increase request.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF WEST LINN that the request of West Linn Disposal Co. and Keller Drop Box, Inc. is approved and the City adopts this Resolution with the attached Exhibit "A" for the rates of West Linn Disposal Co. and Exhibit "B" for the rates of Keller Drop Box, Inc., said schedules being incorporated by reference in this Resolution. The rates approved shall be maximum rates and shall be effective October 1, 1989.



Exhibit "A" - Rate Schedule  
To Resolution Approving Rates

WEST LINN DISPOSAL CO.

Effective Date: October 1, 1989

I. 32 Gallon Cans:

A. RESIDENTIAL RATES

The monthly rate per 32 gallon can per month shall be:

One Collection Per Week	One (1) Can	\$11.30 per month
One Collection Per Week	Two (2) Cans	\$22.60 per month
One Collection Per Week	Three (3) Cans	\$33.90 per month
One Collection Per Week	Four (4) Cans	\$45.20 per month
One Collection Per Week	Five (5) Cans	\$56.50 per month
One Collection Per Month	Per Can	7.40 per month

The monthly rate for a 15-20 gallon can, one collection per week, shall be:

One Collection Per Week	One (1) Can	\$9.65 per month
-------------------------	-------------	------------------

B. MOBILE COURTS

Where the owner of the Court accepts and pays the bill for the entire court and the cans are set on the curb, the Rate for a 32 gallon can/one stop per week service shall be \$9.60 per can.

C. COMMERCIAL RATES

The Commercial Rates shall apply to all customers other than Residential units and Mobile Courts.

One Collection Per Week	One (1) Can	\$12.30 per month
One Collection Per Week	Two (2) Cans	\$24.60 per month
One Collection Per Week	Three (3) Cans	\$36.90 per month
One Collection Per Week	Four (4) Cans	\$49.20 per month
One Collection Per Week	Five (5) Cans	\$61.50 per month

D. EXTRA BAGS OR BRUSH PILES

Extra Bags (Not over 32 gallons, 60 pounds)	\$2.60 per bag

Brush Piles (Not over 3 feet high, 4 feet long)	\$5.70 per pile

II. Containers:

A. LOOSE MATERIAL	<u>First Stop Per Week- Monthly Rate</u>
<u>Size</u>	
1 cubic yard First Container	\$47.65
1-1/3 cubic yard First Container	\$63.80
1-1/2 cubic yard First Container	\$88.40
2 cubic yards First Container	\$110.75

Each additional container shall be at 90% of the first container rate, and each additional stop shall be at 90% of the first stop per week rate.

B. COMPACTED MATERIAL

Compacted Containers that can be dumped into a collection truck shall be charged 2.2 times the loose material rate for containers. Compactors shall be compatible with the equipment of the Collector.

III. Any Other Type of Service:

If, due to changes in technology or needs of residents and business people of West Linn, additional or other type services are needed, the charge for the service shall not be discriminatory, shall be reasonable, and shall be commensurate with the Rates above, and shall not exceed the Rates most generally applicable in the Portland Metropolitan area.

EXHIBIT "B" - RATE SCHEDULE  
TO RESOLUTION APPROVING RATES

KELLER DROP BOX, INC.

Effective Date: October 1, 1989

I. Drop Box Rates (Loose) (Plus Disposal)

10-20 cubic yard	\$62.90 plus disposal
30 cubic yard	\$82.50 plus disposal
40 cubic yard	\$95.25 plus disposal

II. Drop Box Rates (Compacted) (Plus Disposal)

2.2 times Loose Rate, Plus Disposal

III. Miscellaneous Charges

- A. Drop Fee for Occasional Customer  
for the First Box at a given location within  
a 30-day period, or the Repeat Customer that  
requires service at different locations \$17.50
- B. Drop Box Rental per day after 48 hours  
on site \$5.25
