

CITY OF WEST LINN  
RESOLUTION NO. 997

A RESOLUTION REPEALING AND REPLACING RESOLUTION  
NO. 995, ADOPTED APRIL 20, 1977.

BE IT RESOLVED BY THE COMMON COUNCIL of the  
City of West Linn, Clackamas County, Oregon, as follows:

SECTION 1. That there shall be held in the City  
of West Linn, Clackamas County, Oregon on May 10, 1977, a  
Special Election for the purpose of submitting to the legal  
voters of said City at said Special Election, for their approval  
or rejection, a measure to allow a tax levy in the amount of  
\$528,685.00 in excess of the constitutional six percent limita-  
tion set forth in Article XI, Section 11 of the Constitution of  
the State of Oregon. Said amount is required, and is to be used  
to meet the costs of operation of departments and functions of  
the City of West Linn, Oregon, for the Fiscal Year 1977-78.

If this measure is approved, the operating budget  
to be financed by local taxes for the tax year will be \$81,300.00  
more than the operating budget financed by local taxes for the  
preceding year.

SECTION 2. The recorder of the City of West Linn,  
Oregon, is hereby authorized and directed to publish notice  
of said Special Election in a newspaper of general circulation  
in the City. This notice will be published twice with the first  
publication at least ten days prior to the date of said Special  
Election to be held on May 10, 1977. Said notice shall state  
the date upon which said election shall be held, and shall design-  
ate the purpose of said election, the polling places thereof,  
and the hours said election shall be held.

The recorder of the City of West Linn, Oregon is hereby  
ordered and empowered to make all further arrangements and secure  
the necessary supplies for said election.

BE IT FURTHER RESOLVED, there shall be five polling  
places for said election and such polling places are as follows:

PRECINCT NOS. 130 and 131 - Willamette School  
PRECINCT NOS. 132 and 139 - Sunset School  
PRECINCT NOS. 133 and 134 - West Linn First Baptist Church  
PRECINCT NOS. 135 and 138 - Emmanuel Presbyterian Church  
PRECINCT NOS. 136 and 137 - Cedaroak Park School

That the judges and clerks for said election shall be the regularly and duly appointed election boards, appointed by the City Council of West Linn.

The election wards and precincts for said election shall be and constitute all the territory included within the corporate limits of the City of West Linn, Oregon and the polls shall be open from 8:00 a.m. to 8:00 p.m. on May 10, 1977.

BE IT FURTHER RESOLVED, the ballot title under which said Tax Levy shall appear on the ballot shall be as follows:

"PROPOSED BY THE CITY COUNCIL OF WEST LINN, OREGON

A measure allowing a levy of \$528,685.00 in excess of the constitutional six percent limitation, which amount is required, and will be used, to meet the cost of operation of the departments and functions of the City of West Linn, Oregon for the Fiscal Year 1977-78.

If this measure is approved, the operating budget to be financed by local taxes for the tax year 1977-78 will be \$81,300.00 more than the operating budget financed by local taxes for the preceding year.
