The first Business Meeting of the newly Incorporated Town of Milwaukie was called to order by Mayor Wm. Shindler. The officers were all present:

Counsilmen:

Owen J. Roberts, Casper Kerr, Gotleib Keller, James Reed

Recorder: F.H. Lechler Treasurer: Chas. M^CCan Marshall: Jessie Keck

The Mayor states the first thing in order was to elect a President of the Counsil = which honor was accorded Mr. Roberts.

The Mayor then appointed a Finance Committee = Mr. Kerr, Reid, & Roberts

Fire & Water Committee = Mr. Roberts, Keller, & Kerr

Street & Public Property = Mr. Reid, Keller, & Roberts

Health & Police = Mr. Keller, Kerr, & Reid

The Mayor stated it was necessary to have money = as we were at present without funds to run our City Government but that in a short time we would have money to work on.

The Mayor stated that we would soon Tax the Powder Houses = but before doing so it would be necessary to have legal advice.

The Mayor said we would soon begin to Tax all peddlers Grocery Wagons, Hotel Keepers, & Etc. & those that would come under that trade.

Counsilman Kerr said that the Marshall should start to collect Poll Tax but no action was taken.

A subscription was then raised among the officers for current expenses those contributing were M^cCan \$1.00, Keck \$1.00, Keller \$1.00, Lechler \$1.00, Mayor Shindler \$1.00, Reid \$1.00, Roberts \$1.00, Kerr \$1.00.

Mr. Keller said we would all advance \$1.00 each and after we had our government in running order it could be refunded.

Mr. Kerr offered to let us have the hall over the blacksmith shop free for our future meetings and would clean & furnish it.

Mayor Shindler said we could afford to rent Woodmans Hall & so decided to do so.

The Mayor ordered Poll Tax receipt Books printed & requests recorder to look after same.

Mr. Roberts moved that we get a Seal = which was seconded by Kerr. The question was thoughtout & carried. Keller & Kerr was appointed to look after same.

The Mayor said we must employ a legal adviser. A good many prominent Lawyers was mentioned & debated by Keller & Kerr but none was chosen at this meeting.

No further business appearing, the meeting then ajourned until Thursday June 11 1903.
