Jerry Herrmann, resident of Oregon City, hoped that the Commission would allow all of the City Committees to give a brief presentation at the Commission Retreat.

Mike Jarrett, representing the Friends of the Ermatinger House, explained a few months ago the organization was formed to help with the continued preservation, education, and interpretation of this unique architectural and historical asset. He extended an invitation to meet and collaborate with the Commission in order to develop a program for the house.

William Gifford, resident of Oregon City, was asked to relay a message from Larry Hanlon and Larry Long extending congratulations and a welcome to the new Commission.

Doug Neeley, resident of Oregon City, congratulated the new Commission on their appointments. He reflected on Commissioners Pauli and Smith's tenure and the good work they had done on the Commission so far.

Bob Mahoney, resident of Oregon City, said they all had to come together to make things work. He wanted to maintain the integrity of the past Commissions and keep Oregon City as Oregon City.
