### A RESOLUTION CONSENTING TO VACATION OF LIBRARY COURT IN THE CITY OF OREGON CITY

WHEREAS, Library Court is a county road within the City of Oregon City that is designated a local street in the City of Oregon City's Transportation System Plan; and

**WHEREAS**, Clackamas County, as the owners of 100 percent of the abutting property, have petitioned Clackamas County to vacate Library Court (the Vacation Petition); and

WHEREAS, Clackamas County, in accordance with ORS 368.351, has granted the Vacation Petition and Clackamas County has ordered the vacation of Library Court, as shown in Clackamas County Order No. 2006-241, attached as Exhibit "A" to this resolution; and

**WHEREAS**, the City Commission of Oregon City understands that all City public utility lines within or next to Library Court are in existing Public Utility Easements and additional public utilities in other locations will require new easements from the county; and

**WHEREAS**, the City Commission of Oregon City, being fully informed of the purposes of the vacation and the objections thereto.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission that the City of Oregon City, Oregon hereby consents to the vacation of Library Court as ordered by Clackamas County in Clackamas County Order No. 2006-241.

All that portion of Library Court, County Road Number 2709, that lies west of the westerly right-of-way line of Kaen Road as described on sheet 1 of 4 in the Plat of Red Soils, Plat Number 2980, Survey Records of Clackamas County.

The Board has received: (1) a petition signed by 100 percent of the abutting owners, and (2) a written report from Cam Gilmour, the County Road Official, who finds this vacation to be in the public interest, has read the petition and report from the County Road Official, and has determined the vacation of the above described portion of roadway to be in the public interest.

This is an intergovernmental vacation and shall not become effective until the City of Oregon City by Resolution or Order concurs with the County governing body in the vacation procedures.

Clackamas County Planning, Engineering, Transportation Maintenance Division as well as all local utilities have been contacted and do not have any objections to the proposed road vacation as long as utility easements are retained.
