



Moving Forward Milwaukie on the move

After the public weighed in on draft code amendments aiming to remove barriers and create incentives for good development in Downtown Milwaukie at an Open House on Oct. 29th, the Moving Forward Milwaukie Project team is preparing the plan and code amendment package for adoption.

The first of three Public Hearings is tentatively set for Nov. 25th, at 6:30 p.m. at City Hall, and will

focus on focusing on development and use standards. Subsequent hearings are tentatively scheduled for Dec. 9th (focused on design Standards) and Jan. 13th, 2015 (focused on downtown design review).

The amendments are a product of the Moving Forward Milwaukie (MFM) project, and address things such as how buildings look, what can happen in them, and how new

development is reviewed, all of which when taken together aim to encourage the kind of development projects the community supports.

The Downtown Plan and Code Amendments are the first phase of the MFM project. Phase 2, focusing on central Milwaukie plan and code amendments is underway, and Phase 3, Neigh-

TriMet shows bus proposal

TriMet is proposing bus service changes that would take effect when Portland-Milwaukie Light Rail - MAX Orange Line - opens in September 2015. The proposal has been updated throughout the year as TriMet gathered public feedback. Milwaukie residents are invited to view and comment on the final proposal at www.trimet.org/buschanges, where each line modification is broken out individually with details and map information, or to attend the open house on Thurs., Nov. 6, 6-7:30 p.m. at Milwaukie High School.

On the whole, the proposed changes alter bus service to complement the new MAX Orange Line, improving system-wide connectivity, service frequency and efficiency. Although detailed schedules will not be available until closer to the 2015 service change, the changes may alter current travel times, and riders are encouraged to review and comment on the proposal.

We have all seen the incredible work that's taking place at Milwaukie Riverfront Park these past several months, and soon we'll see substantial improvements at the Kellogg Treatment Plant that sits to the south.

Approximately 180 trees and literally thousands of new shrubs will be planted in and around the plant in the coming months, and we can thank the hard work of our citizen-based Kellogg Good Neighbor Committee and the City's partnership with the plant's operator, Clackamas County Water Environmental Services (WES).

More than 30 residents turned out at an Open House this past June to review and provide input on the landscaping plan, which calls for species of trees and shrubs that will provide visual screening of the treatment plant and reduce some of its odors, are unique to the area, and will thrive in that particular environment. To make way for the new plantings, approximately 60 trees from throughout the entire Kellogg site, the vast majority of which are in poor health or dying, will be removed, and many of the shrubs that line the McLoughlin Boulevard-facing fence will be pulled. While the new plants take root and grow, a fabric lining will be installed on the fence to block the newly exposed views of the treatment plant.

The Good Neighbor Committee was created in 2012 as a result of the City's agreement with WES and is backed by a fund that's fed every month with a dollar from every utility bill in Milwaukie. This landscaping effort is funded with those dollars, and the first major disbursement from the fund in 2013 contributed the \$1 million match the City needed for the grant money that's behind the work we're seeing at Riverfront Park.

We're creating a region-wide attraction with our Park, and thanks to the ongoing work of the Good Neighbor Committee and our agreement with WES, we'll see continual improvements along our City's waterfront.

Milwaukie riders and businesses, the proposal includes more service and connections near Milwaukie's Light Rail Station where new bus stops will be added at the intersection of Washington Street and 21st Avenue. These changes will increase bus activity in this part of Downtown.

County offers energy - assistance program

This low income energy assistance program is a federally funded program designed to assist low income people with their utility bills. The energy assistance program is offered through Clackamas County Social Services. The Milwaukie Center is able to offer an early sign-up for seniors and persons with disabilities during mid-October and November.

LIEAP eligibility is determined using gross income (before taxes); the income guidelines are: One person household - under \$1,792.14 per month, two person household - under \$2,343.56 monthly. Households must meet income eligibility and be residents of North Clackamas Parks District. Individuals must have their Social Security annual statement and social security card, pension letter and other proof of income in order to apply. A copy of the above documentation including your electric or any other utility bill and photo identification are required.

FREE Leaf Drop dates start up in November

Milwaukie residents can help prevent the clogging of storm drains, which helps prevent local flooding and preserves water quality, by dumping off all of their leaves at the City's Johnson Creek Facility, located at 6101 SE JCB, on:

November, 15th, 7 a.m. to 2 p.m.

November 22nd, 22nd, 7 a.m. to 2 p.m.

Dec. 6th, 13th, 7 a.m. to 2 p.m.

A drop box will be available for paper-bagged leaves, and another for plastic-bagged or loose leaves. Residents must bring a copy of a City Utility Bill to participate. And though, not required, citizens are encouraged to bring canned food that staff will take to a local food bank.

Phase II Milwaukie Riverfront Park Construction

Milwaukie Riverfront Park's expansive lawn area was hydroseeded in mid-October and grass is already taking root, and the two new parking areas, complete with stormwater treatment facilities and pervious pavers, are constructed. The new floating dock and boat ramp are close to completion, the parking areas will be paved this month, and the new bathroom facility will be constructed. The Park's new access point is also to be constructed. The work will be buttoned-up in time for the Winter Solstice event set for Sat., Dec. 20th.

Milwaukians in Salem

Inside the Senate and House Chambers of our State's Capitol in Salem you will find 158 names painted on the gallery's walls. As author Phillip Cogswell, Jr. author of Capitol Names, put it, "These individuals, with their widely different backgrounds, represent the variety of threads that were woven together to make Oregon what it is. In many cases, had these people been different than they were, had they acted differently, Oregon's history would be different and, in a sense, Oregon today would be different."

Among these names are a number of Milwaukians who aided Oregon's creation and shaped its history.

Lot Whitcomb, founded Milwaukie in 1848 and developed river transportation on Willamette and Columbia Rivers. Whitcomb built the Lot Whitcomb, the first steamboat constructed on the Willamette River.

Seth Lewelling, a pioneer orchardist in the 1850's who developed several varieties of cherries, including the Bing, Black Republican, and the Lincoln. He was also active in the formation of the Republican Party in Oregon.

John Ainsworth, foremost figure in the development of river transportation on the Willamette and Columbia Rivers. He was captain of the Lot Whitcomb steamboat and helped organize the Oregon Steam Navigation Company in 1860.

The City Code Corner

Milwaukie's Municipal Code has laws in place so one property does not create a nuisance for another property. Noise, odor, and many other types of nuisances occur and our Department is called to help.

Sometimes we do receive calls that are neighbor-to-neighbor issues, but we can't help because we simply don't have the codes and laws in place. There is hope though.

Neighbor Law is a book that addresses some issues that just don't fit in the realm of code enforcement, such as tree limbs that cross property lines. This book is available at our Ledding Library. We also encourage you to contact Clackamas County Dispute Resolution 503-655-8850 to see if you can work the issue out with your neighbor.

Be Seen ... Be Safe

The expiration of daylight-savings time at 2 a.m. on Nov. 2nd, marks a perfect time to stop a minute and consider how visible you and your family are when biking and walking. This is the time of year when people need to "dress" to be seen, and drivers should be especially alert to seeing everyone.

Here are some tips to brighten your night:

1. **Be reflective.** Drivers can see bicyclists and pedestrians from farther away when they shine. For example, you are first visible to a driver from 500 feet away when you are wearing reflective clothing. Compare this to just 55 feet away when wearing dark colors.
2. **Add more shine.** Wear shoes, backpacks, jackets and other clothing with reflective materials. Do it yourself by adding inexpensive reflective tape strips to your shoes, backpack, purse, bike wheel spokes, jacket sleeves, pant legs - really, anywhere and everywhere!
3. **Use lights freely.** Headlights, armbands with lights, leg bands with blinking lights, small blinking lights on your coat, purse or backpack ... All of these items can help you be seen while biking or walking.

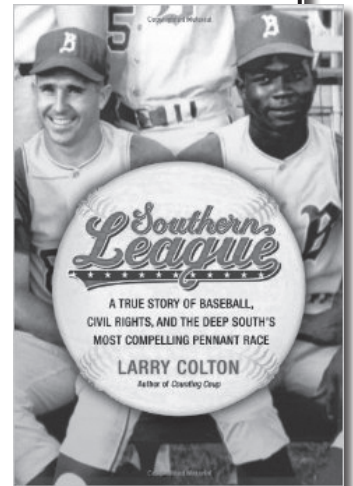

We are about to discover the result of Metro measure#26-160, which if approved will extend a 12-year-old law that prohibits Metro-mandated density increases in single-family neighborhoods.

Measure 26-160 asks voters at the Nov. 4, 2014 election whether to keep an existing provision in the Metro Charter that prohibits Metro from requiring local cities and counties to increase the number of homes in existing single-family neighborhoods.

Voters approved the provision in 2002. It requires the Metro Council to refer the provision to voters again this November.

If a majority of voters in the Nov. 4 election vote yes on Measure 26-160, the existing provision will remain in effect until the question is again put to the voters in 2030. If a majority of voters vote no on Measure 26-160, this provision will be repealed on June 30, 2015.

Voters are encouraged to educate themselves about this measure to maintain the character, livability and safety of our Neighborhood.
