# Awakening a giant

Three years ago Milwaukie High School's football team went to the state playoffs, and in Rachelle Hobson's words, "something clicked" and the school's spirit spread throughout the City and both communities, the High School, and Milwaukie at large, united to urge the team to victory.

# Citizen task force to examine light rail safety

Because safety issues have emerged as a central issue with the study of light rail alternatives in the Portland to Milwaukie Corridor, a Safety and Security Task Force will be created to closely examine these issues during the conceptual design and alternatives definition of the project.

This approach will offer the community and safety professionals an opportunity to voice concerns and provide input about station area locations and design options at a point in the process when changes can still be made.

Those interested in this issue are encouraged to participate and will be asked to commit to attending the six monthly meetings, expected to begin in September. Task force members will tour Interstate MAX stations and meet with stakeholders, learn TriMet's current safety and security strategies, and study and

# Town Center project takes a major step

City Council signed a Memo Of Understanding (MOU) with Main Street Partners, the same firm behind the North Main Village Project, to be the developer of the Town Center Project, the next downtown mixed-use project slated for the former Olsen Brothers Texaco site at Harrison and Main Streets.

The MOU is a formal statement between Main Street Partners and the owners of the site, the City and Metro, that more firmly establishes the expectations of the developer, in terms of conditions of sale, and of the City, in terms of the type of development to be constructed.

The MOU provides a schedule for key project milestones that will lead to the written purchase and sale agreement by November 30, 2007, permits to be filed and approved in the

## **Streets Program goes to work**

Besides serving the public as a City Councilor for the City of Milwaukie I also serve the public as the Athletic Field Coordinator for the North Clackamas Parks and Recreation District (NCPRD).

One of my job duties is coordinating the activities at the new four-field youth baseball and softball complex at North Clackamas Park. The facility opened

April 21<sup>st</sup> this year, fulfilling the promise of new ballfields made in 1990 when Milwaukie citizens elected to join the North Clackamas Parks & Recreation District.

The new fields are home to seven local youth baseball and softball organizations that serve over 2,500 local youth and their families. The improvements at North Clackamas Park not only addressed the need for more ballfields for our youth but had the added bonus of becoming a source of tremendous community pride.

There wasn't a day at the ballpark where you wouldn't hear the local folks commenting on how beautiful the park is now. It was also nice to hear visiting teams and their families from Lake Oswego, Tualatin, West Linn and Wilsonville talking about how nice the facility is and wishing they had one in their community.

During the planning process there were concerns about the impact the improvements would have on the surrounding area. Some of the concerns were will there be adequate parking? Would it bleed out into the Neighborhood? Would it increase traffic on Rusk Road? Would the lighting spill into the Neighborhood? Would the popularity negatively impact the weddings at the Rose Garden, located at the park? I am happy to say that those concerns were adequately addressed by the planners and that those concerns did not come to fruition. That's not to say that there have not been issues that concern some citizens and NCPRD that need to be, and ar, being addressed, but I think we can all agree that the improvements have made North Clackamas Park a better place for all of us to enjoy.

from Johnson Creek Boulevard to Harvey.

On 37<sup>th</sup> Avenue crews leveled the asphalt to smooth the roadway's heavy ruts and then added a two-inch overlay. On 42<sup>nd</sup> the roadway was overlayed in one section, and ground down in another before the whole section was paved with a two-inch overlay.

The SSMP will next target Oak Street between Highway 224 and Monroe and King Road from 43<sup>rd</sup> Avenue to Hollywood. This work is scheduled for fall of 2007 through summer of 2008.



# Work on 99E adds sidewalks and bike lanes

Work is scheduled to begin in late fall of this year on a two-year project to improve Highway 99E (McLoughlin Boulevard) from the Kellogg Creek Bridge in Milwaukie to Roethe Road north of Gladstone.

The project will include repaving the road surface of Highway 99E, adding a new traffic signal and intersection improvements at Highway 99E and River Road, and updates to drainage systems in this section.

From the River Road intersection south to Roethe, ODOT will construct new sidewalks at various locations to enhance pedestrian mobility and safety.

In addition, the signals for this section will be "interconnected" to improve traffic flow along McLoughlin Boulevard, leading into the recently completed highway section in Milwaukie.

Bicycle improvements include widening between River Road and Park Avenue and restriping the section of roadway to include marked bicycle lanes

# City considers quieting trains

Milwaukie staff will present City Council with a proposal that would quiet train whistles by implementing a series of "Quiet Zones" at Council's Sept. 4<sup>th</sup> Regular Session meeting, beginning at 7 p.m. at City Hall (10722 SE Main Street.)

These Quiet Zones would improve crossing safety and silence train horns at several crossings of the Union Pacific Railroad. The proposal, entitled the Railroad Crossing Safety and Quiet Zone project, builds on an existing pedestrian

improvements project at two crossings and incorporates additional safety measures to qualify for a Train Horn Quiet Zone designation. The three rail crossings under study are at Harrison Street, Oak Street, and 37<sup>th</sup> Avenue.

# **The City Code Corner**

If you're spending some of your weekends selling off personal belongings in your yard or garage there are a couple ordinances on Milwaukie's books that cover selling your "special treasures."

First of all, residents can only have two sales in a calendar year. Also, a sale can only last a maximum of three days. And finally, signs advertising the sale cannot be hammered into utility poles. This has been common practice in the past, but it is a violation and we do enforce this regulation. To get the word out on your sale, here's a tip: ask the property owner near that pole if you can stake your sign in their yard for the duration of the sale.

# Protect your water from cross contamination

A properly installed and approved backflow preventer—a mechanical device that prevents water from re-entering your home's water system—helps protect you from the potential risk of drinking water contamination from your sprinkler system. These devices can be purchased at most local plumbing or home improvement stores.

Inspection and repair of backflow prevention devices protect your home's drinking water by preventing possible contamination from backflow, cross-connection or back-siphonage. Contamination may occur when used water, such as from a sprinkler system, is sucked back into the water system by a drop in water pressure. If this water is contaminated by weed killer, fertilizer or pesticide, it can cause health problems. 

I was filling up my gas tank the other day at the local gas station where I always fill my tank. With the fluctuation of gas prices over the last year it dawned on me that I really didn't notice the increase that went into effect in July to help pay for road repair in Milwaukie.

My vehicle has a 20-gallon tank and I

generally fill up every 10 days. The \$0.02 increase has raised my cost by \$0.40 per tank or \$1.22 per month. That equates to about .007% if my math is correct.

Recently I spoke with someone who said this would harm the gas retailers in Milwaukie and they themselves would not buy gas here because of the increase.

This seemed absurd to me. First you are going to penalize the local gas stations because Milwaukie found a solution to help pay for road repair because

the state won't. Second the money you spend won't go to improving the very roads that bring us to our homes and add value to our community.

I guess the moral of the story is...buy your gas in Milwaukie. You will see a return on your investment. Buy everything you can in Milwaukie. You're investing in your community.

The North Milwaukie Industrial Complex doesn't want Light Rail because it will have a deleterious effect on freight traffic and force some companies out of business.

A McLoughlin alignment was quickly dismissed because it would involved tearing up a newly completed "Boulevard Treatment," negatively impact several business, and put the development of Riverfront Park in jeopardy.

Any combination of Main and 21st Ave. street alignments would eliminate sorely needed parking, impede traffic, and force key companies to leave.

The Tillamook Route will erode the quality of two Neighborhoods, three schools, and a large church. Any route calling for rail to Oregon City would have serious political consequences.

Doesn't it seem obvious that these are not just "NIMBY" complaints, but legitimate issues that cannot be casually dismissed by giving lip service to mitigation, Tri-Met's favorite word?

Light Rail its too out out-of-scale for skinny Milwaukie, and wherever you put it will have a long-lasting effect on our way of live, our very existence as a City.

A solution? Cut through ODOT to Southgate, out Highway 224 with stations at 37<sup>th</sup> Street and K-Mart and on out to the Highway 205 line. Come to Milwaukie, not through Milwaukie.
