

RESOLUTION NO. 31-2000

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILWAUKIE, OREGON AMENDING FEES FOR BUILDING PERMIT AND INSPECTION SERVICES AND CLASSIFYING THE FEES IMPOSED BY THIS RESOLUTION AS NOT SUBJECT TO ARTICLE XI, SECTION 11B OF THE OREGON CONSTITUTION.

WHEREAS, the City adopted building permit and inspection charges in Resolution 18-1999 on April 6, 1999; and

WHEREAS, Senate Bill 587 adopted by the 1999 Oregon Legislature amended the State surcharge imposed on building permit fees; and

WHEREAS, Senate Bill 512 adopted by the 1999 Oregon Legislature created the Tri-County Building Industry Service Board ("Service Board") to develop "uniform practices and procedures for the building and construction industries in Clackamas, Multnomah, and Washington Counties;" and

WHEREAS, SB 512 provides that one function of the Service Board is to establish "standardized criteria and methodology for determining fee amounts for permits that are required under the state building code " and

WHEREAS, the fees for electrical permits are set by Clackamas County, and the City is not amending the electrical permits with this action, with the exception of establishing that the State Surcharge for all permits (including electrical) shall be as established under State Law and deleting the minor label program; and

WHEREAS, the Service Board has established and the State of Oregon, Department of Consumer and Business Services, Building Codes Division has adopted fee methodology requiring amendments to the City's fee structure; and

WHEREAS, this amendment of City fees is intended to have a neutral impact on both City revenues and on persons obtaining building permit fees and is only designed to respond to new state regulations:

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Milwaukie, Oregon, that:

Section 1. The fees and methodologies in the attached Exhibit A are adopted and become effective upon signature of this resolution.

Section 2. The City Council determines that the fees imposed by this resolution are not taxes subject to the property tax limitations of Article XI, Section 11(b) of the Oregon Constitution.




EXHIBIT A BUILDING DIVISION FEES AND CHARGES

- A. **Residential Building Permits**—Valuation shall be calculated using the most current ICBO Building Valuation Data Table for “good construction” and without the Oregon modifier. The square footage of a dwelling or addition shall be determined from outside exterior wall to outside exterior wall for each level. The square footage of garages, carports, covered porches or patios, and decks shall be calculated separately at the corresponding values from the most current ICBO Building Valuation Data Table. Permit fees for remodels and alterations shall be calculated using the valuation determined by the fair market value as determined by the building official.

\$25,001-\$50,000	\$172 for the first \$25,000 + \$4.15 for each additional \$1,000 or fraction thereof, to and including \$50,000	
\$50,001-\$100,000	\$276 for the first \$50,000 + \$2.50 each additional \$1,000 or fraction thereof, to and including \$100,000	
\$100,001-\$500,000	\$401 for the first \$100,000 + \$2.50 each additional \$1,000 or fraction thereof, to and including \$500,000

- 2) Initial Plan Review Fees:** 65% of the permit fee

- 3) Plan Review Fees Required/Requested by Changes, Additions, Revisions:** 10% of the permit fee

- 4) Third Party Plan Review Fee: (for transfer of plan review to a third party)** 10% of the permit fee

- B. **Commercial Building Permits**—Valuation shall be calculated using the most current ICBO Building Valuation Data Table, using the occupancy and construction type as determined by the building official, with no Oregon modifier, multiplied by the square footage of the structure to determine the valuation, or value as stated by the applicant, whichever is greater, to determine the valuation. When the construction or occupancy type does not fit the ICBO Building Valuation Data Table, the valuation shall be determined by the building official with input from the applicant.

3) Fire and Life Safety Plan Review Fee (commercial only):40% of structural permit fee

(Based on valuation of total improvements or \$50.00 per hour to review a Fire and Life Safety Master Plan)
(Hourly charge must be approved by Applicant)

4) Plan Review Fees Required/Requested by changes, additions, revisions: \$50 per hour (min. charge 1 hour) hourly fee for revisions available for commercial only)

5) Other inspection and fees:

- a. Inspections outside of normal business hours \$90.00 per hour (min. charge 2 hours)
(Must be pre-approved by applicant)
- b. Inspections for which no fee is specifically indicated \$50.00 per hour
(Must be pre-approved by applicant)
- c. Replacement sheets \$20/sheet

6) The minimum fee shall be: \$45.00

C. Residential Mechanical Permits.

1) Unit Fee Schedule:

For the installation of each forced air or gravity furnace or burner, including ducts and vents attached to such appliance	\$16.50

2) **The minimum fee shall be:** \$40.00

D. Commercial Mechanical Permits—Valuation shall be calculated on the value of the equipment and installation costs.

1) **Use this section for commercial installation, replacement or relocation of non-portable mechanical equipment or mechanical work not covered previously.** Indicate the value of all mechanical labor, materials, and equipment.

\$1 to \$1,000	\$30.00
\$1,001 to \$10,000	\$30.00 + \$1.35 ea. add. \$100 over \$1,000
\$10,001 to \$100,000	\$151.50 + \$8.30 ea. add. \$1,000 over \$10,000

2) **Plan review fee:** 25% of mechanical permit fee

3) **.Other inspection and fees:**

- a. Inspections outside of normal business hours \$90.00 per hour (min. charge 2 hours)
(Must be pre-approved by applicant)
- b. Inspections for which no fee is specifically indicated \$50.00 per hour
(Must be pre-approved by applicant)
- c. Reinspection fee \$50.00

4) **Additional plan review required by changes, additions, or revisions to approved plans:** \$50.00 (min. charge 1 hour)

5) **The minimum fee shall be:** \$45.00

E. Residential Plumbing Permits.

except water heater when issued with a mechanical permit \$25.00
(for water heater w/mechanical)
- 6) **Plan Review Fees Required/Requested:**
by Changes, Additions, Revisions 10% of the permit fee
- 7) **Third Party Plan Review Fee:**
(For transfer of plan review to a third party) 10% of the permit fee.

F. Commercial Plumbing Permits.

- 1) **Each fixture:** \$15.00
- 2) **Utilities per 100 feet:** \$40.00
 - a. Catch basin \$20.00
 - b. Drywell \$20.00
 - c. Backwater valve \$20.00
- 3) **Piping:** \$30 per 100 linear fee
- 4) **Building Sewer – 50 feet maximum:** \$55.00
- 5) **Initial Plan Review Fees:** 30% of the Plumbing permit fees
- 6) **Plan Review Fees Required/requested
by Changes, Additions, or Revisions:** \$50 per hour for commercial
- 7) **Other inspection and fees:**
 - a. Inspections outside of normal business hours \$90.00 per hour (min. charge 2 hours)
(must be pre-approved by applicant)
 - b. Inspections for which no fee is specifically indicated \$50.00 per hour
(must be pre-approved by applicant)
- 8) **Minimum permit fee:** \$40.00(Except water heater
when issued with a mechanical permit
\$25.00(for water heater w/mechanical)

G. Manufactured Home Siting Permits.

For installation and set-up (separate permits and fees are required for electrical and plumbing connections, concrete slabs, runners, or foundations, and decks or other accessory structures \$107

H. A State surcharge shall be collected in an amount as required by State law.

I. Electrical permit fees shall be as adopted in resolution 21-2000, adopted by the City Council on June 20, 2000, with the following exceptions.

- 1) The state surcharge shall be the amount required by State law as noted in section F. of this resolution.
- 2) The Minor Labels program will be deleted as required by SB 512 and SB 587.
