RESOLUTION

WHEREAS, Oregon City has adopted Ordinance 1349, which provides by Section 13 thereof that the City Manager, subject to the approval of the ^City Commission by resolution, may designate stop streets, crosswalks, safety zones, traffic lanes, areas in which no parking shall be permitted and areas in which the time of parking is to be limited, install additional parking meters as required, the operation and use thereof to be governed by Ordinance No. 1326, and direct the placing and maintenance of such traffic signs, markers and signals as may be reasonable or necessary to carry the above powers into effect and also for the regulation and safety of traffic, and

WHEREAS, after careful study it has been determined that the following area requires traffic regulation,

NOW THEREFORE BE IT RESOLVED by the City Commission of Oregon City that the City Manager be and he is hereby authorized and directed to designate the following as areas in which no parking shall be permitted, to-wit:

- 1. On the Northerly side of Fourth Street between Linn Avenue and Jackson Street.
- 2. On the Easterly side of Van Buren Street between Seventh Street and Ninth Street.
- 3. On the Easterly side of Harrison Street between Seventh Street and Ninth Street.
- 4. On the Northerly side of Division Street between Pierce Street and Twelfth Street.
- 5. On the Southerly side of Fifteenth Street between Harrison Street extended and Division Street.
- 6. On the Southerly side of Seventeenth Street between Green Point Street extended and East 82 Street, Oregon State Highway.
- 7. On the Easterly side of Green Point Street between Seventeenth Street and Eighteenth Street.
- 8. On the Northerly side of Eighteenth Street between McLoughlin Boulevard and Main Street.
- 9. On the Easterly side of Main Street between Seventeenth Street and Eighteenth Street.
- 10. On the Northerly side of Eighth Street between Center Street and Washington Street.
- 11. On the Southerly side of Willamette Street between Molalla Avenue and Eluria Street.
- 12. On the Southerly side of Logus Street between Molalla Avenue and Warren Street.
- 13. On the Southerly side of Roosevelt Street between Molalla Avenue and Eluria Street.
- 14. On the Southerly side of Pearl Street between Molalla Avenue and Warren Street.
- 15. On the Southerly side of Dewey Street between Molalla Avenue and Warren Street.
- On the Easterly side of Warren Street between Pearl Street and Dewey Street.
 On the Southerly side of Mt. Hood Avenue between Molalla Avenue and Magnolia Street

18. On the Easterly side of Magnolia Street between Mt. Hood Avenue and Duane Avenue.
