Section 3. B. As related to Planning fees: (1) When two or more applications relating to a single parcel of land will be considered at the same Planning Commission meeting, a 25% reduction in fee will be made for the second (third, etc.) request. The reduction will be calculated for the less costly fee. (2) A 25% discount is offered for senior citizens and low income citizens. Seniors must be at least 62 years of age. Low income citizens may qualify for reduced fees by filing an application similar to the form used to apply for reduced sewer and water rates.

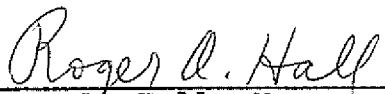

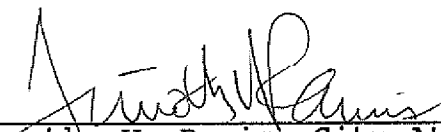
