RESOLUTION NUMBER 25-1988

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILWAUKIE SETTING RATES TO BE CHARGED BY FRANCHISEES UNDER ORDINANCE NUMBER 1301. THE ORDINANCE PROVIDING FOR THE ESTABLISHMENT, MAINTENANCE, AND OPERATION OF A SYSTEM OF WASTE AND SOLID WASTE DISPOSAL.

WHEREAS, the garbage franchisees of the City of Milwaukie have applied for a Rate Increase, and

WHEREAS, there will be a substantial increase in their cost of doing business effective November 1, 1988, as the result of the increase in disposal rates approved by METRO,

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Milwaukie, Oregon, that franchisees under Ordinance Number 1301, an Ordinance providing for the establishment, maintenance and operation of a system of waste and solid waste disposal, shall be as set forth in Exhibit "A" attached hereto, which is by reference made a part hereof, and that said rates as set forth on the attached Exhibit "A" shall be effective on the 1st day of November, 1988.

Introduced and adopted by the City Council on the 4th day of October, 1988 at a regular meeting of the City Council.

EXHIBIT "A"

SOLID WASTE AND WASTE COLLECTION RATES IN THE CITY OF MILWAUKIE

Effective the 1st day of November, 1988

I. 32 Gallon Can

Residential Rates The rate per 32 gallon can per month shall be: One Collection Per Week - One Can One Collection Per Week - Two Cans One Collection Per Week - Each Additional Can	\$ 9.50 \$ 17.90 \$ 7.45
Court Apartments The rate per 32 gallon can per month shall be: One Collection Per Week - Per Can	\$ 8.35
Commercial Can Rates The rate per 32 gallon can, one stop per week: One Collection Per Week - One Can One Collection Per Week - Two Cans	\$ 10.20 \$ 19.10
One Collection Per Week - Each Additional Can	\$ 7.45

Additional stops per week for 32 gallon cans shall be served at 100% of the first stop per week rate.

Additional Residential Service:

- 1) Occasional service on the regular route day in the area is available upon notification to your collector at least 24 hours prior, or personal contact with the driver ("Yoo-Hoo" service) on the route as in the past. The rate shall be \$3.55 cash paid to the driver or \$4.80 if billed, on a per can basis.
- 2) "Roller Can" service may be offered by the franchised garbage hauler. Customers of "roller can" service may be required to place the can at the curb on collection day. The rate shall be no more than \$11.90 per month for this service.

II. Container Service

Additional containers shall be served at 90% of the first container rate. Additional stops per week shall be served at the 90% of the first stop per week rates. The collector shall furnish the containers.

b. Compacted Material - one stop per week, first container:

 Two Yards
 \$166.50

 Three Yards
 \$221.20

Additional containers shall be served at 90% of the first container rate. Additional stops per week shall be served at 90% of the first stop per week rates. Compactors furnished by the customers shall be compatible with the equipment of the collector. If the collector agrees to furnish the compactor, the collector may charge a reasonable rental fee based on the value of the compactor and the cost of repair and maintenance.

III. Drop Box Service

a. Loose Material

For repeat customers:

20 Yards \$63.65 (plus disposal costs)
30 Yards \$81.10 (plus disposal costs)
40 Yards \$93.65 (plus disposal costs)

An additional \$17.20 per drop box may be charged for one-stop service (plus disposal costs). A reasonable deposit for disposal costs may be charged.

b. Compacted Material

Under 18 Cubic Yards \$76.70 (plus disposal costs)
18-29 Yards \$4.70/yd (plus disposal costs)
30-39 Yards \$4.20/yd (plus disposal costs)
40+ Yards \$3.70/yd (plus disposal costs)

Rental Fee after 48 hours on location, per 10 yards of drop box capacity, per day \$2.70

IV. Any Other Type Service

If, due to changes in technology or needs of residents and business people of Milwaukie, additional or other types of services are needed, the charge for the service shall not be discriminatory, shall be reasonable by being commensurate with the rates above, and shall not exceed the rates most generally applicable in the Portland Metropolitan Area.
