Every student at Rowe Middle School, all 689 students, participated in more than 30 community projects of their own choosing on May 26th to improve the lives of others and hopefully, to encourage such service down the road.

"Our community gives us so much, so it's a wonderful feeling to give back and maybe we can spark an interest to volunteeer later on," said Rika Warner, a student parent and active volunteer at Rowe.

This is the third consecutive year Rowe has held its Service

Learning Day, and this year's projects included cutting ivy in Forrest Park, making toys for the animals at a Multnomah County animal shelter (shown to

the right), beautifucation projects on the school's grounds and reading to first and second graders at nearby Elementary Schools.

Rowe Principal Larry Becker explained the effort began when a group of Rowe teachers became interested in building a sense of



community within the classorom, within the school, and outside the school's walls.

"The question was, 'Can 700 students make a difference in one day," Principal Becker said.

The answer: Absolutely.

Council considers utility bill increases

City Council will consider approving a budget for the next fiscal year on June 7th that, as recommended by the Citizen Utility Advisory Board, includes the following rate increases:

0% increase in the Street Fee; 15.5% in Water; 7% in Wastewater; and 7.5% in Stormwater, resulting in an overall average increase of approximately 9% in your monthly utility bill, or approximately \$5.40 per month.

On another note, we have three events this summer for which we need your help, and support.


- The Farmer's Market is up and running, and the vendors have many good products for you to purchase. They are there rain or shine, so get out and support them.

Planning Commission looks at natural resources

The City already has protections in place to preserve the quality of water in the community's streams and wetland areas. Now the City is broadening those protections to include sensitive wildlife habitat and thereby comply with Metro's Title 13, the Nature in Neighborhoods initiative. To do this, the City is proposing to amend its zoning code to establish new guidelines for future construction in and around streamside and wetland habitats.

In April, largely in response to public comments, the Commission directed staff to make some modifications to the proposal and continued the hearing again to June 14th (6:30 p.m. at Milwaukie City Hall). The Commissioners are interested in the public's perspective on this proposal, and the record remains open for additional written comments. The service is provided for Milwaukie residents, and only paper will be accepted.


'Friends' book sale dates set

The City Code Corner

Do your trees and bushes hang over a sign, traffic signals, the street or sidewalk?

The City's Municipal Code (MMC 12.12.015 and 12.12.010) requires vegetation to be clear of traffic signals and street, informational, speed or stop signs in order to maintain clear sight lines and travel lanes for motorists and pedestrians. The code also requires vegetation to hang no lower than eight feet over sidewalks, and 12 feet over streets, including bike lanes.

Proper trimming allows all modes of transportation to occur safely and provides the necessary height clearance for the street sweeper to clean the streets.
