## Milwaukie's Local Leaders

### Providing places to go

Four or five times a week, volunteer Transportation Reaching People (TRP) driver Paul Van Houte is on the road helping his senior and disabled passengers in Milwaukie.

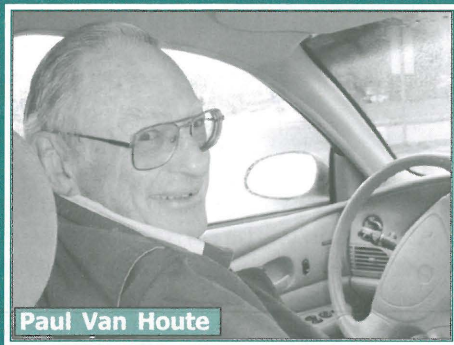
Driving for TRP, a program administered by Clackamas County Social Services Volunteer Connection, Paul uses his own car to help people who need to get to medical appointments and other important destinations.

"The number of people who express their appreciation is really tremendous," Paul said. "Without this program, many of these people would feel trapped. They feel good to go places."

Paul has been helping our community as a volunteer driver for three years and he says he gets as much as he gives.

"I go places I've never been and I meet people I never would have met," Paul said. "And of course just helping other people is very satisfying."

Transportation Reaching People is currently seeking volunteers who can help out in the Milwaukie area. Volunteers receive a mileage allowance, training and supplemental liability insurance. All rides originate in Clackamas County and the destinations are limited to the Tri-County area. ## Annexation vote nears

Before voters submit their ballots regarding Ballot Measure 3-166 on May 17<sup>th</sup>, the measure that asks Milwaukie residents if they wish to annex to Fire District No. 1, there are three basic things City leaders hope voters will keep in mind.

First and foremost, annexing to the Fire District will not increase taxes. The ballot measure requires the City to reduce its property taxes by the same amount the Fire District would levy, \$2.40 per \$1,000 of assessed value, if the measure were to gain voter approval.

Second, annexation is the best and most efficient way to ensure Milwaukie's citizens will receive fire suppression and emergency medical response services. The City has contracted with the District for these services for the past seven years, and the contract expires in 2008. Through annexation, the City and District will be able to stabilize this relationship.

Finally, the measure's language ensures taxes can't be raised in the future without voter approval.

## City lands street funds

Armed with the \$450,000 in federal transportation dollars Metro allocated by Metro on March 24<sup>th</sup>, the City will be able to dramatically upgrade the Downtown streetscape by introducing historical street lighting, street trees, improved sidewalks, benches and angled parking to four blocks near City Hall and adjacent to the North Main Village project.

The money was allocated through the regional government's Metro Transportation Improvement Project. The improvements follow the City's adopted Downtown & Riverfront Plan — a plan seeking to create a more visibly attractive and pedestrian-friendly Downtown core.

The improvements will be coordinated with the North Main Village project. Check future editions of *The Pilot* for details.

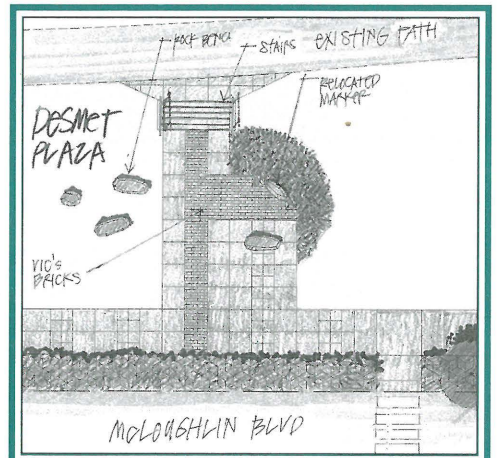

The entry plaza will be located at the end of the newly signalized intersection of McLoughlin and Monroe and will reuse some of the bricks from the nearby Kroll building, the former home of Vic's Tavern, to create an ornamental design for the plaza. The Kroll building and neighboring antique shop will be removed prior to construction.

The plaza will feature benches and the relocated Desmet Historical Marker, which used to be near Jefferson Street. ☘

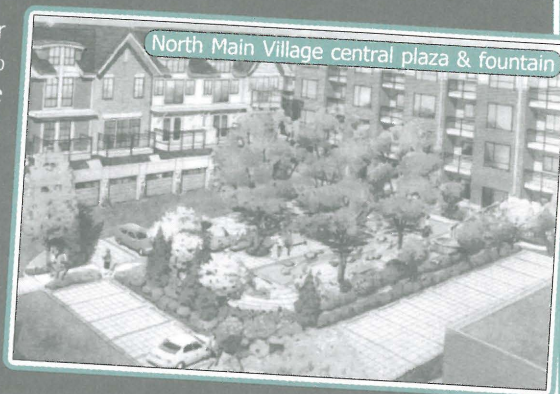
## North Main design nears finish

Construction documents for the North Main Village are 75% complete and are expected to be submitted to the City's Planning Department by mid-May.

Groundbreaking for the project is projected for the end of summer.

The project, located at the old Safeway site, will be comprised of five buildings, feature 97 housing units and 9,496 square feet of commercial/retail space. All told the project will create 86,064 square feet of new Downtown development.

Recent renderings of the project generated by the developer, Main Street Partners, LLC, show the buildings will exhibit a variety of architectural styles, spanning from more of a traditional look to the more modern.



One of the most unique aspects of the project is a water feature in the the Village's central plaza that takes rain-water and runoff and funnels the water into a fountain.

## The City Code Corner

With spring upon us, many of us will not get to all of the projects we had planned all winter.

For some this may include a new fence to spruce up our properties.

But did you know that the City of Milwaukie has an ordinance dealing with fence heights?

Basically, in residential zones, the maximum height for fences is six feet for your rear, street side and side yards.

For the portion standing in the front of your house, including the front property line, 42 inches is as tall as you may go with a fence.

There are additional regulations for flag lots.

Should you have any questions about fences, give our Planning Department a call before you start construction so you do not inadvertently run afoul of your City's zoning ordinance. You can get a hold of the City's "planner of the day" at (503) 786-7630. ☒

According to an article in *The Oregonian*, Metro's 2040 Plan of Regional and Town Centers is not quite working out. As a matter of fact, many critics think Metro's approach is flawed. Ten years

since the Plan's adoption, designated centers are barely outgrowing non-centers. Reasons cited: landowners and developers concentrating on malls and apartments; density fears; environmental regulations; and voter distaste for urban renewal.

Some experts bluntly state that Metro is relying too much on high concept policy planning and regulation to force 2040's centers into being. Seems like there's a snake loose in the New Urbanism Garden of Eden.

Closer to home another confusing statement came from a Milwaukie goal-

setting meeting. As quoted in the same publication a high-ranking official suggested preserving the City's livability should be a preeminent goal for our future. Oh, really? Every time anyone from our Neighborhood mentions livability we are accused of stifling progress growth and prosperity.

As the old story goes, our destiny is tied to our density. Maybe somewhere between Metro's idealistic New Urbanism on one end and the much-maligned urban sprawl on the other we can find what we crave in this little gem of a town – Livability.

Stewart Taylor, City Financial Director, introduced himself as our new City liaison. We look forward to working with him and bid Jason Wachs, our former liaison, good luck in the future as he moves to the Seattle area.

Brian Stegner, Milwaukie Covenant Church youth pastor, gave an overview

of the proposed SK8 (skate board) Park on the church's property, anticipated to open to area youth in the near future.

The park will include portable equipment, a \$5 annual fee, posted rules for use, be open 3-4 days per week and is designed to provide a safe place for youth to interact with adults.

Neighborhood folks voiced some strong concerns regarding issues that have affected residents near the church in the past. In order to reduce impacts to neighbors MCC has agreed to move the

existing tables/benches currently near their western boundary to the east side, which would provide better visibility from Linwood Avenue and increase safety for youth using the area. They also agreed to confine the proposed skating area to that eastern side.

Our next meeting will include elections for board members and a discussion regarding applying for grant funds for the insurance to enable MCC to move forward with the skate park.
