Oregon City	5 AM - 10 PM
City of West Linn	Hours vary by facility – most parks close at 10 PM; Fields Bridge Park open until 11 PM (sports fields); skate park hours are 9 AM – 8 PM
City of Tualatin	Sunrise to sunset, with exception of two lighted facilities with sports courts and skatepark. These can be used until 10:30 PM.
North Clack PRD	Open ½ hour before sunrise and close ½ hour after sunset unless otherwise specified.
City of Canby	6 AM – 10 PM
Lake Oswego	6 AM – 10 PM, except Millennium Plaza which is open 6 AM - midnight
City of Wilsonville	Dawn to dusk unless otherwise indicated

# 2010 PRAC Goals Status as of 10/28/10

- Identify funding for phase 2 and complete development of Wesley Lynn Park. High School Construction Program planning restroom/concessions building (most costly part of phase 2). Staff planning Leland Rd access pathway connection to be done this fiscal year. Need to master plan future use of undeveloped property at some point. No funding identified for further portions of the project at this time.
- Determine future plans for RV Park.
  Staff is finalizing RFP to solicit design services. Anticipate doing this over winter. Once design is complete, will be able to estimate costs and begin to identify potential funding. No funding identified at this time.
- Seek funding and begin new park development projects per completed master plans for Canemah Children's Neighborhood Park and Chapin Park.
   Canemah Park under way – anticipated completion in summer/fall 2011.
   Chapin Park – no funding identified at this point.
- 4. Playground installation of Canemah Children's Neighborhood Park. Will be completed as part of #3.
- 5. Begin Master Planning process for the Glen Oak Road and Filbert Run properties. Anticipate beginning this process in spring/summer 2011. Plan to do these at the same time, with one design firm for efficiencies and consistencies. Funding for these master plan processes are anticipated in the current fiscal year budget.
- 6. Determine future use of Carnegie Center. Task force report completed and was presented to City Commission in July. Library timeline uncertain.

## 7. Investigate dog parks.

Under way – PRAC has formed a committee to begin identifying sites and key issues. No funding identified at this time.

- Naming trail linkages/standardized signage. Standardized signage design completed this summer. No additional progress on naming of trail linkages. No funding identified for any other anticipated costs.
- Work with the City in the process for determining the use of the End of Oregon Trail Interpretive Center site.
   Task force/consultant recommendations report completed. Presented to City Commission in early October.
- 10. Support the effort and provide input as necessary for the transfer of the Ermatinger House to the National Park Service.

Completed. Discussions with NPS have culminated in a decision that the Park Service is not in financial position at this time to accept the Ermatinger House.
