SUBJECT:

First and Second Readings, Ordinance No. 13-1008, Temporarily Suspending a Portion of Oregon City Municipal Code Section 12.16.040.A Regulating Camping in Public Parks and Declaring an Emergency

RECOMMENDED ACTION (Motion):

Staff recommends the City Commission the first and second readings of Ordinance No. 13-1008 to allow camping in public parks over the next thirty (30) days, and to require the staff to report back to the Parks and Recreation Advisory Committee for future consideration of whether the City should allow camping in public parks for special events and circumstances.

BACKGROUND:

The Oregon City Municipal Code (OCMC) Section 12.16.040.A currently prohibits camping in public parks and certain other places. For certain special events and circumstances, the City may want to allow camping for a limited duration in public parks. One such instance is proposed to take place July 21, where camping is anticipated at Clackamette Park for a special cultural ceremony of the Confederated Tribes of Grand Ronde.

The City staff intends to consider this event and any camping associated with the celebration as an experiment to determine whether the City should revise current code provisions to govern camping in public parks for special events and circumstances. In order to allow the experiment to take place, the prohibition on camping in public parks under OCMC 12.16.040. A must be suspended. If the attached Ordinance No. 13-1008 is adopted, then camping will be permitted in public parks for thirty (30) days.

The City will require the Community Services Department staff to report to the Parks and Recreation Advisory Committee (PRAC) to explain whether the event was a success, and learn other details related to the camping activity that occurs. Thereafter, City staff recommends that the PRAC submit a recommendation to the City Commission about next steps the City may want to consider in relation to camping in public parks.

ORDINANCE NO. 13-1008

AN ORDINANCE OF THE CITY OF OREGON CITY TEMPORARILY SUSPENDING A PORTION OF OREGON CITY MUNICIPAL CODE SECTION 12.16.040.A REGULATING CAMPING IN PUBLIC PARKS AND DECLARING AN EMERGENCY.

WHEREAS, Title 12, Chapter 12.16 of the Oregon City Municipal Code is comprised of standards regulating the use of public parks;

WHEREAS, the City has identified particular special events and circumstances where the City of Oregon City ("City") may desire to permit people to camp in public parks;

WHEREAS, the City identified one such special event is scheduled to occur in the month of July;

WHEREAS, a 30-day suspension of the portion of Oregon City Municipal Code Section 12.16.040.A that prohibits camping in public parks is necessary to allow people to camp in public parks for this special event;

WHEREAS, the remaining prohibitions on camping in or upon any sidewalk, street, alley, land, public right-of-way, or any other place to which the general public has access under Oregon City Municipal Code Section 12.16.040.A will remain in full force and effect; and

WHEREAS, adopting this temporary suspension of the portion of Oregon City Municipal Code Section 12.16.040.A that prohibits camping in public parks is in the best interest of Oregon City to ensure that the goals and policies of the City can be realized.

NOW, THEREFORE, OREGON CITY ORDAINS AS FOLLOWS:

Section 1. The portion of Oregon City Municipal Code Section 12.16.040.A,

"12.16.040.A It is unlawful to camp in or upon any sidewalk, street, alley, lane, public right-of-way, public park or any other place to which the general public has access."

that prohibits camping in public parks is hereby suspended for thirty (30) days.

Section 2. Because this Code suspension is necessary for the summer operations of the public parks beginning in July 2013, this Ordinance shall be in full force and effect from the time of passage by the City Commission.

Read for the first time at a regular meeting of the City Commission held on the 17^h day of July 2013, and the City Commission finally enacted the foregoing ordinance this 17th day of July 2013.

Background:

The Oregon City Municipal Code (OCMC) Section 12.16.040.A currently prohibits camping in public parks and certain other places. For certain special events and circumstances, the City may want to allow camping for a limited duration in public parks. One such instance is proposed to take place later in July to celebrate the End of the Oregon Trail, where camping is anticipated.

The City staff intends to consider this event and any camping associated with the celebration as an experiment to determine whether the City should revise current code provisions to govern camping in public parks for special events and circumstances. In order to allow the experiment to take place, the prohibition on camping in public parks under OCMC 12.16.040.A must be suspended. If the attached Ordinance No. 13-_____ is adopted, then camping will be permitted in public parks for thirty (30) days.

The camping proposed in conjunction with the special event to celebrate the End of the Oregon Trail is being run by event staff. The City will require the event staff to report back to the Parks and Recreation Advisory Committee (PRAC) to explain whether the event was a success, and learn other details related to the camping activity that occurs. Thereafter, City staff recommends that the PRAC submit a recommendation to the City Commission about next steps the City may want to consider in relation to camping in public parks.

STAFF RECOMMENDATION:

Staff recommends the City Commission approve Ordinance No. 13-____ to allow camping in public parks over the next thirty (30) days, and to require the special event staff for the celebration of the End of the Oregon Trail to report back to the PRAC for future consideration of whether the City should allow camping in public parks for special events and circumstances.

Scott,

Ed, Carrie and I discussed the best approach to the code amendments to allow camping for the Tribes in Clackamette Park in July and the Pioneer Family Festival operator when the carnival is running.

We recommend the following approach given the short timeframe to draft the ordinance:

1. Adopt an ordinance on July 17 temporarily suspending Section 12.16.040.A as an emergency ordinance (2 readings on the same night). The suspension will be for 30 days, unless you foresee a need to extend the suspension.

2. After the tribal camping event staff will report to the PRAC with recommendations about consideration of whether the City should allow camping in certain parks.

3. PRAC should make recommendations to the City Commission about next steps.

4. City Commission to take recommendations under consideration and direct further action by staff, if necessary.

5. Thereafter, staff can work with our office to put into place the City Commissions directives. The City Attorney will assist in code amendments if that is the direction from the City Commission.

Relatedly, is the tribal camping event going to be an annual event? What provisions are being made to ensure adequate parking and restroom facilities?

What is the date of the Pioneer Family Festival? It appear from a quick Google search that the event occurs in May. Is this accurate? Also, is it necessary for the carnival operator to camp onsite?

Last, can you update Kattie Riggs on our recommendation.

I am available to discuss any of the foregoing in greater detail. We will get you a draft ordinance by July 8. Thank you.

Sure, that would be great. Here is the update:

The Request for Proposals (RFP) for park design/master plan services is anticipated to be advertised by (or about) August 1. This will be done in conjunction with the Filbert Run property – one consultant for both park sites, though each site master plan will be done as its own unique design. The advertising period and selection process will take a few weeks; this is somewhat dependent on the volume and quality of responses the City receives. I plan to ask PRAC for a representative on the selection committee – maybe that is something you'd like to consider? Once a consultant is selected, we will quickly determine a work timeline and establish a public meetings schedule for each of the park sites separately. These meetings will likely take place this fall. We will announce the meetings through the respective neighborhood associations as well as via our other public outreach methods (website, media, etc). If people wish to be directly contacted when the meetings are scheduled, you may give them my phone/e-mail contact info and ask them to submit their contact info to me & I will put them on a direct contact list.
