BACKGROUND:

As part of efforts to provide outreach and education, staff will be providing overviews and explanation of specific chapters of the development regulations in our municipal code (OCMC) which pertain to protection and mitigation of natural resources. The first chapter we will be explaining is Chapter 17.41, Tree Protection.

The intent of Chapter 17.41 is to ensure that new development is designed in a manner that preserves trees to the maximum extent practicable. As a requirement of any Type II land use application, the siting of structures, roadways and utility easements, shall provide for the protection of tree resources to the maximum extent practicable. This chapter applies to all subdivision, partition and site plan and design review applications.
