Dog Park – Mike and Patrick

- Update on where we are as a committee in discussions
- General feeling that the public desires based on anecdotal evidence (Scott)
- Where it racks and stacks in the Master Plan
- Types of dog parks and the pros/cons
- Methodology of choosing the park location

Support PMUF for Parks maintenance and staff level increase – Bryan

- Current level of Staff well below national standard (Scott)
- What the proposed PMUF should be used for (All)
- PRAC should be included in18-month-long "methodology process"

Advocate that PMUF issue should be linked with the disposal of pocket parks – Bryan

- PMUF & Disposal should run concurrent and yield separate measures on the ballot
- Funds used for other park development possible? ...list of parks under developmt
- Would only dispose of those that made sense, would generate profit and/or significantly decrease man-hours to maintain thereby creating savings=win, win

RV Park - Bryan

- Relevance of RV Park location With Cove project on the table, park seen as a continuation of the improvements that will be made economic multiplier
- "Eyesore" status plans to date that have been drawn up (Scott/Larry)
- Trail system linking it to a number of parks and city center
- Revenue generator, modest, but sure will conceivably have break-even point

Singer Falls Project – Bryan

- Rotary grant approved and project commencing
- Logical continuation of the promenade maintenance completed in 2010
- First phase will include the removal and repainting of mural at base of the Falls
- Next phases include possibility of lighting the Falls & (Scott)
- The uniqueness of Oregon City Falls, Staircase, Elevator, Promenade, Bridge; at night the lit Falls can be seen from the bridge

Naming of Trail Linkages and Standardized Signage – Bryan

- The "pros" of starting in old city center and working outward "Center of Gravity"
- Lines up with Commission 2011/12 Goals trails to/from city center (downtown)
- Linking Prom to Old Canemah, Prom to Water Board, Clackamette to Storm to City Center to Prom...etc – Rivers, Cove projects (Scott/Denise, any trail linkages from proposed Rivers site we can mention here?)

- PRAC supports "Main Street Oregon City" River to Prom project (Scott/Denise)
- Name of trail from Storm up 99E to the Willamette Falls? Willamette River Trail (Scott/Denise, is there any project we can advocate for in this section?)
- Newell Creek Canyon Trail is in the Trails Master Plan as Tier 1

Support the formation of the Heritage Committee – Bryan

- Overarching body to oversee all historical entities
- Compare reports/recommendations from EOTC and Carnegie TF consultants; look at solutions using a holistic approach

New information / highlights:
