1. CALL TO ORDER

Chairperson Carter called the meeting to order.

2. REVIEW OF WORK SESSION NOTES: December 13, 2000

Commissioners previously agreed to approve the December 13, 2000 work session minutes at the January 8, 2001 Planning Commission meeting.

3. Work Session - Molalla Avenue Improvement Plan

Nancy Kraushaar stated that the Molalla Improvement Plan had been developed to allow the Metro designated transit corridor to handle an increase in traffic flow due to new development. She stated that Sharon Zimmerman was the Staff project lead, and that Bob Wallis from Wallis Engineering would give a brief presentation on the improvement plan. The presentation and covered the following points:

- The main goal of the Molalla plan is to maintain capacity and handle growth without having to rely on right-of-way additions; access management is an important factor for improvement.
- The Molalla Improvement Plan is very specific and would supersede the TSP only in the Molalla transit corridor.
- Main problems identified for improvement include sidewalk obstructions, sidewalk discontinuities, too many driveways, poor pavement, lack of landscaping and bike lanes, and excess signage.

- The improvement plan cuts Molalla into three different segments; each segment incorporates plans for phased build-out and for full build-out.
- The project also includes planning for intersections, landscaping, sewer and utility management along the Molalla corridor.
- Commissioners need time to thoroughly review the plan and would like to postpone approval.
- Commissioners need to keep several questions in mind while reviewing the Molalla Improvement Plan: How does the plan fit in with the TSP? How to word a condition that would require a plan review in five years? How to allow for flexibility with property easements?

4. OTHER

A. Year 2001 Calendar

Maggie Collins stated that the year 2001 calendar would be discussed at the January 22, 2001 meeting.

B. Review of Planning Division Work Program

Maggie Collins stated that she is currently working on finding a meeting facilitator and would inform the Planning Commission when she has more information. She stated that the new Planning Design Standards documents would be handed out once they are approved, and that the RD-4 zone change documents would also be made available at that time.

5. ADJOURN

Chairperson Carter adjourned the worksession.
