## ORD INANCE NO. 1227

An ordinance authorizing the Mayor and City Recorder of Onegon City, Oregon to enter into a contract with C. P. Scroggins for gathering swill and garbage in Oregon City, Oregon, and declaring an emergency.

## OREGON CITY DOES ORDAIN AS FOLLOWS:

Section 1. That the Mayor and City Recorder of Oregon City, Oregon are hereby authorized and instructed to execute a contract with C. P. Scroggins to gather swill and garbage in Oregon City, Oregon until the 1st day of January, 1933, and authorizing the said C. P. Scroggins to charge therefor the following sums to-wit: Not more than twenty five cents (25¢) per month for hauling away the cans from a residence; not more than fifty cents (50¢) per month for hauling away the garbage and cans from a residence; not more than Two Dollars (\$2.00) per month for hauling away the garbage and refuse from a restaurant, and not more than Six Dollars (\$6.00) per month for hauling away the refuse, cans, etc., from business houses, and not more than One Dollar (\$1.00) each, for hauling away any dead cat or dog.

Section 2. Whereas, it is necessary for the health and safety of the public to have the garbage and swill taken care of, an emergency is hereby declared and this ordinance shall be in effect immediately upon its passage and approval by the Mayor.

It is hereby declared and adjudged that existing conditions are such that this ordinance is necessary for the immediate preservation of the peace, health and safety of the public, and an emergency is hereby declared to exist, and that this ordinance shall take effect and be in full force and effect from and after its approval by the Mayor.
