Ordinance No. 1339, an ordinance amending paragraphs two and three of Section 11 of Ordinance No. 1326, known as the Parking Meter Ordinance, and providing penalty for violation thereof, was read the second time and on motion placed on its final passage, and it appearing from the certificate of VanHoy O. Ballou, principal clerk of the Publisher of the Oregon City Enterprise, that the same had been properly published as required by the Charter, the ordinance was passed.

The following Resolution was read and adopted:

RESOLUTION

WHEREAS, the petition of Clifford Corless, Doris Corless, August Entner, Geo. Boettcher, Bertha Boettcher, Theodore Entner, Cora Schroeder and Arthur Schroeder has been filed on November 15, 1946, asking that the City Commission of Oregon City, Oregon initiate proceedings to reduce the alley through Block 167, Oregon City, according to the duly recorded plat thereof, between Jackson Street and Van Buren Street, from 26 feet in width to 10 feet in width in its entirety by vacating a strip of land eight feet in width along the entire Northeasterly side of said alley adjoining lots 2 and 7 in said Block and by vacating a strip of land 8 feet in width along the entire Southwesterly side of said alley adjoining lots 3 and 6 in said Block, and reduce said alley from 26 feet to 10 feet in width as above set forth as by law provided; and it appearing that said Petition contains the signatures of all the owners of property abutting the alley in said block 167, Oregon City, according to the duly recorded plat thereof, consenting to said vacating,

NOW, THEREFORE, BE IT RESOLVED, That the City Commission of Oregon City, Oregon initiate proceedings to reduce the alley through Block 167, Oregon City, according to the duly recorded plat thereof, between Jackson Street and Van Buren Street from 26 feet in width to 10 feet in width in its entirety by vacating a strip of land 8 feet in width along the entire Northeasterly side of said alley adjoining lots 2 and 7 in said Block and by vacating a strip of land 8 feet in width along the entire Southwesterly side of said alley adjoining lots 3 and 6 in said Block, on its own motion as by law provided, and make said vacating in the absence of valid, legal objection thereto.
