#### SPECIAL MEETING

The City Commission met in special session at the office of the City Manager at 1:00 o'clock p.m., on the above date.

Mr. Arthur Beattie appeared before the commission as an attorney in the case of L.A. Morris versus Oregon City, No. 17425.

After due consideration a motion was made and duly passed moving that Oregon City rest in the case of L.A. Morris versus Oregon City, No. 17425, and asking that the court decide the case on the evidence and pleadings heretofore presented.

The following resolution authorizing the sale of the following described property was read and adopted.

RESOLUTION

WHEREAS, Oregon City is now the owner of the following described real property, to-wit:

All of Lot Four (4) in Block Twenty-six (26) Oregon City, according to the duly recorded plat thereof, except a strip along the southeasterly side of said Lot 4, conveyed to Oregon City by deed recorded February 15th, 1929 in Book 196 at page 223, records of Clackamas County, Oregon.

Situate in Clackamas County, State of Oregon.

WHEREAS, Geo. W. Dunmire and Hazel E. Dunmire, his wife, desire to purchase said property from Oregon City on contract for the purchase price of Thirty-five Hundred (\$3500.00) Dollars, and

WHEREAS, it appears to the best interests of Oregon City that said property be sold, and

WHEREAS, it appears that \$3500.00 is a reasonable price for said property,

NOW THEREFORE, BE IT RESOLVED that the Mayor and Recorder for and on behalf of Oregon City be, and they hereby are, authorized to enter into a contract of sale with Geo. W. Dunmire and Hazel E. Dunmire, his wife, for the sale of said property for \$3500.00, payable as follows; Down payment of \$300.00, and monthly payments of \$25.00 per month, with interest at 5% from date on the unpaid balance, beginning February 1, 1940, and continuing said monthly payments at said periods thereafter until December 31, 1942, and on January 1, 1943, the balance of \$2325.00, and interest, will become due. And upon the payment in full of said contract the Mayor and Recorder be, and they are hereby further authorized to execute a corporation quitclaim deed of said property to said Geo. W. Dunmire and Hazel E. Dunmire, his wife.
