The City Manager presented the question of more land for the cemetery. He stated that the Cemetery Superintendent had informed him that there was land enough left for approximately ten years. Several sites were discussed. It was agreed by the Commission to make a personal survey and look over prospective sites after the first of the year.

A question of hot water showers at the swimming pool was presented and the City Manager suggested that a charge for all persons using the pool be considered. He stated that at such time as we get hot water showers there will be added expense plus added operational expense. It developed that the City could not share the burden alone. He stated that approximately 21,000 people used the pool last year and, therefore, the income under these conditions would amount to approximately \$2,100 per year. The Commission agreed to take the matter into consideration and that the Manager be directed to investigate the cost of installation of hot water showers.

The Commission discussed the proposed zoning ordinance and agreed to take the matter up again at the meeting on December 2nd.

The City Manager presented the results of his preliminary investigation as regards the elevator. He stated that three things were considered: 1. Making changes in the existing plans and asking for new bids; 2. Remodeling the old elevator; 3. A new elevator design. The Manager stated that he had discarded making changes in the existing plans as he felt that not enough money could be eliminated and still leave a satisfactory structure. He stated that he was still considering remodeling the old elevator. However, preliminary investigation showed that the cost would run in the neighborhood of \$90,000 and he thought it would not be wise to put that much money into an old structure. He further stated that regardless of what is done the tunnel must definitely be eliminated because of the cost of the rock work. A discussion ensued as to merits of the various proposals and the question of a new design and it was agreed that the Commission confer with the architect, Mr. Huntington, regarding the matter. It was moved by Commissioner Roake and seconded by Commissioner Helzer that the present plans be rejected as not within our monetary funds available.

The regular meeting of the City Commission was held on the above date in the Commission Chambers at the City Hall at 7:00 P.M.

The minutes of the previous meeting were read and approved.

The City Manager presented for consideration the contract for the coming year to buy chlorine. Two proposals were presented: one from Pennsylvania Salt Company and the other from Hooker Electrochemical Company. He stated that for the past several years all chlorine had been purchased from Hooker, and he recommended that for the coming year the chlorine be purchased from the Pennsylvania Salt Company and in 1955 it again be purchased from Hooker, and that the business be alternated in that manner in the coming years. It was moved by Commissioner Roake and seconded by Commissioner Helzer that the City buy chlorine from the Pennsylvania Salt Company for the year 1954.

Nays: None.

The City Manager presented for consideration buying a coin sorter for approximately \$265. He stated that the old machine was beyond repair and a new machine would definitely have to be purchased. It was moved by Commissioner Roake and seconded by Commissioner Helzer that the City Manager be authorized to purchase a coin sorting machine in the amount of approximately \$265.

On Roll Call: Long, Aye; Helzer, Aye; Roake, Aye. Nays: None.

The City Manager presented the proposition of the Portland General Electric Company for constructing lights for the Singer Hill steps. He presented descriptive literature on the lights and stated the lens was non-breakable as far as rocks and miscellaneous were concerned. He stated that it would cost approximately \$53 per year to amortize the investment and pay for the power. It was moved by Commissioner Helzer and seconded by Commissioner Roake that the City Manager be authorized to purchase two lights at this time for the Singer Hill steps.

WHEREAS, the Clackamas County Health Department has requested permission for said trucks to dump their refuse in the Oregon City Sewer. System at a manhole or other place to be designated by the City and to establish rates therefore and the Commission being fully advised, it is

RESOLVED that permission is hereby given to septic tank cleaning trucks to deposit their refuse or sewage, under the supervision of the City Manager, at a place so indicated by him, for which service the following fees are hereby set:

\$1.00 per load up to 500 gallons for each load. \$2.00 per load from 500 up to 1500 gallons for each load.

\$3.00 per load from 1500 gallons up to 2500 for each load,

which fees are payable at the time of unloading.

Jack Albright appeared before the Commission in regard to a sewer coming from Clackemas Heights Housing Project. He stated that it had a foul smell a great deal of the time and he was wishing something could be done with it. The City Manager stated that he had contacted Mr. John Borden of the Health Department in regard to it and that Borden advised it was because sewage was lying stagnant in the bottom of an inverted syphon and that it would necessitate flushing at frequent intervals. Mr. Borden had advised the Clackamas Heights Housing Authority of the matter and they agreed to do something as soon as they had completed their well.

Up for discussion next was the city elevator. The City Manager presented two proposals for designing the elevator. One proposal from Mr. Daniel Riggs Huntington for a fee of 4%; the other from the engineering firm of Stevens and Thompson for a fee of 5%. The Mayor brought up the question of whether or not any previous motions in regard to the elevator should be rescinded and further what instructions should be given to the designer of the elevator. The City Attorney advised that he did not feel that anything would have to be done at this time and that any further action would have to wait for a report from the designer before the City could set any policy in regard to a tunnel or an overhead walkway. ### ORDINANCE NO. 1408

AN ORDINANCE making it unlawful for any person to give or cause to be given false statement that a felony or misdemeanor, about to be committed, and providing penalties for the violation thereof.

## OREGON CITY DOES ORDAIN AS FOLLOWS:

Section 1. It shall be unlawful for any person to give or cause to be given to the Police Department, or any officer of the Police Department a false statement, report or call to the effect that a felony or misdemeanor has been committed or is about to be committed, knowing that such felony or misdemeanor has in fact not been committed or is not about to be committed.

Section 2. Any person violating any of the provisions of this Ordinance shall, upon conviction thereof, be punished by a fine not exceeding \$300.00 or by imprisonment in the city jail for a period not exceeding ninety days, or by both such fine and imprisonment.
