## ORDINANCE NO. 1472

An ordinance amending Ordinance No. 210 of the City of Oregon City by inserting therein a new sub-paragraph, to be designated as sub-paragraph Ninth under Section 1 thereof, classifying additional persons as vagrants.

OREGON CITY DOES ORDAIN AS FOLLOWS:

Sec. 1. That Ordinance No. 210 of the City of Oregon City entitled "An Ordinance to define and punish vagrancy.", approved November 19, 1897, be and the same is hereby amended by inserting therein a new sub-paragraph to be designated as sub-paragraph Ninth under Section 1 thereof, which new sub-paragraph shall read as follows:

"Ninth. Every person who loiters about any school or public place at or near which children attend or normally congregate."

Read first time and ordered published at a regular meeting of the City Commission held on the 2nd day of December, 1959, and to come up for second reading and final passage at a regular meeting of the City Commission to be held on the 6th day of January, 1960, at the hour of 8:00 P.M.

The Commission requested a letter be written to Mr. Perrin stating that it would consider their recommendation at the time of the next appointment to the Civil Service Commission.

Commissioner Faust brought up the matter of an old, hazardous sidewalk on Jackson Street between 5th and 6th. Discussion was held.

The Attorney presented some sample incinerator ordinances to be discussed at a later date.
