WHEREAS, after careful study it has been determined that the following area requires traffic regulation,

NOW THEREFORE BE IT RESOLVED by the City Commission of Oregon City that the City Manager be and he is hereby authorized and directed to designate the following as a street in which the speed limit thereon shall be limited to 15 miles per hour, to-wit:

#### Gentlemen:

We, the undersigned employees of the City of Oregon City respectfully request your consideration of the following recommendations concerning improvements in our working conditions:

#### For all Employees:

- 1- That vacation time be increased to three weeks after the years service.
- 2- That employees required to work on New Year's Day, Memorial Day, 4th of July, Labor Day, Thanksgiving Day or Christmas be paid overtime for such days, or given compensatory time off.
- 3- That all city employees be placed under civil service.
- 4- That time off due to service connected injury or disability not be charged to regularly accumulated sick leave.
- 5- That sick and accident insurance be provided for all employees.
- 6- That a substantial wage increase be made effective July 1, 1959.

## Police Department:

- 7- That all police employees be placed on a 40-hour week immediately.
- 8- That 4 days off a year, to be known as "short time", be allowed to compensate for time spent in court; carrying on an investigation over into another shift; etc.
- 9- That a shift differential be established for the 1st and 2nd night shifts.
  - 10- That false arrest insurance be provided for all officers.
  - 11- That officers required to work any shift on New Years' Day, Memorial Day, 4th of July, Labor Day, Thanksgiving Day or Christmas be paid overtime for such days, or given compensatory time off.

## Street & Water Departments:

12- That department heads supervise and be in charge of their designated departments.

# Elevator Department:

13- That the Sunday morning early shift be eliminated so that the employes can have one day per week off, effective immediately.

## City Offices:

14- Office to be open 35 hours per week, effective immediately.

#### <u>Library Department:</u>

15- The Library requests the establishment of a 35 hour work-week for all full-time library employees.

The above requests have been carefully considered by all signatories and we each concur in the recommendations for all department concerned.

C. D. Newman spoke briefly. The Commission referred the discussion to a later date so that they might meet with representatives from each department.

A request from the Chamber of Commerce for an amendment to an ordinance pertaining to over head wires was presented. The present ordinance prohibits the wires and the Chamber wished to have this changed to allow permanent wires for Christmas decorations. It was moved by Laurs, seconded by Brown that the Commission take the matter under advisement for further study.

A request of the Retail Trade Bureau of the Chamber of Commerce of the City to take over and maintain two wooden telephone poles on 7th Street west of Washington Street was presented. It was stated this would be to allow Christmas decorations to be hung across the street from these poles. It was brought out the telephone company is abandoning them and removing them. It was moved by Laurs, seconded by Brown that the request be rejected on the basis that the City desired to have all poles as possible removed because they were unsightly.

The Manager brought up the question of the lack of space in the Oregon City Library. He stated the Library is now becoming very crowded and that the County Library occupies the entire basement. He recommended the City Library take over the entire basement area which will allow them to operate for some time to come. It was moved by Laurs, seconded by Brown to notify the County that the City will not rent space to them at the Oregon City Library after July 1, 1959.
