SPECIAL MEETING

A special meeting of the City Commission was held on the above date in the Commission Chambers at City Hall, at 8:00 P.M.

The minutes of the previous meeting were read and approved.

It was moved by Faust, seconded by Bowman, that proposed Ordinance No. 1484 be read the first time and ordered published.

On roll call: Brown, Aye; Faust, Aye; Bowman, Aye.

ORDINANCE NO. 1484

An Ordinance making a tax levy for Oregon City for the last six months of the year 1960 and the first six months of the year 1961 ending June 30, 1961, and declaring an emergency.

Oregon City does ordain as follows:

Section 1. That there be and is hereby levied upon and against all property within the corporate limits of Oregon City which is assessed and taxable for the fiscal year 1960-61 ending June 30, 1961, for State and County purposes and for the purpose hereinafter set out which sums of money are hereby levied pursuant to the general laws of the State of Oregon, and which authority is invested in Oregon City by the Charter of Oregon City.

Section 2. The sum of \$12,000.00 to provide a fund for the operation and maintenance of a Recreation Department.

Section 3. The sum of \$19,869.00 to provide a fund for the maintenance of the Oregon City free library.

Section 4. The sum of \$6,000.00 for a fund to provide additional street lighting in Oregon City.

Section 5. The sum of \$13,897.50 to provide a fund to pay a portion of the principal and interest on \$175,000 Elevator Bonds.

Section 6. The sum of \$25,000.00 to provide a fund for a special salary increase.

Section 7. The sum of \$115,175.00 to provide a fund to pay a portion of the principal and interest on \$900,000 Water Filter Bonds.

Section 8. The sum of \$11,007.50 to provide a fund to pay a portion of the principal and interest on \$150,000.00 Sewage Disposal Bonds.

Section 9. The sum of \$106,651.00 to provide a fund for the general municipal expenses of Oregon City.

WHEREAS, it is necessary that Oregon City, Oregon, raise the said sum of money for defraying the expense of the government for the fiscal year 1960-61 ending June 30, 1961, and it is necessary to protect the peace, health and safety of Oregon City, Oregon by raising the said sums, an emergency is hereby declared and this ordinance shall go into effect immediately upon its final passage and approval by the Mayor.

Read first time and ordered published at a special meeting of the City Commission held on the 1st day of July, 1960, and to come up for second reading and final passage at an adjourned regular meeting of the City Commission to be held on the 14th day of July, 1960, at the hour of 1:00 o'clock P.M.

RESOLUTION

WHEREAS, on June 30, 1958, Clackamas County, a political subdivision of the State of Oregon, and the City of Oregon City, Oregon, a municipal corporation, entered into an agreement whereby both parties would furnish fire protection to Safeway Stores, Inc., a Maryland Corporation, on its property lying within Sections 9, 10, 15 and 16, Township 2 South, Range 2 East of the W.M., near Clackamas, Oregon, said property being at that time located within Fire Zone 2, said agreement being for a period of one year with an annual renewal unless terminated by notice given on or before June 15th of each year by either party, and

WHEREAS, said property is now located within Clackamas Fire District by virtue of an election and is no longer a part of Fire Zone 2 of Clackamas County, and

WHEREAS, Safeway Stores, Inc. desires to continue said fire protection for a period of thirty-one days from July 1, 1960, with Oregon City in order to protect its present rating for fire insurance purposes and work out a satisfactory arrangement as to fire rating for the future,

NOW THEREFORE BE IT RESOLVED that the City of Oregon City shall continue its agreement directly with Safeway Stores, Inc., to furnish fire protection in accordance with said agreement for a period of thirty-one days from July 1, 1960, expiring July 31, 1960, at midnight, at a cost of \$83.33 for said period to be paid by Safeway Stores, Inc.
