ORDINANCE NO. 1535

An Ordinance amending Ordinance No. 1405, being the Zoning Ordinance of Oregon City by changing certain districts.

OREGON CITY DOES ORDAIN AS FOLLOWS:

Section 1. Whereas, public necessity and the general welfare of Oregon City require changes in certain districts, which changes have been referred to the City Planning Commission and approved by them after public notice and hearing, as required by said Ordinance No. 1405, the following described property in Oregon City, Clackamas County, Oregon, to-wit:

PARCEL I: Part of the William Holmes D.L.C. in Section 5 in T.3S.R.2E. of the W. M., described as:

Beginning 4.83 chains north from the northeast corner of the Catholic Cemetery described in Deed Book 29 page 103; thence west 204.96 feet; thence north 768.76 feet to the southwest corner of that tract described in Deed Book 92 page 457; thence N. 86°E. 208.56 feet to a stone set in the ground and marked with an X on top for the southeast corner of said tract; thence south 770 feet more or less to the place of beginning.

ORDINANCE NO. 1536

An Ordinance amending Chapter 6, Title 6 of the 1963 City Code relating to curfew and declaring an emergency.

Oregon City does ordain as follows:

Section 1. That Chapter 6, Title 6 relating to Curfew heretofore adopted in the 1963 City Code on May 21, 1963, be and the same is hereby amended to read as follows:

6-6-1 CHILDREN ON STREET AT NIGHT: It shall be unlawful for any child under the age of 18 years to be in, or remain in, or upon any street, alley, park or other public place between the hours specified herein, unless such child is accompanied by a parent, guardian or other proper companion of the age of 21 years, or more, specially chosen by the parent, or guardian to escort the child on the occasion in question, or by a person over 21 years of age having the care and custody of such child or, unless such child is then engaged in an entertainment, or night school, or going to, or from, an employment or night school which makes it necessary to be in, or upon, such street, alley, park, or other public place, during the night-time between such specified hours. For the purpose of this section the applicable hours shall be: As to children under 14 years who have not begun high school, between 9:15 o'clock P.M. and 6:00 o'clock A.M. of the following morning except that during the months of June, July and August, the hours shall be between 10:15 o'clock P.M. and 6:00 o'clock A.M. of the following morning; as to children 14 years or age or over or who have begun high school, the hours shall be between 10:15 o'clock P.M. Sunday, Monday, Tuesday, Wednesday or Thursday, and 6:00 o'clock A.M. of the following morning and between 12 midnight on Friday or Saturday, or any day prior to a legal holiday when no school is scheduled for said legal holiday, and 6:00 o'clock A.M. of the following morning, except that during the months of June, July and August the hours shall be between 12 midnight and 6:00 o'clock A.M. of the following morning. Any child under the age of 18 years employed in selling, delivering or wrapping newspapers shall obtain from the newspapers employer and the employer shall issue to child employed a card showing such employment. A child failing to carry, and produce, such card shall not be deemed to be within the protection of the preceding provision.

6-6-2 VIOIATION BY PAREMTS: It shall be unlawful for any parent or guardian or the person having the care or custody of any child under the age of 18 years, to permit, or by inefficient control to allow such child to be in or remain in or upon any street, alley, park, or other public place between the hours herein set forth in Section 1 of this Chapter contrary to the provisions of this Chapter. Proof that such a child was on any street, alley, park or other public place at a time prohibited shall, prima facie, be sufficient evidence to sustain a conviction of a violation of this Chapter.

6-6-3 DUTIES OF OFFICERS: All peace officers, juvenile department counsellors, state or county welfare department employees or any other person authorized by the juvenile court of the county in which the child resides or is found, may take into temporary custody any child violating any of the provisions of this Chapter and, for the first violation, shall as soon as practicable thereafter, notify the child's parent, guardian or other person responsible for the child of the violation and shall take or sand such child home and release the child to the custody of his parent or other responsible person in this state, except where the Juvenile Court otherwise orders. In case any child under the age of 18 years shall again violate any of the provisions of this Chapter, such child may be apprehended and taken into temporary custody as a juvenile offender and delinquent and may be brought before the juvenile court of the county in which such child resides or is found.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of Oregon City in this: That it is necessary that the rules and regulations of the hours and control of children on the streets of Oregon City be amended to adequately and properly control the same, and to conform to a uniform curfew ordinance for the greater metropolitan area of which Oregon City is a part, therefore an emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage by the Commission and approval by the Mayor.

Read first time and ordered published at a regular meeting of the Commission held on the 4th day of September, 1963, and to come up for secondreading and final passage at an adjourned regular meeting of the City Commission to be held on the 24th day of September, 1963, at the hour of 1 o'clock P.M., Oregon Daylight Time.

ORDINANCE NO. 1537

An ordinance amending Chapter 1, Title VI, of the 1963 City Code by adding Section 6-1-1.1 relating to after hours and by adding Section 6-1-27.1 relating to negligent driving, and declaring an emergency.

Oregon City does ordain as follows:

Section 1. That Chapter 1, Title VI relating to General Offenses under Police Regulations heretofore adopted in 1963 City Code on May 21, 1963, be and the same is hereby amended by adding a new section to be designated as 6-1-1.1 as follows:

6-1-1.1: AFTER HOURS: It shall be unlawful for any person or persons to loiter or wander about the streets or public places of Oregon City, Oregon, between the hours of 1 o'clock A.M. and 5 o'clock A.M. of every day.

Section 2. That Chapter 1, Title VI relating to General Offenses under Police Regulations heretofore adopted in 1963 City Code on May 21, 1963, be and the same is hereby amended by adding a new section to be designated as 6-1-27.1 as follows:

6-1-27.1: NEGLIGENT DRIVING: Any person who drives any vehicle upon any public street or thoroughfare of Oregon City, negligently or carelessly, without due regard for the rights or safety of others, or in a manner so as to fail to exercise due and proper care, or in an unusual or unorthodox manner shall be guilty of negligent driving.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of Oregon City in this: That it is necessary to adequately and properly control and regulate the use of the public streets and public places of Oregon City at late hours of night and to more adequately regulate and control the operation of motor vehicles upon the streets of Oregon City, therefore an emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage by the Commission and approval by the Mayor.

Read first time and ordered published at a regular meeting of the Commission held on the 4th day of September, 1963, and to come up for secondreading and final passage at an adjourned regular meeting of the City Commission to be held on the 24th day of September, 1963, at the hour of 1 o'clock P.M., Oregon Daylight Time.

AIFRED SIMONSON City Recorder Mr. Harold Koenig, 1807 - 15th Street, was present in the audience and requested Commission consideration to reimburse him for damages suffered by a sanitary sewer back-up into the basement of his residence, caused apparently by an accumulation of grease in the main trunk line beyond point of entry of his sewer service.
