Special Meeting

The City commission of Oregon City met in special session on the above date in the office of the City Manager in the Municipal Building at 1:00 o'clock p.m.

Roll call showed the following present: C. H. Caufield, L. O. Harding, commissioners; J. L. Franzen, City Manager.

The bids for the construction of a retaining wall from 7th street to 8th street were considered. Jacobsen-Jensen of Portland being the lowest responsible bidders bid \$17,028.80. On motion the bid of Jacobsen-Jensen Company was accepted.

-Ordinance No. 1214 was read the first time and ordered published.

Ordinance No. 1214

An ordinance authorizing the Mayor and City Recorder to enter into a contract with Jacobsen-Jensen Company for the construction of a concrete wall on Water street between 7th street and 8th street.

OREGON CITY DOES ORDAIN AS FOLLOWS:

Section 1. The Mayor and City Recorder of Oregon City, Oregon are hereby authorized and directed to enter into a contract with Jacobsen-Jensen Company for the construction of a concrete wall on . Water street between 7th street and 8th street, for the sum of Seventeen Thousand Twenty Eight Dollars and Eighty Cents (\$17,028.80) in accordance with the plans and specifications on file in the office of the City Recorder of Oregon City.

Section 2. Whereas, it is necessary to protect said Water Street on account of the condition of the fill on said Water street, and it is necessary for the peace, health and safety of the public that said wall be immediately constructed, an emergency is hereby declared, and this ordinance shall be in effect immediately upon its passage and approval by the Mayor.

Read first time and ordered published at a special meeting of the City Commission held on the 24th day of January, 1930, and to come up for second reading and final passage at the next regular meeting of the City Commission to be held on the 5th day of February, 1930, at one o'clock p.m.

RESOLUTION

Whereas, J. L. Franzen has been the City Manager of the City of Oregon City since May, 1925, and during said period of time as such manager he has advanced the interest of Oregon City very materially, and has saved the City of Oregon City many thousands of dollars in actual money, and

Whereas, the City Commission of Oregon City feel that for some time past he has been entitled to an increase in salary but on account of the financial condition of the city he has been willing to work for the city for less salary than he was entitled to, and

Whereas, the financial condition of the City has very materially improved under his management and on account of his saving, we believe that for the year 1930 his salary should be increased at the rate of \$100 per month so as to pay him a salary of \$400 per month.

Therefore, Be it Resolved by the City Commission, that for the year 1930 the salary of J. L. Franzen as city manager of Oregon City be raised so that the total salary received by him shall be \$400 per month.
